This report is submitted by Officer Carlos Felix assigned to District One.

On February 23, 2021 at 3:00PM I conducted a CPTED for the business located at 823 N. 2ND Street, which is located in the lower level of the building in a common hall area. This is a mix use building with office, living, and other businesses inside of it. There are exterior doors that are locked after 5:30PM and the convenience store can only be accessed by the tenants in the building. There are two interior cameras at the front entrance and one at the rear door capturing all foot traffic. These three cameras are owned by the building management company. The agent for the store has a camera at the front entrance of the business and plans on adding a second camera. I advised that the second camera be placed behind the register capturing all of the activity at the register. There is a small safe box attached on the floor in the storage area. I advised that the agent check the MPD Website and enroll into the Robbery prevention course. There were no licenses displayed and the agent could not produce the Tabaco or Food license when I requested to view them. He was advised that the licenses should be displayed at the business.




City Concentration Map
