

Re: Filing a claim against the City of Milwaukee

I. Circumstances:

I was arrested on June 9, 2005 at about 3:00 am on the premises of the former Pabst Brewery for trespassing. Certain personal photographic equipment was held as evidence starting on the date and time of my arrest. I had used said equipment earlier that day as well as late in the evening on June 8. I was released from jail approximately 24 hours later on \$200 of bail with a scheduled court date of Tuesday, June 14, at 2:00 pm and was informed that the charges against me were for Criminal Trespass to a Dwelling.

I attended the prescribed court date to learn that charges against me had been dropped by the District Attorney's office.

I then appeared in person, on June 14, at the District One desk to find out how to reclaim my property. I followed the procedures that I had been told and went to the Property Control Division after some paperwork had been complete to retrieve my property. I inspected it on the premises at 2620 West Wisconsin Avenue on June 15, when I went to claim it, and found substantial damage to my primary camera assembly (two cameras of mine had been seized; both were in hard cases. One sustained fatal damage). It appeared that my Canon digital camera had been dropped, lens down. The lens cover had been forced into the UV filter and was no longer removable. The focus/zoom tube had been forced into the main barrel of the lens and was no longer operable at all; neither the focus nor zoom rings would rotate.

This precision optical device met a horrible tragedy and can no longer be used. Attached, please find a picture, taken with the other camera, that clearly shows the damage to the lens. Additional pictures are available upon request. Also attached you will find a receipt for the camera assembly that shows when I purchased it, where I purchased, and the purchase price of \$1,530.00, which is the dollar value of reparation I am seeking.


