RE: Introduction of one Resolution Relating to Expenditure of Funds
to be Reimbursed by Greater Than Anticipated Revenue
(Debt Service Fund-Principal Expenditure)

Dear Council Members:

We are submitting the attached resolution for introduction at the December 22, 2008 Common Council meeting. This resolution is needed to increase the 2008 appropriations for the Debt Service Fund-Bonded Debt Principal. General Obligation Cash Flow Promissory Notes, Series 2008 R5 for the purpose of financing the City's operating budgets on an interim basis in anticipation of the receipt of State shared revenue payments were issued as general obligation debt rather than Revenue Anticipation Notes. This change requires that the principal be paid from the Debt Service Fund rather than the General Fund. Operating transfers (revenues) of \$90,000,000.00 from the General Fund in 2008 were greater than anticipated and will offset the principal paid in the Debt Service Fund on this debt issue.

This resolution is recommended for adoption.
