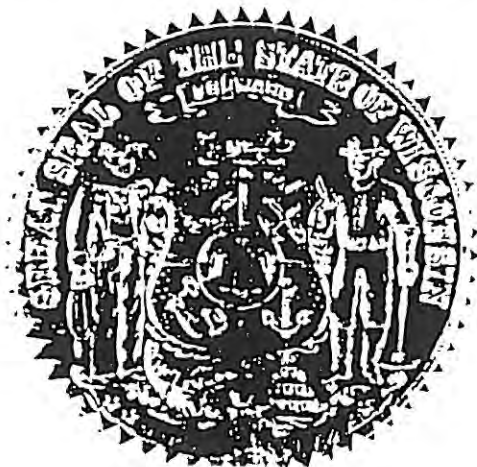



ARTICLES OF INCORPORATION

Executed by the undersigned, natural persons of more than twenty-one years of age, for the purpose of forming a Wisconsin corporation under Chapter 181 of the Wisconsin statutes, WITHOUT STOCK AND NOT FOR PROFIT.

- Article I. The name of the corporation is the Next Door Foundation, Inc.
- Article II. The period of existence shall be perpetual.
- Article III. The purposes shall be exclusively religious, educational and charitable. No part of the property or net earnings of the corporation shall inure to the benefit of any individual.
- Article IV. Location of the principal office of the corporation shall be Milwaukee, Wisconsin.
- Article V. The initial registered agent shall be Mr. Byron Tweeten, 3046 West Wisconsin Avenue, Milwaukee, Wisconsin 53201.
- Article VI. The number of Directors shall be provided for in the By-laws.

The number of Directors constituting the initial Board of Directors shall be three (3). The initial Directors shall hold office until the first annual selection of Directors as provided for in the By-laws.

- Article VII. The initial Board of Directors shall be the following:
1. John R. Dewey, Box 393, Milwaukee, Wisconsin, 53201
 2. George E. Aker, 111 East Wisconsin Avenue, Milwaukee, Wisconsin 53201
 3. Pastor Charles A. Berdahl, 3046 West Wisconsin Avenue, Milwaukee, Wisconsin 53201
- Article VIII. The corporation shall have no members.

Article IX. In the event of the dissolution of the corporation, all of its assets, after payment of its debts and liabilities, shall be used for the purposes set forth in Article III.

Article X. These Articles may be amended in the manner authorized by law at the time of amendment.
