I left my duplex and checked into the Ambassador Hotel, 2308 W. Wisconsin Ave, (414) 342-8400 at 10:11p I stay there (1) week until Friday, February 20th when I decided to move out. I checked myself in at the Suburban Motel, 4600 S. 24th St. I was on my way back to the Ambassador Hotel when my car brake down on 2700 W. Orchard St, at the estimated time of 9:00am to 10:00am.

She took me to the Ambassador Hotel where I checked out. Jeanne Moore then drove me to the Suburban Motel where I had registered earlier in the day. I had no money to get my car from the tow lot. So I left it there until my next payday, Friday, Feb. 24th.

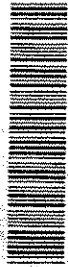

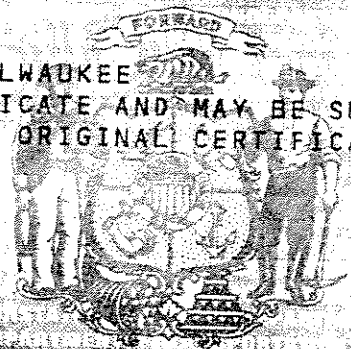
