3. On 02/14/2010 at 3:11am Milwaukee police responded to sick/injured person call for service at 425 East Capitol Drive (Citgo Gas Station). Investigation revealed a patron slipped and fell approaching the front door of the business. The patron received stitches at St. Mary's hospital as a result of this incident.

- 14. On 07/13/23 at 11:35a.m., Milwaukee Police were dispatched to a Trouble with Subject at 425 E. Capitol Dr. On arrival the caller was no longer on scene, however, officers spoke to an employee who stated they juveniles they were having trouble with were gone. The employee was cooperative with the investigation.
- 15. On 09/05/23 at 10:53a.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 425 E. Capitol Dr. Investigation revealed 3 subjects were inside the store, when the employee accused them of stealing. Upon exiting the store, one suspect dropped their cell phone and a screwdriver. The employee picked it up and refused to return it. The suspect then picked up a brick and threw it at the window, causing damage. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

### LICENSED PREMISE REPORT

This report was written by Police Officer Kimberly L PETTERSEN, assigned to District 5, Late Power Shift (Squad 5468).

On Saturday, November 16th, 2024, at approximately 8:03 PM, I conducted a license premise check at the CITGO gas station, located at 425 E. Capitol Dr., located in the City and County of Milwaukee (WI).

Upon entry, I made contact with two employees, one identified as Kirpal SINGH (W/M 04-15-87). There was an additional gas station clerk as well. I began to explain that I would be conducting a check on the licenses for the business and I also informed SINGH and the additional clerk I would be checking various items on the shelves for expiration dates.

There appeared to be a strong language barrier between SINGH, the additional clerk, and myself. SINGH called an individual who identified himself as Sukhwinder SINGH (W/M 10-17-89), who I was able to speak with. I asked S. SINGH if he was the individual listed on the permits as the agent and S. SINGH informed me that his father is the one listed on the permits as the agent. The male subject listed on the permits was identified as Swaran S MULTANI (W/M 07-15-56).

I explained to S. SINGH why I was at this location and S. SINGH asked me if license premise checks are something new, because he had never heard of them before. I explained to him that I go to different gas stations and taverns, just to make sure that permits are up to date, items for sale are not expired, etc.

I located the following permits posted behind the counter where the employees work:

- Food Dealer Retail: Effective date of 01/17/23 and an expiration date of 01/16/25
- Weights and Measure: Effective date of 01/17/23 and an expiration date of 01/16/25
- Extended Hours Establishments: Effective date of 01/17/23 and expiration date of 01/16/25
- Filling Station: Effective date of 01/17/23 and an expiration date of 01/16/25
- Underground Storage Tank Permit: Effective date of 11/28/23 with an expiration date of 11/28/24

I did not see a permit posted for Cigarette and Tobacco, but with a search on the City of Milwaukee License Search, it appeared that it currently is active and has an expiration date of 01/16/25.

All of the above permits, except for the Underground Storage Tank Permit, were listed on the City of Milwaukee License Search and are all currently pending renewal.

I asked S. SINGH if there is security that is employed at this business and S. SINGH stated yes. S. SINGH stated that the security guard is NOT armed and works every day of the week from 5:00 PM - 1:00 AM, except for on Tuesdays. I informed S. SINGH that I did not locate a security permit for this business and S. SINGH informed me that he is a citizen who just helps out due to children coming into the business and causing issues.

I asked K. SINGH if this business is equipped with working surveillance cameras and after asking multiple times, due to the language barrier, the additional clerk stated yes. I asked S. SINGH more in regard to the surveillance cameras. S. SINGH stated that the surveillance cameras are accessible and provided me with the password, which is the pattern of the letter C.

I asked S. SINGH how many employees are employed at this business and S. SINGH stated that he believes a total of 3 individuals are employed. I asked what the working hours of the employees are, and S. SINGH stated that they overlap with one another. S. SINGH stated that the business closes from 12:00 AM and opens back up at 5:00 AM.

On a few of the permits there were hours of operation listed other than what S. SINGH informed me. The following hours that were stated on the permits are the following:

- Sunday: 12:00 AM 11:59 PM
- Monday: 12:00 AM 11:59 PM
- · Tuesday: 12:00 AM 11:59 PM
- Wednesday: 12:00 AM 11:59 PM
- · Thursday: 12:00 AM 11:59 PM
- Friday: 12:00 AM 11:59 PM
- Saturday: 12:00 AM 11:59 PM
- Friday: 12:00 AM 11:59 PM

Once I was finished speaking with S. SINGH, I began to look over various items on the shelves that are for sale to the citizens. Most of the items were not expired, however I did locate chips and other items that were expired. I removed the items from the shelves and explained that these items could not be for sale due to their expiration dates. K. SINGH contacted S. SINGH once again and I advised S. SINGH that I located multiple expired items. I advised S. SINGH that there were items that were close to expiring as well. I asked S. SINGH if anyone does routine checks on the items out for sale and S. SINGH stated that they get merchandise from two business representatives, and those are the ones who normally check the shelves for expired items.

I explained to S. SINGH that if MULTANI had any questions or concerns to give me a phone call. I advised S. SINGH that I would be leaving a Community Contact Card with the employees on site during my license premise check. I filled out a Community Contact Card and left the card with K. SINGH.

Everyone I spoke with during my license premise check was very cooperative and answered all of my questions.

At 10:05 am, Syntrell, a minor, went into Citgo gas station. The Indian male clerk sold SYNTRELL a pack of Dutch Honey Fusion blunt wrap. The male clerk did not ask SYNTRELL for ID and he only paid \$1.30. SYNTRELL stated the clerk looked in his early 30's, 5'9, slim build, black hair, goatee facial hair, grey camouflage t-shirt, blue jeans.

I went into the store, and I observed an Indian male, grey camouflage t-shirt, goatee, black hair and blue jeans behind the counter. I stated that he sold tobacco to a minor. The male clerk stated that he did not know. I asked the clerk for his name, and he stated, Mehar and I asked for the owner's name and phone number. I explain how important it is to check ID's and do not sell to minors. The business licenses are up to date and the owner will receive a citation.
