This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/27/2017 the applicant was charged in Waukesha County with Illegal Games/Gambling (Forfeiture).

- 2. On 08/31/2019 at 2:39am officers observed a subject leaving Silk, 144 E. Juneau Av. The officer asked the security guard if that subject was an employee. The security guard stated he was not. The officer asked the manager why a customer was leaving 9 minutes after closing. The manager stated the customer was a high paying customer and he was using the ATM.
- 3. On 10/10/2019 at 1:30am an officer observed a car parked in the alley next to Silk, completely blocking the alley. The officer has seen this occur before with the auto waiting for a Silk employee. The officer spoke with the security guard about keeping the alley clean and he

- stated that was not Silk's problem. The officer then spoke with the manager, who also stated that was the officer's problem and not Silk's.
- 4. On 12/07/2019 at 1:29am officer's observed a group of people gathering in front of Silk, 144 E. Juneau Av. The officer approached and observed a subject in a scuffle with security. The security guard stated the subject was inside Silk for several hours. The subject was kicked out after attempting the take money off a table that was not his. Outside he accused the security guard of being racist and hit him with a closed fist to the face. The subject was issued a citation for Assault and Battery and arrested for violating his probation.

5. On 06/18/20 at 1:30am, Milwaukee Police were dispatched to 144 E. Juneau Avenue for a battery complaint. Video surveillance reveals an employee/bouncer and a patron have a heated discussion inside the establishment. When they both start walking toward the front entrance, the bouncer takes the patron down and strikes him several times with a closed fist. Two employees then carry the subject, who is unconscious, outside and laid him on the sidewalk. No employees called for medical attention.

- 6. On 02/19/21 at 8:30pm, Milwaukee Police conducted a license premise check at 144 E. Juneau Avenue. The establishment was found to be in compliance at the time of inspection.
- 7. On 03/18/21 at 2:02am, Milwaukee Police were flagged down by the manager of 144 E. Juneau Avenue for a fight complaint inside the tavern. The fight was in the basement of the establishment and was between several dancers/employees. Security dispensed "OC" spray in an attempt to break up the altercation. Two dancers involved in the fight received a citation.
- 8. On 04/12/21 at 12:35am, Milwaukee Police were dispatched to 144 E. Juneau Avenue for a battery complaint. Initial investigation, which was relayed to officers by security, revealed that the staff of 144 E. Juneau had escorted an intoxicated patron away from the establishment without any physical altercation and had not observed any physical fight. Later investigation, through surveillance footage from a neighboring tavern, shows that the employees of 144 E. Juneau were involved in the altercation and had witnessed what had happen to the victim of the battery. A security guard was seen on video taking off his jacket and going into the alley with the victim of the battery, along with several security members of Silk. A different subject who has been employed as security by silk and other establishments in the area is then seen chasing the victim into the street and punching the victim several times. This subject was arrested for the battery. The employees of the establishment were untruthful with police and failed to call police when they observed a crime being committed.

9. On 09/12/21 at 1:50am, Milwaukee Police, while on foot patrol in the 100 block of E. Juneau Avenue, observed security escorting a subject outside of 144 E. Juneau Avenue. Approximately five minutes later, officers observed the subject who was ejected back at the location and engaged in an argument with the bouncer who escorted him out. Officers returned to the location and broke up the argument telling the subject to leave the area. Both subjects began yelling at each other, so officers arrested the subject who refused to leave the area and cited for Disorderly Conduct.

- 10. On 03/26/22 at 1:51am, Milwaukee Police, while on foot patrol in the 100 block of E. Juneau Avenue, observed security grappling with subjects outside of 144 E. Juneau Avenue. Police broke up the fight and the subjects left to an unknown location. Investigation revealed that security tried to escort three subjects out of the establishment when they began fighting. One of the security guards, who was struck in the back of the head, deployed a one second burst to the face of one of the subjects.
- 11. On 04/15/22 at 12:31am, Milwaukee Police were dispatched to 144 E. Juneau Avenue for a battery compliant. Investigation revealed that two subjects engaged in a physical altercation with security and one of them threw a bottle striking a security guard in the head causing injury. One of the security guards discharged his "pepper spray" in the direction of the subjects and they were physically escorted outside the establishment. While outside, the subjects threw brass stanchions toward staff members then left the area. Security told officers that they were trying to find police to report the incident and encountered the subjects again and another fight began with the subjects. A later meeting was requested by the establishments general manager and he was told by police to remain on their premise unless sever bodily harm or death was imminent.

INITIAL INVESTIGATION

This report is typed by P.O.Crystal JACKS, assigned to District 1, early shift. On 09/12/2021, from 12:00 a.m. to 3:00 a.m., I was instructed to report to the area of N.Water and E.Juneau, for Code Red (a specialized assignment to ensure the safety of patrons at downtown bars).

Also present with me were P.O.Christian GARRIDO, P.O.Christopher PETERSON, and P.O.Jacob WASECHEK. Myself and these officers were standing on a cement island that is directly across the street from Silk Gentlemen's Club located at 144 E. Juneau. At approximately 1:50 a.m. I observed a skinny black male, early twenties, light colored jeans and tee shirt, being escorted out of Silk by a bouncer dressed in a all black suit, bald head, and thick gold chain. The bouncer was identified by Wisconsin Driver License as (Jason A. CARSON B/M 02/20/91). The male that had been ejected from Silk was identified as (SALINAS, Caprese R B/M 07/11/95).

SALINAS was asked to leave due to inappropriate touching of a dancer. After being ejected I observed SALINAS walk westbound on Juneau Street. P.O.GARRIDO followed shortly behind to make sure SALINAS was leaving the area. P.O.GARRIDO returned to where myself and the other officers were standing. P.O.GARRIDO stated to me, he has had problems with CARSON before. P.O.GARRIDO stated CARSON tends to be heavy handed with unruly patrons. On a previous occasion P.O.GARRIDO warned CARSON to be physically careful with intoxicated people, as it is easy for them to fall and obtain head injuries.

Approximately 5 minutes after this conversation SALINAS returned to Silk, where CARSON was standing in front outside. SALINAS approached CARSON and the two were talking for a couple seconds. However myself and other above listed officers quickly walked over to prevent CARSON and SALINAS from physically fighting. We quickly grabbed SALINAS and pushed him back away from the bar. Officers were pushing and yelling at SALINAS "to leave the area"! SALINAS was yelling profanities at CARSON, and refusing to leave on his own free will.

While we were pushing SALINAS, CARSON threw his hands up in the air and stated to SALINAS "what's up motherfucker, I aint scared of you. I'm from the northside too. Ill beat your ass you skinny punk"! CARSON then got into a fighting stance, and started inching toward SALINAS. Another security guard from Silk restrained CARSON to keep him from getting to SALINAS.

Due to SALINAS refusing to leave he was handcuffed and placed into a patrol wagon. SALINAS was conveyed to District One and cited by P.O.WASECHEK for Disorderly Conduct, J981JXM759.

After SALINAS was taken away, I spoke to CARSON about his actions. He was cooperative with my

questions and gave me his driver license and CCW permit. CARSON identified himself as the on duty manager. I explained to him I was concerned with how he reacted to SALINAS. Initially CARSON, looked confused as to what I was saying. I explained the yelling profanities and having to be physically restrained was unnecessary, because police were right there to diffuse the situation. CARSON'S actions made the situation worse and clearly has a problem with self control and anger. CARSON gave me the impression he likes and embraces fights with patrons.

This report is being submitted by Police Officer Lorenzo HERNANDEZ, Squad 1230, in full duty uniform, wearing a body worn camera. I was partnered with Police Officer Nicole PLEVAK. I am currently assigned to District One, Early Shift.

On 3/26/22 P.O. PLEVAK and I were assigned to Code Red in the area of N Water St/ and E Juneau Ave, located in the City and County of Milwaukee, WI.

P.O. PLEVAK and I were on patrol across the street from 144 E Juneau Ave (Silk Exotic on Water Gentlemen's Club) at approximately 1:51 AM. I heard loud arguing coming from 144 E Juneau Ave front west entrance doorway. I observed security staff grappling with unknown individuals. It appeared security staff at Silk were attempting to remove patrons from the establishment.

P.O. PLEVAK and I approached 144 E Juneau ave on foot. I announced "Police!" multiple times loudly. P.O. PLEVAK and I were attempting to break up a physical altercation between security staff and unknown multiple individuals physically fighting. P.O. PLEVAK and I were able to separate all parties. The other parties left on foot to an unknown location.

After the physical altercation I was able to speak with security from Silk identified as James N CATLEDGE (B/M, 12/2/91.)

CATLEDGE stated while inside of the establishment he was attempting to remove three heavyset black females from the establishment. CATLEDGE stated while escorting the three females from the establishment one of the black females became combative and struck him. CATLEDGE stated someone struck him in the back of the head. CATLEDGE stated one of the heavy set black females struck him and he deployed a one second burst of Oleoresin Capsicum to the face of the female subject.

CATLEDGE stated he did not wish to be a victim for a battery. I provided a PF-6

INITIAL INVESTIGATION

This report is written by PO Brian WUNDER assigned to District one, Late Power Shift.

On Friday 12-15-2022 at approximately 12:31am, I (Squad 1441) while monitoring the Entertainment District was dispatched and responded to Silk on Water located at 144 E. Juneau Ave, which is in the City and County of Milwaukee, in regards to a Battery call for service.

Upon arrival, it was met by Silk Staff who stated one of their Security Employees, later identified as Ricardo L. ACEVEDO-COLON (H/M, 1-15-1991) had been hit in the head with a bottle. I proceeded into the basement where ACEVEDO-COLON had indeed suffered a head injury which was consistent with being struck with a blunt object such as a bottle. ACEVEDO-COLON declined medical attention and stated he did not wish to prosecute the subject.

On-Duty Manager Fernando RUIZ (H/M, 10-21-1987) provided the following synopsis of events:

RUIZ stated a fight had broken out amongst patrons. One of the patrons, further referred to as Subject 1, had became irate that someone had "stole his seat". Subject one was told to leave the premises, to which refused and was then physically escorted out of the building. Upon exiting, Subject #1 and his brother (Subject #2), threw the beer bottles they had in their hands at the entry door of the bar, striking ACEVEDO-COLON in the head. Both Subjects than began assaulting Security Staff.

Contracted Armed Security Guard Brandon K. MCDONALD (M/B, 5-10-1985) retrieved and discharged his pepper spray in the direction of both subjects in an attempt to stop the assault and disperse both subjects, however it had little to no effect on them. Both Subjects then picked up the brass stanchions located directly outside the front door and launched them towards staff members, nearly missing one of the Security Personnel's head.

RUIZ was able to immediately show me the video from both the interior and exterior of Silk, which depicted the event nearly identically as RUIZ had explained.

While I was conducting this investigation, a simultaneous call for service of a battery placed by Subject #1 came over and Squad 1422 (PO Benjamin DELANEY) responded and eventually made contact with the caller at a nearby hotel. I also responded with PO DELANEY. Upon locating Subject #1 in his hotel room, I observed numerous injuries to his face and head. Subject #1 stated he was attacked by Security Staff at Silk on Water without provocation. Subject #1 stated the altercation occurred on the corner of Water & Juneau. Subject #1 also declined medical attention and stated he did not wish to prosecute.

Due to the severity of Subject # 1's injuries, I returned to Silk to inquire how he sustained those injuries' as it was not consistent with the video I had viewed. RUIZ stated Security Member Jason A. CARSON (M/B, 2-20-1981) and himself had left Silk to find a police officer. He stated we (Squad 1441) are normally parked in the 100 Block of E. Juneau, however he didn't see us out there, so he said they started walking towards the 1200 Block of N. Water St, where RUIZ stated he knows another MPD Squad is normally posted for "Code Red" events. RUIZ stated as they turned the corner (Water & Juneau) an altercation ensued with the subjects. Both parties then departed the area in separate directions, with RUIZ and CARSON returning to Silk.

I obtained video from Duke's on Water (154 E Juneau) from their exterior cameras which captured the 2nd encounter between the parties. The video obtained from Duke's on Water is not audio capable and the exchange of words prior to the 2nd incident is not known. The video depicts an encounter that is consistent with Subject #1's injuries'.

A follow-up meeting was requested by Silk On Water's General manager to address this incident. Unless severe bodily harm or death is imminent, Silk Staff was advised to remain on their premises and phone police, rather than leave and look for them (police) to avoid any further re-encounters with patrons they had escorted out.

- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
