1st Aldermanic District

W. Villard Ave. (Excluding Structure) – N. Green Bay Ave. to N. Teutonia Ave. (ST320021001): Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, and sodding.

4th and 15th Aldermanic Districts

N. 20th St. – W. Highland Ave. to W. North Ave. (ST320051201): Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding, and tree removal where necessary.

5th Aldermanic District

N. 88th St. – W. Chambers St. to W. Burleigh St. (ST211070106): Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

Alley between W. Capitol Dr., W. Fiebrantz Ave., N. 90th St., and N. 91st St. (East-West Leg) (ST212060130): Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where necessary.

Alley between W. Center St., W. Lorraine Pl., N. 82nd St., and N. 84th St.

(ST212060104): Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where necessary.

Alley between W. Congress St., W. Lawrence Ave., N. 88th St., and N. 91st St. (Easterly half of East-West Leg): Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, and storm drainage facilities where necessary.

6th Aldermanic District

E. Brown St. – N. Holton St. to N. Palmer St. (ST211070148): Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

8th Aldermanic District

S. 29th St. – W. Montana St. to W. Cleveland Ave. (ST30683001/BR30683001): Remove and replace bridge and reconstruct concrete pavement.

S. 45th St. – W. Oklahoma Ave. to W. Cleveland Ave. (ST211060104): Asphalt pavement resurfacing, replace all curb and gutter, sidewalk and driveway approaches, sodding, and tree removal where necessary.

8th and 11th Aldermanic Districts

S. 33rd St. – W. Lakefield Dr. to W. Oklahoma Ave. (ST211070126): Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

10th Aldermanic District

W. Chester St. – S. 92nd St. to W. Dixon St. (ST211060127): Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

W. Dixon St. – S. 92nd St. to W. Chester St. (ST211050122): Asphalt pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

11th Aldermanic District

S. 83rd St – W. Morgan Ave. to W. Euclid Ave. (ST211060107): Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.
