**1. Description of Grant Project/Program (Include Target Locations and Populations):**

Through a multi-agency FBI coordinated effort, the "Save Our Streets" task force will use agency resources, intelligence and investigative expertise to investigate violent crimes, monitor gang intelligence, and apprehend criminal offenders. Concentrated efforts focus on investigating unsolved violent crimes and information sharing to develop intelligence on criminal networks operating in the area. Further, efforts also involve the generation of actionable intelligence related to gangs and to assess whether new gangs are relocating in local communities.

**2. Relationship to City-wide Strategic Goals and Departmental Objectives:**

The overtime funds solely will be used to assist this agency in current and future joint law enforcement operations, investigations, and prosecutions to reduce violent crime (ie. homicides and non-fatal shootings), arrest violent gang members, and seize weapons and drugs to create safe neighborhoods for the residents of the City of Milwaukee.

**3. Need for Grant Funds and impact on Other Departmental Operations (Applies only to Programs):**

The funds for this grant are to be used to specifically fund overtime in specified "Save Our Streets" initiative investigations and prosecutions.

**4. Results Measurement/Progress Report (Applies only to Programs):**

Effectiveness of this mission will be measured by the amount of search warrants executed, violent gang members arrested, weapons and drugs seized. We will also strive to reduce shootings and associated crimes, as well as improve the clearance and charging rates for firearms related violent crimes. Approximately 473.5 hours have been charged to this grant with approximately \$32,489.24 charged to the account. Investigations were comprehensive and included extensive interviews with victims/witnesses, suspect identification through DNA collection, NIBIN investigative leads, and photo arrays to provide prosecutorial outcomes.
