120676 An ordinance relating to temporary deviations from the plans of operation of alcohol beverage establishments and public entertainment premises.

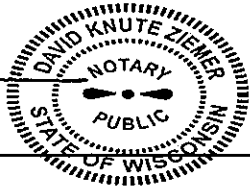
