Dear Council Members:

Enclosed please find a proposed substitute resolution to approve a settlement for \$95,500 to settle the claims raised by Joe Bohannon in the lawsuit entitled *Joe Bohannon v. City of Milwaukee, et al.*, U.S. District Court Case No. 13-CV-1224, as well as a fiscal impact statement.

On October 31, 2013, Mr. Bohannon filed a Complaint with the United States District Court for the Eastern District of Wisconsin, Case Number 13-CV-1224 alleging, among other things, unreasonable search and seizure in violation of his constitutional rights and civil rights under the United States Constitution. In addition to suing the City of Milwaukee directly, Mr. Bohannon sued Police Chief Edward Flynn, former Sergeant Jason Mucha and former officer Michael Vagnini, and Officers Jeffrey Dollhopf, Matthew Gadzalinski and Erin Perleberg. Mr. Bohannon alleges that during a traffic stop on April 1, 2008, Officer Vagnini subjected him to an unlawful search and that he was subjected to excessive use of force. Defendants' motion for summary judgment was denied and the case was set for trial. Although the defendants deny that any unlawful search was conducted, and deny other issues of alleged unconstitutional conduct, the parties agreed to engage in mediation, resulting in the proposed settlement which the City Attorney recommends.

Based on the status of these claims, it is the City Attorney's recommendation that the proposed settlement is in the City's best interest. In exchange for the settlement, Mr. Bohannon will execute a settlement agreement and general release of all claims arising out of the incident.

We request that this matter be assigned for a hearing in closed session before the Judiciary & Legislation Committee and the Finance & Personnel Committee to be followed by an open session in order to take action.
