This report is written by Police Officer Michael P. TERRELL, assigned to the City of Milwaukee Police Department, District 5, Day Shift, Squad 5166.

On about 2:00 PM, on August 24, 2023, Squad 5164, PO Keith GARLAND and myself, received a phone call from Lindsey O'Connor of the City of Milwaukee Health Department. O'Connor stated that she had 2 Health Inspectors contact her by email stating that they went to Star Groceries, 2500 N Booth Street, which is located in the City and County of Milwaukee, for a routine inspection. They stated that during the inspection, DAHIR made several inappropriate (racial) comments regarding one of the inspectors, who was black should be playing basketball and not working for the city. They also stated that DAHIR said he would kill her and laughed. O'Connor stated that at this time the inspectors where not seeking any charges they just requested we speak to him about the inappropriate behavior. The two inspectors involved were Victoria SAGER and Giovanti MELTON.

I spoke to licensed premise manager, DAHIR regarding this incident, who stated he was joking with Mr. Melton about the inspection, and he did not mean to offend Ms. SAGER. Mr. DAHIR was informed it was a crime to threaten a government official and he could be issued a citation or arrested for the offense. Mr. DAHIR stated he was going to officially apologize to Ms. SAGER during the next inspection, and he

was truly sorry.

While on scene, Officer GARLAND reviewed the licenses, which were not posted, however they were up to date. During this follow up investigation I did not observe any violations in the licensed premise. We were informed by the inspectors that they instructed DAHIR to clean up rat droppings in the basement prior to the next inspection.

Victoria SAGER (Environmental Health Specialist) was assigned to conduct the health inspection. SAGÈR requested for CPU to be present during the inspection, because the last time she inspected the business the owner made some inappropriate comments toward her and another health inspector. The owner of the business was identified as Marouf (NMI) DAHIR (I/M,

Upon arrival, I spoke to Marouf DAHIR who was very cooperative with the investigation and very apologetic for making the inappropriate comments to SAGER. SAGER discovered there were rat droppings in the basement which I observed, SAGER instructed Marouf DAHIR to clean up the rat droppings and he agreed that he would obliged. I observed that the business licenses were displayed in in view full behind the glass encased cash register area. The licenses were current.

The business agent was identified as Mohamad H. DAHIR (I/M, 0618/1997) who was not present during the inspection.

It should be noted that the business is not in nuisance monitoring.

- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
