Dear Ms. Patterson:


We have received your claim in the amount of \$1,405.00, relating to damage sustained to your property on December 1, 2004 at 4026 North 61st Street, Apt. 3 when the Milwaukee police allegedly entered your home to conduct a search.

Our investigation reveals the Milwaukee Police Department (MPD) was involved in a multi-agency operation that conducted numerous search warrants on said date. The MPD records do not reflect that they conducted any search at the location in question. Since the City did not cause your loss it cannot accept liability, as such, we are denying your claim.
