There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/13/22 at 3:10a.m., Milwaukee Police were dispatched to a Battery at 1434 E. Brady St. Investigation revealed a customer was arguing with the employee over an order placed. The argument escalated and more people entered the premise to back up the customer. The suspect then swung their fist at the employee, however, missed. A second suspect then went behind the counter and struck the manager, while a third suspect joined in. The agent was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 2.On 06/03/23 at 3:54a.m., Milwaukee Police were dispatched to check for a shooting scene as reported by a victim at a local hospital. The officer did locate one shell casing and one unfired cartridge in front of 1434 E. Brady St. The business was closed; however, the officer noted a surveillance camera that may have captured the incident. The officer attempted to contact the agent or employees to retrieve the video surveillance, with negative results.

LICENSED PREMISE REPORT

07/18/2023

This report is typed by P.O. Shahriar SOLATI, assigned to District One, Late Shift, Squad 1391.

On Sunday, 11-13-22, at 3:10am, I was dispatched to a Battery complaint at 1434 E. Brady St. (Wings Over Milwaukee), in the City and County of Milwaukee

Upon arrival, I observed an unidentified white male employee, bleeding from his face. I also observed a laceration to his upper left lip area. I observed the subject to be behind the business counter. Squad 1340 (P.O. Ryan BALLOGH and P.O. Martinis HUGHES) and 1341 (P.O. Aaron FROH) also responded to this assignment.

Upon arrival, I observed the victim, identified as Nathan S. JERABEK (W/M, 11-15-94), to be bleeding from his mouth area with a severe laceration to his upper left lip area. NATHAN stated that he is the General Manager for the above listed Wings Over Milwaukee. NATHAN stated that on 11-13-22, at a little before 3:00am, he was alerted to an argument at the front of the restaurant between one of his subordinates and some customers. NATHAN stated that the patrons were upset because they felt cheated out of food that they paid for. NATHAN stated that he attempted to calm the situation down but was unsuccessful. NATHAN stated that one point, Suspect #1 takes a closed right fist swing at him from over the counter but missed. NATHAN stated that he then moved to behind the register and curled up in a defensive position in fear of further attack and doesn't remember who attacked him further. NATHAN stated that the whole situation happened so fast and that there were too many subjects to get any description of the actors.

I then spoke with a witness, identified as Austin J. GWIDT (W/M, 10-18-96), who stated that he was working as a cashier on 11-13-22, at a little before 3:00am, when an unknown black male came in and began to complain about paying for a six piece of wings that he claimed he never received. AUSTIN stated that the male had two unknown black females came in and began to join the male in yelling at him. AUSTIN stated that the females began to get really upset with him and yell at him louder, claiming that they were being disrespected. AUSTIN stated that NATHAN was alerted to the situation and came up front to help ease the problem. AUSTIN stated that NATHAN attempted to calm the subjects down but that it was not working. AUSTIN stated that four to five other unknown subjects came into the restaurant to back up the male and two females. AUSTIN stated that once the additional subjects came that the original male took a swing at NATHAN with a closed right fist but missed. AUSTIN stated that after that, the whole group began to physically attack NATHAN. AUSTIN stated that he then ran to the back of the store to get help. AUSTIN stated that the situation happened so fast that he couldn't get any descriptions of the actors involved.

I then viewed video surveillance of the incident, provided to me by the owner, Bryan C. RIEBER (W/M, 5-20-85). On 11-13-22, at approximately 3:03am, I observed an unknown black male (Suspect #1) arguing with the victim along with two unknown black females. A short time later I observed suspect #1 appear to hold back the two females from engaging with NATHAN. I then observed 4-5 additional unknown persons enter the establishment in defense of Suspect #1 and the two unknown females. I then observed Suspect #1 swing over the counter with a closed right fist in attempts to strike NATHAN but was unsuccessful. I then observed a second subject (Suspect #2) approach NATHAN from behind the counter and strike him in the face with a closed right fist. I then observe NATHAN turn and duck down behind the cash register in a defensive position. I then observed a third subject (Suspect #3) run up from behind NATHAN and begin to strike him multiple times with closed right and left fists. I then observed all the suspects and subject run out the front of the store (south side) and flee in an unknown direction.

The business and all of the employees were cooperative with Milwaukee Police Officers during the investigation.

The video was recovered and inventoried/uploaded to AXON.

While on scene, I observed the licenses posted and they were up to date. During my investigation I did not observe any violations in the licensed premise.

Per the district community partnership unit this location is not a designated nuisance premise.

On Saturday, June 3rd, 2023, at approximately 3:54 A.M., I (myself, in full-duty uniform, and operating marked MPD Squad 499, as Squad 1390, and wearing department-issue AXON body camera) responded to 1434 E. Brady St. I went to this area to check for a potential shooting scene, as reported by a shooting victim at Froedtert Hospital. I was joined by Squad 1330; P.O. Brendan KULCINSKI, and Squad 1310; Sergeant James FILSINGER. Upon arrival, I took note of one casing, and one unfired cartridge. Both were .40 caliber Federal rounds. These were located just in front of Wings Over Milwaukee, which was the address of 1434 E. Brady St. This area was an open surface parking lot to a strip-mall business setting. I noted an interior camera of Wings Over Milwaukee, which would have been facing directly at the incident scene. I immediately closed down the scene, and began checking Tritech for potential business agents or employees. I located two, listed as Bryan G. RIEBER (w/m, 05-20-85), and Austin J. GWIDT (w/m, 10-18-96). Due to the business being closed, I attempted multiple calls to both employees, but was unsuccessful in gaining a response.

Some time later, CIB arrived and took control of the scene. I later was tasked to walk to 2047 N. Cambridge Avenue and attempt to contact GWIDT in person at his place of residence. Upon arrival, I discovered this apartment complex had a locked interior lobby, and despite ringing every unit, was unable to gain a reply from anyone including GWIDT. I returned to the scene and informed CIB of this. I was informed that CIB would conduct follow-up at a later time, if desired. I was unable to speak to any staff member, or review any video at the scene. As such, I have no licensing information or business agents to list.

The hearing before the Licenses Committee will take place on 9/6/2023 at 10:15 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
