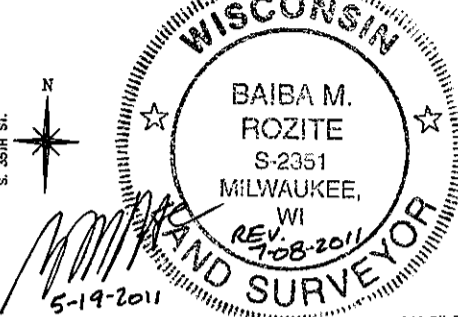
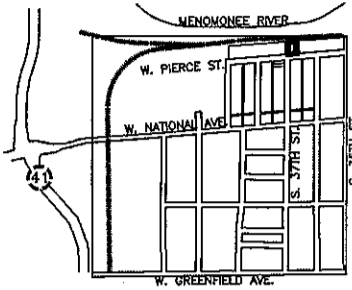

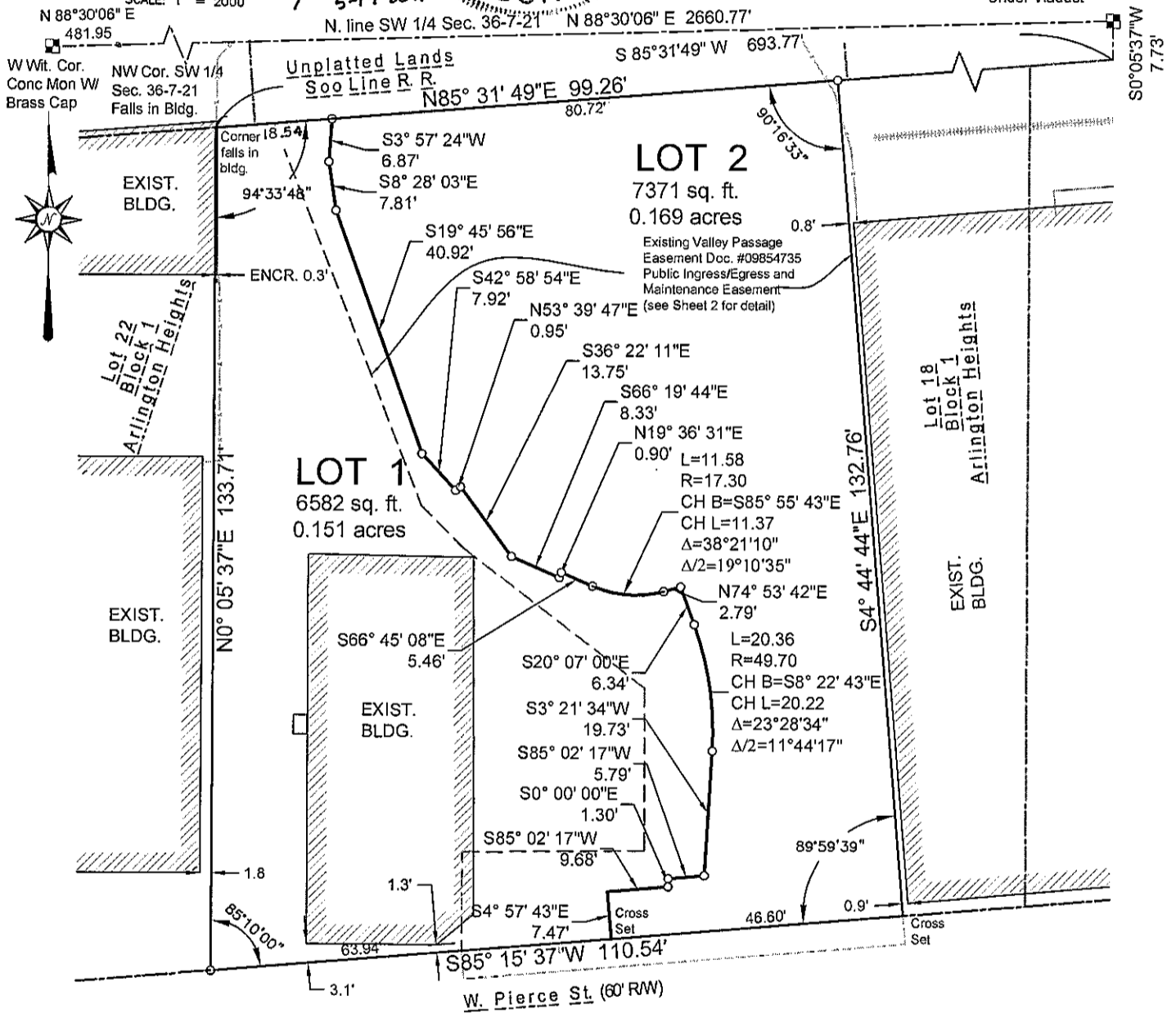

SW 1/4 SEC 36-7-21

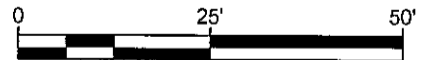

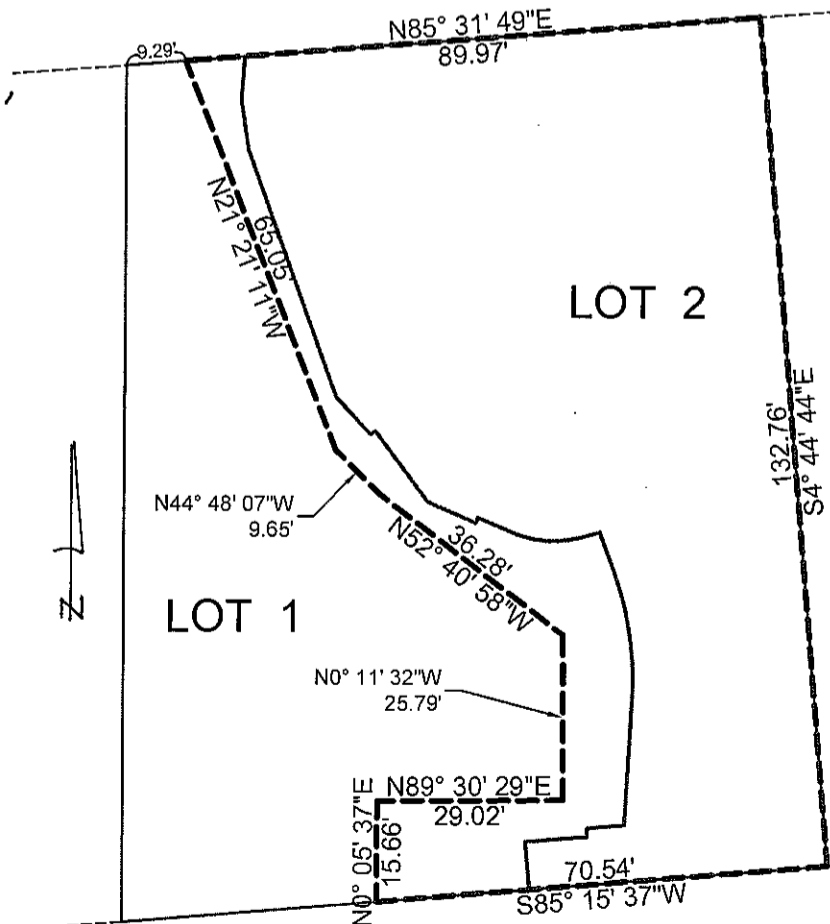
Said parcel contains 13,953 square feet or 0.320 acres of land, more or less.

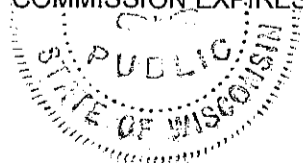
