Unfortunately, the drivers of these units have no control as to the amount or velocity in which the snow and ice comes off the snow b' le during plowing operations.

In that the snow plow operator was reasonable and prudent in the course of their duties, we cannot accept liability for your damages. Accordingly, we are denying your claim.
