Outdoor: We propose to install the condenser unit on the back patio on the second floor. Refrigerant lines to be ran through line hide to the eave and into the attic.

Attic: We will run a perimeter high velocity ductwork package through the attic. All runs will be insulated. The Unico blower and coil unit will be hung to reduce noise. The unit will be installed with a secondary pan underneath the unit and a wet switch flood protector in the pan.

2nd Floor: We propose to run 15 supply runs total. Each bedroom will have 3 runs with an additional 2 runs in the bonus room off the child's bedroom at the back of the house. We will also install a run in the bathroom. Upstairs closets will be used to get runs to the first floor. There will be a 14x30 return air filter grill located in the hallway at the top of the stairs. We will mount the thermostat near this location.

1st Floor: We propose to install up to 9 runs (9 for in the downstairs. 2 runs in the kitchen, 2 runs in the dining room, 3 runs in the living room, 2 runs in the foyer.
