INITIAL INVESTIGATION

This report is written by P.O. Andrew DUDLEY, assigned to District 1, Late Power Shift, Squad 1431.

On Saturday, July 1st, 2023, at approximately 11:50 PM, while assigned to Code Red detail on Brady St, I was approached by the victim of a theft complaint, identified as Alexis SCHNITZLER (f/w, [REDACTED]), that had occurred at the address of 1216 E. Brady St. in the City and County of Milwaukee.

SCHNITZLER stated that she was working at the location and observed that her backpack, which was in an unsecured back hallway where employees keep their belongings during their shift, had been unzipped and items inside were in disarray. SCHNITZLER went through her backpack and observed that her wallet (containing her WI issued driver license, Cash App debit card, Forward Bank debit card and credit card, Associated Bank debit card), apartment keys and vehicle key fob to her Ford Escape had been taken from her backpack.

SCHNITZLER had a manager check camera footage from the hallway which showed that at approximately 11:10 PM a B/F, approximately 35-45 years old, heavy build, wearing a white t-shirt, black leggings and white tennis shoes was in the hallway and going through bags hanging in the hallway.

SCHNITZLER emailed me images of the suspect from the security cameras which were uploaded to evidence.com.

SCHNITZLER had already canceled the credit/debit cards that had been taken prior to reporting the theft.

I provided SCHNITZLER with a PV-17, Community Contact Card and advised her to contact me with any questions, further information, or if any charges posted to her accounts.

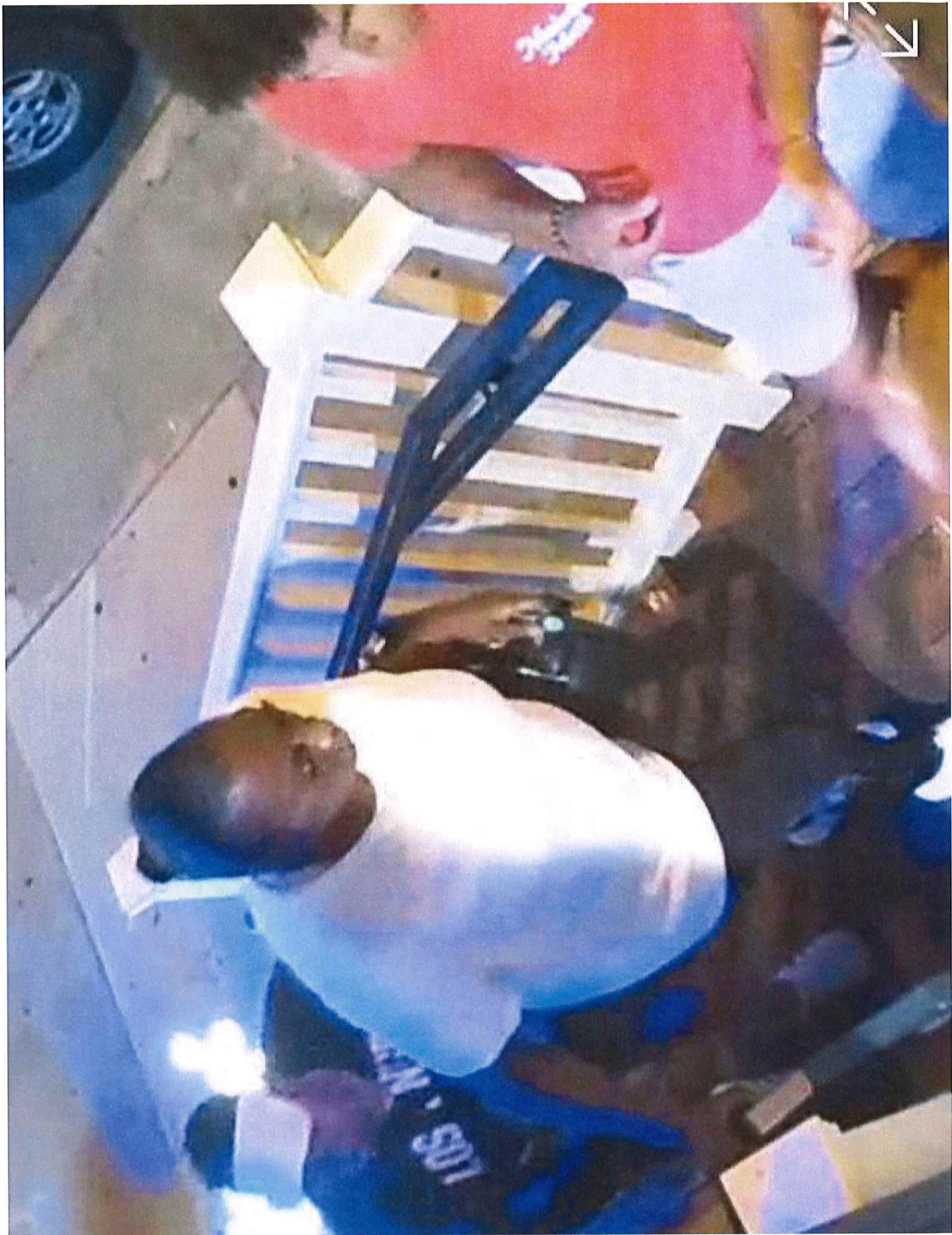

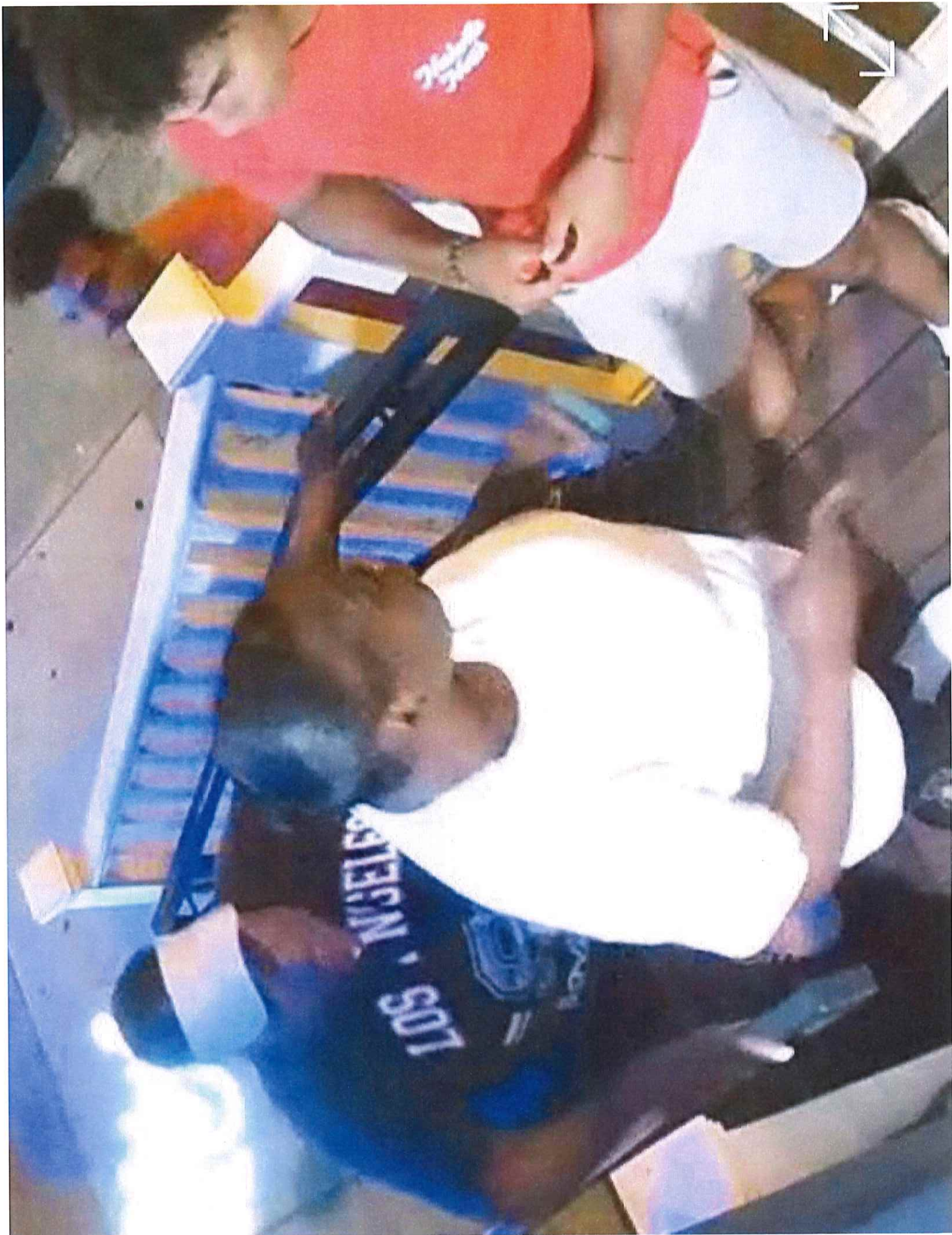
