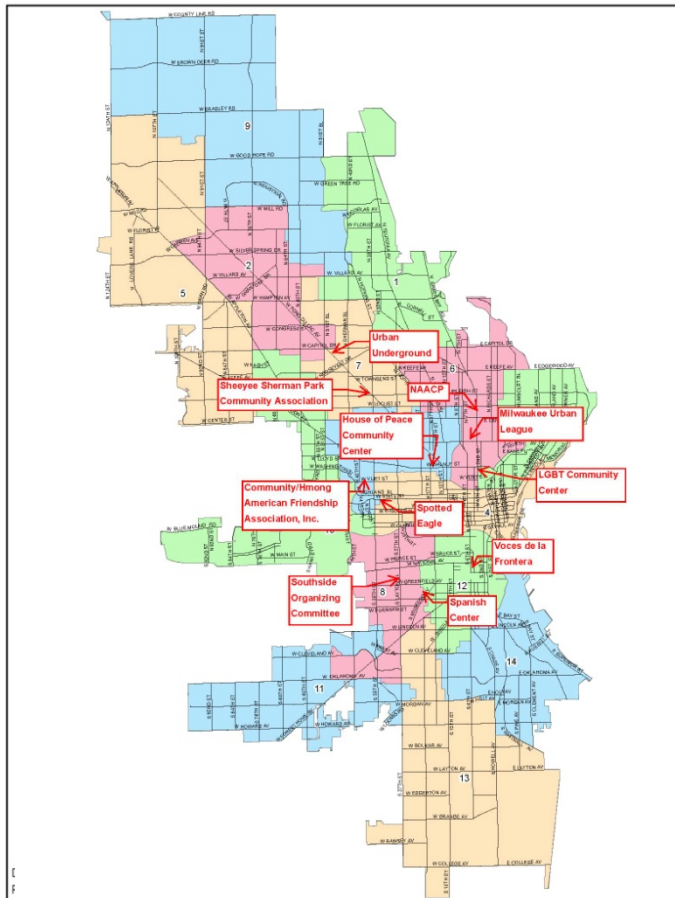


Community Relations

- The Fire and Police Commission is celebrating its 125th anniversary in 2010.
- The FPC website (www.milwaukee.gov/fpc) received over 10,500 hits in September 2010.
- FPC staff participate in over 120 community meetings outside of City Hall annually.

- Accept complaint forms



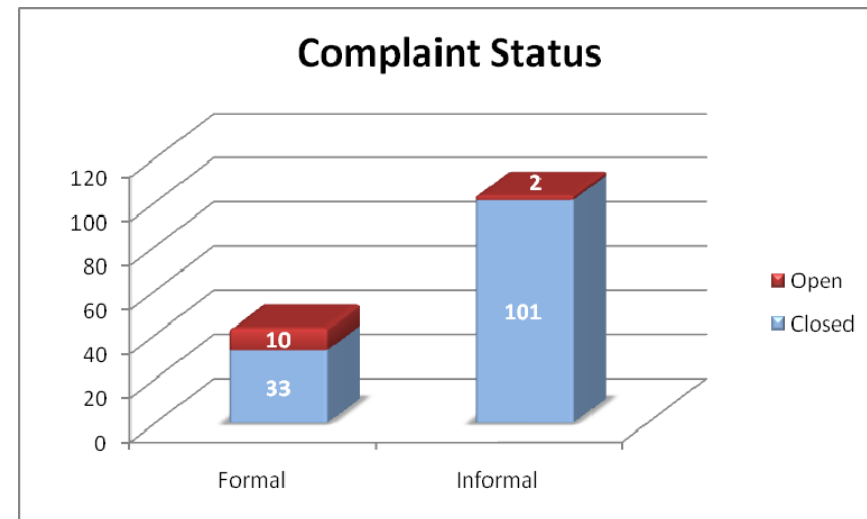
Fire and Police Employment

- 119 Fire Department employees were appointed/promoted in 2009.
 - 64 Fire Department employees separated in 2009.
- 193 Police Department employees were appointed/promoted in 2009.
 - 132 Police Department employees separated in 2009.
- Mark Rohlfing, former Fire Chief of Rapid City (SD) Fire Department, appointed as new Fire Chief of the Milwaukee Fire Department in May 2010.

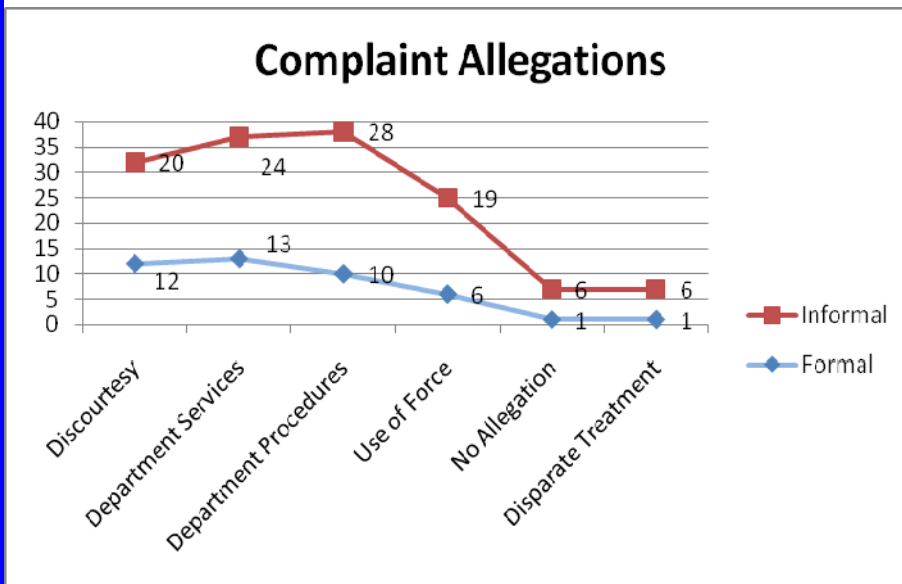


Citizen Complaints

- Mediation expanded to complaints filed with MPD
- 146 complaints were filed with the FPC between January 1, 2010 and June 30, 2010.
 - 103 informal complaints
 - 43 formal complaints
- 188 complaints (66 formal, 122 informal) filed during first 6 months of 2009



Complaint Allegations



- Most formal complaints alleged discourtesy, department service, or department procedures.
- Most informal complaints alleged discourtesy, department services, department procedures, or use of force.



Analysis of Use of Force

- FPC published reports analyzing MPD's use of force for 2009 and the first 6 months of 2010.
 - First time a report of this magnitude was undertaken.
- In the first 6 months of 2010, there were 262 use of force incidents.
 - Approximately 1% of all arrests involved use of force.

Office of Emergency Management and Homeland Security

- Transition began in January 2010
- \$2.2 million UASI funding received for public safety and emergency response projects
- Initiated upgrade to All Hazards Emergency Operation Plan for 5-county area
- July 2010 flooding disaster declaration
 - Federal assistance approaching \$30 million
