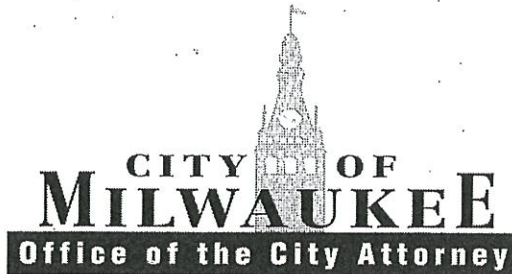

Dear Ms. Harmon:

We have received your claim for the amount of \$8,765.64 in relation to the vehicle damage you sustained on February 13, 2014 near North 27th Street and West Burleigh Street.

The Fleet Services Department reports the City of Milwaukee vehicle was stopped at a red light at the intersection of North 27th Street and West Burleigh. Your vehicle, driven by Sharda Lowe was traveling on the shoulder of the road on North 27th Street attempting to make a right turn. Once the light turned green, the city vehicle continued northbound and Ms. Lowe attempted to merge back into traffic colliding with the city vehicle.

Based on this information, the damage to your vehicle was not the result of any negligence of the City of Milwaukee and therefore the city is not legally liable for your damage.
