Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 3-14-2003 at 9:40pm and underage Milwaukee police aide entered Jo-Cat's Pub, 1311 E Brady St. at the direction of Milwaukee police officers. The aide was able to purchase 2 bottles of beer from the bartender, Jeno J Cataldo.

2. On 5-23-2005 at 1:20am Milwaukee police were sent to Jo Cat's Pub, 1311 E Brady St to investigate a fight. They learned that a fight began inside the tavern between 2 females. The licensee, Patricia Cataldo attempted to break up the fight and a male patron pushed her away and then the bouncer got involved. As the bouncer was escorting someone out of the bar another patron began to fight with the bouncer. Seven patrons were arrested for Disorderly Conduct and one of them additionally charged with Resisting/Obstructing

- 3. On 5-30-2005 at 1:25am Milwaukee police were sent to Brady and Arlington PI. regarding a battery. A male stated that he was in front of Jo Cats Pub, 1311 E Brady St. when he became involved in an argument with one of the bouncers. This male was observed by the officers to be very intoxicated . The bouncer was issued a citation for Assault and Battery and the male/victim was issued a citation for Disorderly Conduct.
- 4. INCIDENT On 8-13-06, at 5:25pm, officers were dispatched to a report of a subject threatening to shoot the bartender, at Jo-Cat's Pub, 1311 E Brady Street. On arrival they found a highly intoxicated person, who told the bartender, "How would you feel with an automatic going through your body." He lifted his shirt making gestures indicated he had a gun. One arrest for Disorderly Conduct. Report filed.
- 5. On 03/14/09 at 8:00 pm, Milwaukee police were dispatched to the 951 N James Lovell for a Battery complaint. Officers spoke to the victim who stated that on 03/13/09 at 11:30 pm, he and some friends were at the Jo Cat's Bar located at 1311 E Brady Street. The victim stated he had an altercation with a known subject who was also in the bar and that he suffered a contusion to the left forehead and several of his teeth were chipped. Officers did observe these injuries to the victim. It should be noted that the victim did not immediately call police and when asked why, he stated he was confused about what to do and played video games all day. Follow up was conducted and officers spoke to the suspect as well as the bouncer who was working that night regarding this incident. The case was ordered into the DA's office where no charges were issued.
- 6. On 04/27/08 at 2:04 am, Milwaukee police were dispatched to 1311 E Brady for a Fight/Battery complaint. Investigation found that a patron was denied entry into the tavern due to capacity limits. The subject left but returned shortly later and was told he still could not enter due to capacity. The subject then punched the bouncer in the face causing a minor injury. A citation was issued to the subject for Assault and Battery.

11. On 04/10/11 at 3:20 am, Milwaukee police were dispatched to 945 N 12th Street for a Battery complaint. Officers spoke to the victim who stated he was beaten up outside of a bar located at 1313 E Brady Street. The victim stated he was approached from behind when he was struck in the face multiply times with a closed fist. On 04/14/11 at 11:20 pm, officers conducted follow up regarding the battery and spoke to the bartender Daniel Fischer and Erik Lund who work as bouncers for the bar. Fischer and Lund stated there were no problems in or outside of the bar and that they did not put their hands on anyone that night. Police then spoke with the manager Lorenzo Cataldo who also stated there were no problems in or outside of the bar and that they don't have any cameras inside or out of the bar.

14. On 10/10/2014 at 2:10am officers went to Jo-Cat's at 1311 E. Brady St for a tavern check. From outside the bar a Sergeant observed a male inside the tavern sitting at the bar with a glass of opaque liquid in front of him. When officers entered the bar the glass was gone and the bartender, Lorenzo CATALDO, was serving the subject, who was not a bar employee, water. CATALDO became agitated while speaking with officers and threw a glass on the floor. The applicant was cited for allowing patrons after hours.

- 15. On 02/19/2015 officers went to Jo-Cats, 1311 E. Brady St for a tavern check. The officers provided Lorenzo CATALDO with a packet of tavern related ordinances that are commonly found in violation. The officers offered CATALDO time to answer questions related to these ordinances and any other issues.
- 16. On 03/06/2015 at 9:45pm officers went to Jo-Cats, 1311 E. Brady St for a tavern check as part of an underage tavern enforcement initiative. The 19 year old Police Aid was challenged at the door for ID and denied entry when she was unable to produce and ID.

 17. On 08/07/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to 1311 East Brady Street (Jo-Cats Tavern) but was denied when she could not produce proof she had attained the legal drinking age of 21.

- 18. On 07/31/2016 at 2:30am an officer was flagged down for a fight at Jo-Cat's, 1311 E. Brady St. The officer observed the fight on the ground on the front steps of the tavern and heard glass break. The subjects in the fight had been inside Jo-Cat's earlier in the night. One subject had bumped into the other and words were exchanged. At closing time outside the tavern the suspect saw the victim and attacked him with a glass beer bottle. The manager, Lorenzo CATALDO, was on scene and told the officers that the fight started somewhere else and ended in front of Jo-Cat's.
- 19. On 03/30/2017, officers conducted underage tavern enforcement in District One. At 8:05pm, an underage Police Aid was able to gain entry to Jo-Cat's, 1311 E. Brady St, through the front door where there was no security. At the bar the Police Aid ordered and was served a Miller Lite beer for \$4.00. The bartender was Crystal VAUGHN. On 03/31/2017 the officer informed Timothy AVRIT that the bar failed the check.

20. On 11/14/2017 a subject walked in to District 1 to make a complaint of a battery which occurred on 11/12/2017 at Jo Cats Tavern, 1311 E. Brady St. The victim, Paul LARKIN, stated he was at the bar and thought he observed the bouncer watching a video of the mens restroom on his phone. LARKIN then took a female patrons phone from a table and hid it in the bathroom. The female patron told security her phone was missing and they watched the video and saw LARKIN take the phone and go to the bathroom. The phone was recovered and returned to the patron. Security confronted LARKIN and took his ID. After closing LARKIN asked for his ID back and security refused. He stated security and another unknown subject began hitting and kicking him. After a time one of them stated "That's enough" and LARKIN got up and walked out. On 11/14/2017 officers went to Jo Cat's and recovered LARKIN's ID and asked for video of the incident. They checked the bathroom for video cameras but did not locate any. The officers were advised the video would be produced. On 11/21/2017 an officer went to check for the video but was advised to speak with the manager. On 11/24/2017 the officer returned and spoke with the manager, who stated he would check for video, no video was produced. On 01/15/2018 the officer issued a citation to the bouncer for Assault and Battery.

- 21. On 10/14/2018 at 1:22am officers were dispatched to a battery at Jo-Cats Pub, 1311 E. Brady St. The officer spoke with the victim who stated he fell down the stairs as he was leaving. The victim was conveyed to the hospital where he received stitches to his head. On 10/19/2018 the officer conducted follow up at Jo-Cats checking for cameras. The owner, Lorenzoo CATALDO, stated there are no cameras on the door. He stated he was bartending that night and remembered the victim buying a lot of drinks that night. CATALDO stated the injury happened outside and he was told the victim fell and hit his head.
- 22. On 11/29/2018 at 7:48pm officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Jo-Cats, 1311 E. Brady St. The Police Aid was allowed inside and purchased a Miller Lite beer for \$4.00. On 11/30/2018 at 12:05am the officers notified Lorenzo of the failure and he stated he did not know who the bartender was based on the description. He then stated he was not pleased with how the officers did not immediately issue the bartender a citation. He then posted a picture of the Police Aid on Facebook to warn the other owners of the ongoing sting. \
- 23. On 07/18/19 at 3:50pm, Milwaukee Police, along with an agent from the state Alcohol and Tobacco Enforcement Unit, conducted a license premise check at 1311 E. Brady Street. Officers found 17 bottles of contaminated bottles of alcohol inside the establishment which were emptied and thrown away. No other violations were found.
- 24. On 09/06/20 at 1:30pm, Two subjects entered the First District Police Station to report a battery which occurred on 09/06/20 at 1:45am. They told officers the fight occurred on the sidewalk outside the address of 1311 E. Brady Street and involved patrons from that establishment.
- 25. On 11/29/20 at 12:10am, Milwaukee Police were dispatched to 1311 E. Brady Street for a battery complaint. Investigation revealed that a subject tried to enter the establishment but security told him that the tavern was at capacity. The subject then tried to push his way into the establishment and security pushed him, causing him to fall backwards down the steps sustaining injuries. A subject, who identified himself as the owner, said that he has surveillance cameras that would have captured the incident but he could not provide it to the officers.
- 26. On 02/13/21 at 1:20am, Milwaukee Police, along with the Department of Health Services, conducted a license premise check at 1311 E. Brady Street. Violations observed were; no six foot spacing from other occupants, no face coverings, and no adequate seating available. The manager on scene was notified of the violations and he was cooperative.
- 27. On 02/28/22 at 1:04am, Milwaukee Police were dispatched to 1311 E. Brady Street for a battery compliant. Investigation revealed that a patron inside the establishment was intoxicated and attempted to fight several people inside and outside the tavern. The subject was located and given a citation for disorderly conduct.

28. On 04/28/22, First District Police Officers, along with Milwaukee Police Aides, performed an underage tavern enforcement initiative inside the First District boundaries. At 10:21pm, a Police Aide entered the tavern at 1311 E. Brady Street and was able to purchase an alcoholic seltzer. The bartender was issued a citation for Sale of Alcohol to Underage Person and the applicant was issued a citation for Allow Underage on Premise.

He informed officers that he was not allowed inside because he was acting inappropriately and the subject spit on him. He asked the subject to leave and the subject left.

30. On 05/29/23 at 11:44p.m., Milwaukee Police were dispatched to an Overdose at 1311 E. Brady St. The manager advised officers a patron became unconscious and they contacted medical. The staff were cooperative and provided medical assistance until MFD arrived.

31. On 01/09/24 at 11:45p.m., Milwaukee Police were dispatched to a Battery at 1311 E. Brady St. Investigation revealed a patron was escorted out for being disorderly, when they attempted to re-enter, another patron became involved and a fight ensued. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is written by PO Elliott SANDERS-BARTA, assigned to District One, Late Shift, Squad 1330.

On Tuesday January 9th, 2024 I was dispatched to 1311 E Brady St for a Battery.

On scene I spoke with bar owner and licensee manager, Lorenzo G CATALDO (W/M 03/17/1984) and bar security, Alex R SPERRY (W/M 04/09/1992). Both who were cooperative with this investigation.

SPERRY said he was working at the bar as security when he observed a male (Ivancarlos A ARAYA-SCHRANER W/M 03/31/1985) and female (Karin M STOWE W/F 11/21/1982) arguing. SPERRY said he overheard ARAYA-SCHRANER telling STOWE that she lost him clients, but was unsure what the complete context of the argument was. SPERRY said the argument between the ARAYA-SCHRANER and STOWE who were patrons of the bar continued and escalated to the point that he asked ARAYA-SCHRANER to leave the bar. SPERRY said ARAYA-SCHRANER was escorted out of the bar, but then later tried to reenter without permission. SPERRY said ARAYA-SCHRANER approached the door and SPERRY told him he was not allowed to re-enter the bar. SPERRY said the ARAYA-SCHRANER then forced the door open and a fight ensued between another patron and ARAYA-SCHRANER.

CATALDO was not on scene at the time of the incident but came to the location after he heard there was an issue. CATALDO provided me with video footage of the incident on his personal phone while I was on scene. The patron who fought with ARAYA-SCHRANER goes by "NATE" unknown spelling and date of birth. I sent CATALDO an evidence request for the video footage and CATALDO sent the footage to evidence.com while I was on scene. CATALDO mentioned that he heard STOWE was saying that her wallet got stolen or lost and that's was possibly started the incident. CATALDO said ARAYA-SCHRANER has been a patron of the bar for years.

I viewed the video footage after it was sent to evidence.com. In the first video SPERRY can be seen standing and leaning on a wall at the front door of the bar. ARAYA-SCHRANER approached the front door of the bar on the south sidewalk and from the west on E Brady St. The patron NATE can be seen smoking a cigarette in the front of the bar. ARAYA-SCHRANER walks up to the top step of the bar entrance (there are 5 steps to walk up to enter the bar). ARAYA-SCHRANER can be seen scolding SPERRY while pointing at him as he walks up the bar steps. ARAYA-SCHRANER gets to the top step and stands over SPERRY who is still leaning against a wall and holding his jacket. ARAYA-SCHRANER then grabs the door handle and starts to open the bar door. SPERRY stands up and puts his hand on the bar door to prevent ARAYA-SCHRANER from opening it. ARAYA-SCHRANER then forcibly pulls the door open with his right hand and then again pushes the door with his left hand causing SPERRY to be pushed backwards

while SPERRY was standing on the fourth and fifth step. As SPERRY is pushed away by the door NATE (who is now on the steps to assist SPERRY) punched ARAYA-SCHRANER in the left cheek area. ARAYA-SCHRANER then reaches back with his right arm to punch but instead falls down the steps. SPERRY pulled Nate away from ARAYA-SCHRANER as soon as NATE punched ARAYA-SCHRANER causing NATE and SPERRY to fall down the steps. It appears ARAYA-SCHRANER fell down the steps because ARAYA-SCHRANER was trying to throw a punch at SPERRY and Nate who were already falling down the steps. In the video it appears ARAYA-SCHRANER falls from the 3rd or 4th step to the sidewalk. It appears as if ARAYA-SCHRANER may have hit his head on the concrete from the fall from the stairs. All subjects then leave the camera view.

The second camera video is from the second story of the bar viewing down towards the sidewalk. ARAYA-SCHRANER, SPERRY, NATE, and another unknown subject enter the camera view. This view appears to begin when the subjects leave the area of the initial camera footage. ARAYA-SCHRANER is on the ground and NATE appears to kick at ARAYA-SCHRANERs head area. SPERRY can be seen moving NATE away from ARAYA-SCHRANER. NATE then walks out of video view. SPERRY and the unknown subject can be seen assisting ARAYA-SCHRANER who is now sitting on the ground.

When we arrived ARAYA-SCHRANER was on scene still arguing with STOWE. I looked at ARAYA-SCHRANER and I observed blood running down his left eye area with swelling on his left eyebrow, the blood ran down his face to his Green Bay packer jersey. PO ROECKER initially interviewed ARAYA-SCHRANER. ARAYA-SCHRANER was highly intoxicated and accusing SPERRY of throwing him down the stairs. ARAYA-SCHRANER then said SPERRY's friends attacked him and that it was, "coordinated gang activity." ARAYA-SCHRANER did not provide any information on what occurred before the altercation.

PO ROECKER also interviewed STOWE who now identified herself as ARAYA-SCHRANER's fiancé. STOWE who was also highly intoxicated but she said she saw ARAYA-SCHRANER on the ground getting attacked. No further details from STOWE. While on scene STOWE was trying to get ARAYA-SCHRANER to leave the area and not pursue with any police investigation.

ARAYA-SCHRANER refused medical attention on scene.

ARAYA-SCHRANER was very upset with me that I did not arrest SPERRY who was on scene. it was clear to me that SPERRY had no involvement in this incident other than telling ARAYA-SCHRANER he could not reenter the bar, holding back NATE, and then assisting ARAYA-SCHRANER after falling to the ground. I informed ARAYA-SCHRANER that another patron had hit him not SPERRY, but ARAYA-SCHRANER disagreed. NATE was not on scene.

ARAYA-SCHRANER then told me he would not allow me to take pictures of his injuries because he does not trust me. ARAYA-SCHRANER would not provide me with his new and current address in Milwaukee (DOT has the Wausau address).

ARAYA-SCHRANER then decided to go to Columbia St Mary's hospital through a ride share. ARAYA-SCHRANER then asked me to take photos of his injuries.

We changed locations to St Mary's. ARAYA-SCHRANER was put into ER#6, Admit time 1:03AM, and seen by PA Vittel.
