This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/25/07 at 2:58 am, Milwaukee Police were dispatched to 5806 N 76th Street for a Armed Robbery Complaint. Investigation revealed that earlier, at about 1:30 am, the victim was at the gas station at 2707 W Burleigh getting gas and when he was getting back into his car, three men entered his auto and one held a gun to his back demanding the victims car. Officers spoke to the gas station manager who stated he was unaware of the robbery. Officers were able to view videotape that the manager provided officers.
2. On 04/27/07, Milwaukee Police along with an agent from the Department of Revenue were conducting tobacco enforcement investigations at 2707 W Burleigh. The agent found that there were no invoices for the cigarettes or blunt wraps. Some of the stamps were unreadable on the boxes of cigarettes. The agent confiscated the above items.

3. On 07/24/08 at 4:26 pm, Milwaukee police were conducting sales of tobacco products to underage persons and had a 15 year-old subject enter 2707 W Burleigh. The clerk, later identified as Asghar Choudry, sold a pack of Newport 100's without first asking for any ID. Choudry was uncooperative with police and at first refused to provide his ID when asked by police. A citation was issued to Choudry for Underage Tobacco Sale.

4. On 02/27/08 at 1:17 pm, Milwaukee police were dispatched to 2707 W Burleigh Street for an Armed Robbery complaint. Investigation found the victim pumped gas and left his car running while he ran inside to pay for gas. As the victim exited the store, he observed a subject running towards his car when the victim approach said subject, the subject then pulled a gun and pointed it at the victim firing several times but no shots were fired. The suspect then entered the victims' car and fled the scene. No injuries were reported.

Disposition added to item #3 02/19/2010

5. On 02/21/2009 at 1:43am Milwaukee Police, while on routine patrol, were flagged down by a citizen in the parking lot of the business at 2707 West Burleigh Street (A and I Petroleum). The citizen informed officers that he had observed 3 subjects running through the yards away from this location and that one of the subjects appeared to be armed with a handgun. Investigation revealed the business had been robbed at gunpoint (the weapon used was a BB gun) and that three actors had fled on foot. Police incident report #090520032 filed.
6. On 06/24/2009 at 4:00pm a 16-year-old subject, working in conjunction with Milwaukee Police on the Wisconsin WINS tobacco initiative, was able to purchase a pack of tobacco product from a clerk at 2707 West Burleigh Street (A and I Petroleum). The clerk, Asghar A. Choudhry, was cited for Sale of Cigarettes to Minor/Underage. This citation was later dismissed without prejudice in Milwaukee Municipal Court. The applicant was not cited.
7. On 01/26/2010 the applicant met with Lieutenant James MacGillis, Officer Minisha Howard and Officer Ray Robakowski, all of the Milwaukee Police Department, in the conference room at Milwaukee Police District #5 concerning the illegal activity around the licensee's properties. The applicant indicated he had recently installed drop safes in his businesses and that he makes cash pick-ups from the businesses during the day. He further stated that this business has 16 digital security cameras at the business with 4 of those cameras being outside and he welcomes additional police presence. The applicant states he has assisted police previously by providing DVD copies of surveillance footage from his security cameras and that he encourages his employees to both cooperate with police and to call if there are any problems. The applicant was provided with contact information for District #5 and the Community Prosecution Unit.

8. On 04/26/2012 Milwaukee police responded to a Battery/Robbery complaint at 2707 West Burleigh Street. Investigation revealed the victim was purchasing items from the business when the suspect attempted to take her purse from her auto. When the victim's boyfriend intervened, the suspect struck him in the head with a glass bottle. Milwaukee police incident report #121170024 filed.
9. On 01/12/2012 Milwaukee police conducted a security survey at 2707 West Burleigh Street in an attempt to combat some of the violent crime occurring in the area.

10. On 06/12/13 at 9:45am, a Milwaukee Police Officer along with an agent from the Wisconsin Department of Revenue conducted a licensed premises check at 2707 W. Burleigh St. (Gas Depot). The employee on duty was able to provide the agent invoices for cigarette and tobacco purchases. The licenses were current and posted. No violations were found.

11. On 09/23/19 Milwaukee Police were flagged down for a complaint of multiple subjects dealing drugs in front of the gas station located at 2707 W. Burleigh St. On arrival officers observed 6-8 subjects loitering in front of the location; who upon sight of the officers began to walk away. Upon entering the business officers interviewed a male sitting on top of a ice cream cooler. The subject was wearing a plain white t-shirt and blue jeans and notified officers he was security. The subject referred officers to a female in the store who he identified as being in charge. The female stated she owns the security company. Both individuals were uncooperative with police, refusing to identify themselves. The agent was notified via telephone and the subjects eventually provided identification. The clerk on scene was cooperative.

12. On 06/28/20 Milwaukee Police were dispatched to Gas Depot, 2707 W. Burleigh St., for a Shot Spotter call for service regarding 13 rounds. While enroute to the call officers were advised by dispatch there was also a trouble with subject call in which at least 15-20 cars were in the lot and people were dancing on top of vehicles and being loud. On arrival officers observed 75-100 people and at least 20 vehicles in the lot, blocking the driveways. Officers were able to disperse the crowd with no further incident. Officers interviewed the employee who stated the crowd began to gather earlier, then overflow onto W. Burleigh St. The employee was asked why he didn't call sooner; however, he could not provide an answer. The agent was contacted and advised of the situation. The agent stated he was aware this was an ongoing issue regarding subjects and his business.

13. On 03/05/21 Milwaukee Police conducted follow up at Gas Depot, 2707 W. Burleigh St., regarding a drug dealing investigation that took place in the lot earlier in the day. An officer spoke to the employee on duty and was cooperative and provided officers with video surveillance pertinent to the earlier investigation. Officers attempted to identify a security guard at the location, however, the subject refused to identify himself. Police contacted the agent and advised him of the investigation and he was cooperative acknowledging he is aware drug dealing is occurring in the lot and will make a better effort to contact police in the future.

On Friday, March 5, 2021 Squad 5469 (P.O. Robert PARKS and myself) conducted follow up at 2707 W. Burleigh St. (Gas Depot) in the city of Milwaukee. We went to location at 7:35 p.m. to obtain video surveillance of Drug Dealing that occurred at approximately 1:50 a.m. on the same date. Please refer to IR# 21-064-0009.

On scene we spoke with employee who was working the cash register, he was identified as Nisham SINGH (I/M 08-09-91). SINGH stated that I could look at the video surveillance. SINGH also stated that he works from 10:00 a.m. to 10:00 p.m.

P.O. PARKS checked the following Licenses on the premise

- Cigarette and Tobacco #1029169
- Weights and Measures #0005712
- Filling Station #0001355
- Food Dealer

All of the licenses were issued on July 7th, 2020 and expire on July 6th, 2021.

P.O. PARKS attempted to identify the security who was working inside the location. The security guard refused to give his name and stated that Police would shoot him.

On scene I was able to obtain video surveillance of Drug Dealing that occurred at the gas pumps at the location.

At 10:33 I contacted the Business Agent, who is identified as Mohammed I YOUNAS (u/m 11-02-59). I informed YOUNAS of the reason for our stop at the Gas Depot. YOUNAS informed me that he knows that Drug Dealing is occurring and he will make a better effort to contact Police in the future. YOUNAS also agreed to meet with myself at District Five in regards to information he may have about Drug Dealing/Dealers that frequent his location. A meeting will be set up at a later date.

This concludes my report.

INITIAL INVESTIGATION

This report is written by P.O. Nicolas FERRANTE, assigned to District 5, Late Shift, Squad 5321 with (P.O. Brent SLUKA).

On Sunday, June 28, 2020 at approximately 2:57 AM, Squad 5321 was dispatched to the area of 3076 N 27th St, for a shot spotter call for service regarding 13 rounds (Flex 404814).

While en route we were advised by dispatch a related Trouble with Subject call for service was coming in regarding The Gas Depot (2707 W Burleigh St) in which the caller who was an employee stated that there were 15 to 20 cars, in the lot of the gas station and that the subjects were dancing on top of vehicles being loud and causing a disturbance. The caller also stated that he locked the doors to enter The Gas Depot.

Upon arrival we staged due to us observing at least 20 vehicles in The Gas Depot parking lot, blocking the driveways, we also observed at least 20 vehicles on W Burleigh St, just West on N 27th St, on both sides of the road blocking traffic. In total there was approximately 75 to 100 Subject in the gas station parking lot, the sidewalk to the north, and in the street on W Burleigh.

Squad 5390 (P.O. KRUEGER), Squad 3340 (P.O. GONZALEZ, and P.O. GONZALES), and Squad 3490 (P.O. NORWOOD, P.O. DAVIS) arrived on scene to assist with the Shot Spotter investigation and large crowd that had congregated at The Gas Depot (2707 W Burleigh St). All 4 Squads activated lights in sirens, in fully marked squad cars, and made announcements over the PA system to inform the crowd to disperse. After minutes of making attempts to break up the crowd and push traffic through, vehicles and subjects began to disperse. It should be noted many of the vehicles left in all directions in a reckless manner, and had subjects hanging from out the windows.

A C15 was given regarding the shot spotter CAD which was across the street of the The Gas Depot, on N 27th St (east side).

The Gas Depot (27070 W Burleigh St)

I spoke with a Karandeep SINGH (W/M 5-5-95), who is an employee of The Gas Depot. SINGH stated that a crowd began to congregate in the parking of the business around 2 AM, and began to overflow onto W Burleigh St. I asked SINGH why he did not place a call for service regarding sooner, and he was unable to provide a reason to why. I also asked SINGH if he heard any gunshots or witnessed any subjects with guns in the area, which he answered No. **Upon our arrival it the lights to the business interior and exterior were turned off, and the doors locked.** SINGH then allowed me inside the business to check posted license, which were posted behind the counter.

I asked SINGH if the extended hours license had been renewed, he stated he believed the owner had been granted an extension. It should be noted no license was posted for extended hours past the date of 6-30-20.

I then made contact with Younas MOHAMMAD (W/M 11-2-59) who stated he was the owner of The Gas Depot. MOHAMMAD states this has been a ongoing and growing issue regarding subjects and his business. MOHAMMAD was unable to provide me an answer for why a call for service was not placed sooner regarding the subjects. MOHAMMAD stated that he had been granted an extension regarding the licenses of the business, no paperwork was observed while I was on scene. A check of the licenses shows an expiration date of 7-31-20 for the Provisional Renewal Licenses.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


