Dear Mr. Murphy:

We have received your claim in the amount of \$615.12, relating to damage allegedly sustained to your vehicle on January 31, 2005 when a sanitation crew was collecting garbage at 3647 South 92nd Street.

Our investigation reveals the Sanitation Division inspected your garbage cart and it had some red paint on a corner of the lower rung. The location of the paint does not line up with the damage to your vehicle. In addition, the paint does not match the color of your vehicle. Since the City did not cause your loss, it cannot accept liability as such, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
