This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/27/23 at 7:02p.m., Milwaukee Police were dispatched to a Reckless Use of Firearm at 6544 N. 76<sup>th</sup> St. Officers were met by the victim who stated an occupied vehicle in the drive thru requested a shake. The employee advised the shake machine was broke but offered another drink instead. When the employee turned away from the vehicle a suspect fired a BB gun, striking the employee in the back, as well as causing damage to the drive-thru window. The employee stated they email video of the incident to officers for review.
2. On 04/29/23 at 6:57p.m., Milwaukee Police were dispatched to a Reckless Use of Weapon at 6544 N. 76<sup>th</sup> St. Officers were advised a subject pulled into the drive-thru, however, did not reply after being asked if they could be helped. Eventually a verbal argument ensued between the employee and the customer. The employee later was outside smoking when a subject approached armed with a handgun and asked "are you the bitch on the speaker", then left the location. The officer requested video surveillance and was advised it wouldn't be available until a later date.
3. On 05/28/23 at 11: 45a.m, Milwaukee Police were dispatched to a Battery at 6544 N. 76<sup>th</sup> St. The victim stated they were picking up a Grub Hub order and after beeping their multiple times, an employee came outside and assaulted them. The officers interviewed a manager who was cooperative and provided the employee's information as well as video surveillance of the incident.

4. On 06/26/23 at 7:13p.m., Milwaukee Police were dispatched to a Threat at 6544 N. 76<sup>th</sup> St. The manager on scene advised officers a customer was upset over their order and began to make threats to assault all the employees. The business was cooperative with the investigation.
5. On 07/07/23 at 11: 23a.m, Milwaukee Police were dispatched to a Hold Up Alarm at 6544 N. 76<sup>th</sup> St. On arrival officers found the doors to be locked, however, the business was operating normally. Officers spoke to a manager who stated there were no issues.
6. On 07/20/23 at 4:25p.m., Milwaukee Police were dispatched to a Robbery at 6544 N. 76<sup>th</sup> St. Investigation revealed the suspect placed an order and when the cash drawer opened to collect the money, they suspect pushed the employee's hands away and took money out of the cash drawer then fled. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
7. On 09/26/23 at 6:04a.m.; Milwaukee Police were dispatched to an Entry at 6544 N. 76<sup>th</sup> St. Investigation revealed a suspect gained entry via a locked drive-thru window and left via the front door. The manager did not notice anything missing and it didn't appear anything else was disturbed. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
8. On 12/05/23 at 1:51p.m., Milwaukee Police were dispatched to a Threat at 6544 N. 76<sup>th</sup> St. Investigation revealed a subject was asked to leave due to them harassing customers and asking for money. The subject refused but fled the scene when police were called.

### Dispatch Call Type and Detail:

CLLR REPORTING SUBJ FIRED BB GUN AT WINDOW, STS BB GUN HIT HIM IN BACK

### Initial Observations and Scene Description:

The incident occurred at 6544 N 76th St. which is a one-story restaurant named Burger King with a drive thru for vehicles coming to the restaurant. Burger King also has a dine area for customers but, has been currently closed to customers and used to bring out customers' orders. This door is locked and not accessible to anyone on the outside. This entrance is facing the east. Officers observed a window, next to the front entrance door shattered, but still intact.

### Interview of Victim Timothy L. JONES (B/M 02-01-1993)

JONES stated that around 6:54pm, a Silver SUV pulled up to pick up their orders. While on scene JONES stated he noticed in the driver seat a thin black male, wearing a gray hoodie in his mid 20's ask for a shake. JONES stated that the shake machine at Burger King was not working proper but asked if he would like a pink Lemonade instead. The driver agreed to the drink, JONES stated that as he turned to enter Burger King. JONES stated as he turned his back to the vehicle, the passenger in the back seat of the SUV pulled a BB gun and shot approximately (3) three times. JONES stated at least one bb hit him straight in the back which caused physical

pain. JONES stated the bb's also struck the window to the business causing the window to be damaged. JONES stated the vehicle then drove off onto N. 76th St and JONES went inside and contacted police.

There were no witnesses on scene. JONES stated though there was CCTV Camera footage but was unsure if they had caught the scene on camera. JONES stated he would send footage to the email provided on the Crimes victim for Officers to review.

On 4/29/23, at approximately 18:57 pm, PO Doughty and I were dispatched to a Burger King, at the address of 6544 N 76th St for a reckless use of weapon call for service. This address is located in the City and County of Milwaukee.

Upon arrival, I made contact with the victim who was identified as Angela L Swope (b/f,11/26/82).

Interview with Swope:

Swope, whom is the manager at the Burger King stated she was working as the drive through attendant when a black tinted sedan, pulled up to the order window. Swope stated she said, "welcome to burger king, how can I help you". Swope stated she did not get a response, and then asked again if she could help then. Swope stated she then again got no response.

Swope stated she and the driver engaged in a short verbal argument, but the driver never ordered any food. Swope stated she then walked out towards the east side of the Burger King to smoke a cigarette, and the dark sedan pulled around towards where she was standing.

Swope stated the driver described as b/m, 25-30, medium build, braided hair, wearing a gray hooded sweatshirt, and gray pants.

Swope stated the driver exited the dark sedan, armed with a black handgun, and pointed the handgun at Swope multiple times and said, "are you the bitch on that speaker".

Swope stated she replied, "Over a burger". Swope stated the driver then left the location.

I inquired about viewing Burger King's video surveillance. I was advised by a general manager video surveillance will not be available until Monday May 1st.

The victim stated after blowing her horn repeatedly at the workers, an unknown female employee came outside the location and assaulted her. The business was locked upon our arrival but was opened up by the general manager (*James Kirk*) who provided the necessary information on the worker and also allowed for video review of the incident. This incident will be handled with a citation as soon as the suspect is located.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the battery, I did not observe any violations in the licensed premise.
