Upon arrival, my partner and I spoke to an employee at the listed location (CVS Pharmacy) who was verbally identified as Adrian ROMERO (W/M 12/25/2004). ROMERO gave officers an envelope that contain a device that was observed to be a skimming device. The employee elaborated that a customer notified them on January 31st a piece of the ATM broke off and they put in a service request. The repair man notified them today it was a piece of a skimmer.

NIEVES stated she confronted this subject about the items in the bag and the subject stated " you,better not touch me" as she reached into the bag. The suspect then exited out the store without paying. The total stolen is estimated to be between \$70 -\$85 in items.

NIEVES stated the subject was a B/F, 45-50 YRS OLD, 5'08", 150 lbs, wearing a leopard print hat and black jacket.

On 06/19/25 at 2:00 P.M. I was dispatched to 3860 S. 27th St., the C.V.S. Pharmacy, to investigate a retail theft. The district manager called to report that a B/M and a B/F had just stolen various store merchandise. While enroute I observed this call to have been initiated at 1:22 P.M.

Upon arriving at 2:09 P.M. I was met outside by the caller and C.V.S. district manager Scott A. MARTIGNETTI, W/M, 02/12/82. MARTIGNETTI then told me that a B/M and B/F entered the store together, filled a shopping cart with merchandise, and stole the merchandise by leaving the store without paying for any of the items.

MARTIGNETTI then took me to the back office at which time he showed me the surveillance video of the incident. At 1:13 and 36 seconds a black female about 30 years of age, wearing a long brown wig, a white short-sleeve v-neck polo shirt, black pants and knee-high brown boots enters the store. Also with this person is a B/M about 25-30 years of age wearing a white long sleeve pull over shirt, black cargo shorts and white tennis shoes. Upon entering the store, the female gets a shopping cart at which time both subjects proceed to the aisle containing the cleaning supplies and diapers. Both male and female then begin filling the cart with store merchandise listed in the property tab of this report.

At 1:20 and 53 seconds, both subjects, after filling the cart with store merchandise, leave the store with the cart without paying for any of the items. Both subjects then walk to a vehicle which was parked in the lot and after placing the stolen merchandise inside of the vehicle both subjects got into the car together and left the scene. The camera which covers the area in the lot where the suspect's parked their vehicle was not working at the time so there is no description of the suspects vehicle. The total amount of merchandise which the suspect's stole is \$243.41. MARGINETTI uploaded the video which captured this incident to the Axon Evidence system.
