This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/12/2020 at 6:12am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The caller provided a description of the subject and the officers located the subject walking away from the store. The subject admitted the theft and was returned to the store where he was positively identified. The subject is known to the business and has been issued a no trespassing order in the past. The subject was arrested.
2. On 07/20/2020 at 5:20am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers interviewed the manager, who stated two subject came in and stole a shopping cart full of merchandise. The manager could not give a list of the items stolen and could not access the video system.
3. On 08/02/2020 at 1:57am officers were dispatched to Walgreens, 3233 S 27th St for an Armed Robbery. The officers interviewed the clerk who stated a subject produced a firearm and demanded money. The subject obtained money and fled the scene. The officer were able to recover video of the incident.
4. On 08/02/2020 at 9:40pm officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officer interviewed the manager, who stated a customer told them someone was stealing merchandise and he has no description of the suspect or merchandise taken. The manager stated they will review the video in the morning and call if they develop a suspect.

5. On 08/06/2020 at 9:54am officers were dispatched to Walgreens, 3233 S 27th St for a Welfare Check. The call was for a known subject in the store "huffing" compressed gas. The officers located the subject in the parking lot and conveyed him to Detox for treatment.
6. On 08/17/2020 at 11:00pm officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers spoke with the manager, who stated a known subject came in the store on four separate occasions and stole merchandise. The manager could not access the video system for the officers.
7. On 08/28/2020 at 1:23am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The caller was a security guard contracted by Walgreens. The officer spoke with the manager, who stated he did not want to make a complaint and was advised by the company to not call the police for basic retail theft complaints.
8. On 08/29/2020 at 2:01am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers interviewed the manager, who stated a subject jumped the counter unoccupied counter and began stealing cigarettes. The subject fled the scene and the manager did not recognize the subject.
9. On 09/01/2020 at 10:23pm officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers interviewed the clerk who stated she caught a subject behind the counter stuffing cigarettes in his pants. She confronted the subject and he jumped over the counter, grabbed a bag with additional merchandise and fled the scene. The manager showed the officer video of the incident.
10. On 09/03/2020 a meeting was held regarding recent calls for service at Walgreens, at 3233 S 27th St. The officers spoke with the Asset Protection manager for Walgreens, who advised them of upgrades to the location that should help. They want to lock up high price commonly stolen items and change security companies or possibly hire off duty police officers. He stated they may also change the business hours to close at midnight instead of being open 24 hours. The officers issued the business a nuisance designation letter.
11. On 09/04/2020 at 11:45pm officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers interviewed an employee, who stated the store was closed for cleaning but the door was left slightly open by a contractor. A subject entered the store and filled garbage bags with tobacco products and other merchandise. The subject fled the scene. The manager was able to make a copy of the video for the officers.
12. On 11/03/2020 at 12:58am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officers interviewed the security guard, who stated a subject was walking out the door with an arm load of merchandise. He stopped the subject, who dropped the merchandise. As he was picking up the items the subject punched him in the head. The subject fled in an auto. The manager provided video of the incident.
13. On 11/23/2020 at 12:07am officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officer spoke with the manager who stated a subject was observed shoplifting. When security stopped the subject and asked him to remove the concealed items the subject refused. The subject turned toward them armed with a screwdriver and fled the scene.

14. On 12/01/2020 officers were flagged down at Walgreens, 3233 S 27th St for a Retail Theft. The officer spoke with security who stated he had stopped a subject for shoplifting and would like him removed from the store. The subject was issued paperwork telling him to never return.
15. On 12/04/2020 at 9:01pm officers were dispatched to Walgreens, 3233 S 27th St for a Theft. The officer spoke with the manager, who stated an unknown subject broke into the cash register and took money. The manager provided officers with video of the incident.
16. On 12/17/2021 at 5:45pm officers were dispatched to Walgreens, 3233 S 27th St for a possible theft of Prescription. The caller stated a subject picked up his prescription without his permission. The business was cooperative with the investigation.
17. On 12/18/2020 at 6:15am officers were dispatched to Walgreens, 3233 S 27th St for a Trouble with Subject. The officer spoke with the manager, who stated a subject was sleeping in the store and refused to leave. The officers were able to wake the subject and escort him from the store.
18. On 12/30/2020 at 6:39pm officers were dispatched to Walgreens, 3233 S 27th St for a Sick/Injured call. The officer met with MFD who was on scene with a subject requesting to the hospital for medical treatment. The officers conveyed the subject to St. Francis Hospital.
19. On 12/31/2020 at 6:34pm officers were dispatched to Walgreens, 3233 S 27th St for a Sick/Injured call. The officer spoke with the manager, who stated a subject came into the store and requested they call an ambulance for medical treatment.
20. On 01/05/2021 officers were dispatched to Walgreens, 3233 S 27th St for an Auto Theft. The officers interviewed the caller, who stated he went into the store and left his car outside still running. While he was inside an unknown subject took his car with his dog inside.
21. On 01/06/2021 at 4:08pm officers were dispatched to Walgreens, 3233 S 27th St for a Retail Theft. The officer spoke with security, who stated a subject was stopped for concealing merchandise on his person. The subject was issued a citation for Retail Theft and arrested on outstanding warrants.
22. On 01/24/2021 at 11:50pm officers investigated a Theft at Walgreens, 3233 S 27th St. The investigation revealed the suspect was standing in the checkout line. When the clerk opens the register to put money away, the suspect reaches over and removes the cash drawer and takes the money. The manager provided officers with video of the incident.
23. On 01/27/2021 at 9:05pm officers were dispatched to Walgreens, 3233 S 27th St for a Subject with Gun. In the original call the caller stated the subject had left the scene. The officer spoke with the caller by phone about the subject legally open carrying a firearm. The officers did not visit the store.
24. On 02/07/2021 at 1:23am officers were dispatched to Walgreens, 3233 S 27th St for a Theft. The officers interviewed the manager, who stated a subject added \$380.00 onto a prepaid credit card without paying the money. The manager did not know why the clerk completed the transaction without obtaining the money. The clerk was no on scene to interview.

25. On 02/24/2021 at 1:11pm a meeting was held at Walgreens, 3233 S 27th St, regarding their Nuisance Abatement plan. The store representative stated they have secured their high theft items, have uniform security at night and they are working to identify suspect to get No Contact orders issued.

This report was written by PO Jedidiah THOMPSON, assigned to District 6 late shift.

On Sunday, July 12, 2020 at 6:12am my partner, PO Daniel PARKS, and I responded to the Walgreens located at 3233 S 27th St for a report of a shop lifter. The caller stated that a Hispanic male wearing a blue shirt and brown pants had placed several items in a "party bag" and left the store without paying.

While we were responding to the location I observed a Hispanic male wearing a blue shirt and brown pants walking northbound on 27th St holding a children's party gift bag. After stopping the subject at 3145 S 27th St he stated that he just got a gift for his girl. When I asked him if he had a receipt for it he stated "No I'm guilty." The subject was then identified as Dante G LOPEZ-GIRON (H/M 06/03/1994). A check of CCAP revealed that LOPEZ-GIRON was on bail for shoplifting, Milwaukee County Case 2020CM807.

I observed that the bag was full of several sets of woman's socks, a note book, marker, and disposable face mask. I then conveyed LOPEZ and the bag back to Walgreens. I went into the store and spoke to Lefty E BURGOS. She stated that she was working at the store when LOPEZ came in at about 5:45am. BURGOS stated that she knows LOPEZ to be a chronic shoplifter who had been served with a no trespassing order. She stated that she observed LOPEZ take a gift bag and start filling it with items. She then went and started to call the police. BURGOS stated that while she was on the phone LOPEZ stood near the register with the bag. He then told the employee that was working at the register that he wasn't going to pay and walked out of the store.

BURGOS rang up the items that I had recovered from LOPEZ. They totaled \$105.86 before tax. I conveyed the receipt to District 6 where I was placed on MPD inventory 20024198. LOPEZ was conveyed to St Lukes Hospital for medical clearance.

On Monday, July 20th, 2020 at 5:33am, Squad 6331 (PO Terrance ISLAND and I) was dispatched to 3233 S. 27th St (Walgreens), which is in the City and County of Milwaukee, for a Shoplifter complaint.

The CAD stated a male and female went into the store and stole a backpack and shopping cart full of items before fleeing northbound. The male is a B/M, 40-50 YOA, wearing a black shirt, red shorts, and backpack. The female is a B/F, 30-50 YOA, with a shopping cart.

The clerk, Madie, advised her manager Bobby W. SAXTON (m/b, 1-28-87) that these two subjects entered the store and stole items. Madie stated the male went behind the counter and removed cigarettes. The male also took candy and then walked behind the photo counter and removed unknown items. The female subject was observed placing items into a shopping cart with unknown food items.

The employees from Walgreens stated they did not know what items were taken, the value of the items, and SAXTON was unable to make copies of the video due to not having access to the video system.

SAXTON stated this is a daily occurrence where people come into the store and steal items. SAXTON stated he has asked corporate for assistance and possibly getting a night time security guard.

This report is being written by PO Nash DATHE, assigned to District 6, Late Shift, off group 6.

On August 2, 2020, Squad 6341 (myself) was dispatched to Walgreens located at 3233 S 27th st in the City and County of Milwaukee for an armed robbery. Upon arriving, I made contact with the manager Hussein ABDI (B/M, 01/01/1994). ABDI stated that the store was robbed by an unknown black male carrying a black handgun. ABDI stated he did not see the incident but was paged to the front of the store immediately after the robbery occurred. ABDI stated the only items taken was an unknown amount of money taken from register 2.

I then spoke with Madia JOHNSON (B/F, 12/27/1990) who was the employee who was robbed. JOHNSON stated the unknown male walked into the store and pointed the black semi automatic handgun towards her and demanded the money fro the register. JOHNSON stated she is unaware as to the amount of money that was taken and did not recognize the actor involved.

A check of the exterior and interior cameras revealed the actor entered the store at 1:57 am and walked straight to the counter. The actor proceeded to point a gun towards JOHNSON and was then seen putting money into his pocket after JOHNSON had opened the register. The actor then left the location at 1:58 am.

Copies of the footage were recovered and placed on inventory and an FI attempted to recover prints from the scene.

This report was submitted by Officer Frederick TERRIQUEZ assigned to District 6, Early shift.

On Sunday, August 2nd, 2020 at 9:40pm, Officer Thomas KRESA and I, squad 6240 were dispatched to a retail theft complaint at the Walgreens drug store, 3233 S. 27th St. City of Milwaukee. The caller, Alex, stated a customer advised him that there was someone stealing merchandise in the store. No description was provided.

Scene:

The Walgreen Drug Store is located on the west side of S. 27th St. with access points to the north and to the south off a service road. The main doors are located on the south east corner of the building with parking to the east and south of the property. A drive through pharmacy is accessed off the north end of the building.

Interview with Manager Bobby SAXTON:

Upon arrival, I spoke to the store manager, Bobby SAXTON, b/m, 01-28-87. Bobby is the night manager at Walgreens. Bobby stated at approximately 9:30pm this date he was informed by an employee (Alex) working a cash register that a customer was stealing merchandise. Bobby stated he did not get a description of the suspect but called for the police as soon as he could.

Bobby stated he would look through the surveillance cameras the following morning and contact me with video of the suspect. I left my contact card with Bobby regarding this incident.

Interview with cashier Alex:

I spoke to Alex working at the front cash register, who stated, "I really don't have any information, just that a customer came to me and told me someone was stealing merchandise" Alex could not give me a description of the suspect stealing items nor did he know what the suspect was taking.

CERDA approaches the Black male, and the Black male has no problems taking additional items while she is talking to him. He then jumps over the counter, grabs the garbage bag full of additional property, and leaves the location. The surveillance video was placed on police INV# 20031709.

Based on a guess, the Black male took approximately \$150.00 worth of cigarettes, and \$250 worth of additional store merchandise.

This meeting was meant to discuss problems/issues and the amount of calls for service coming from this location and ways the Milwaukee Police Department and their business can work together to decrease the amount of calls for service and issues coming from this location.

Those present representing Walgreens were Store Manager Jason DREGER, District Manager Bob HILBER, and Asset Protection Manager Telly KNETTER. Also present during the meeting were Tara CAVAZOS representing the S. 27th Street/ HWY 41 BID, Alderman Mark BORKOWSKI representing the 11th Aldermanic District, and Assistant City Attorney Heather HOUGH. The subject then appears to take some batteries before going behind the photo booth counter and taking numerous amounts of Redbull from the cooler. Lastly the subject appears to take SD cards before gathering the bags and leaving the store.

MITCHELL stated the two employees were not in the main part of the store during this incident and were in the back area cleaning and re-stocking, which is what they were instructed to do. MITCHELL was able to pull up the video and make a copy for officers as well.

A incident report was filed and I am currently waiting for MITCHELL to conclude a inventory check to get the specific items that were taken during this retail theft.
