
This office is in receipt of your claim in the amount of \$945.00, relating to the loss of personal property when the Department of Neighborhood Services conducted a litter nuisance clean-up of your property located at 617 South 6<sup>th</sup> Street on April 23, 2003.

We are advised by the Department of Neighborhood Services that on April 9, 2003 an inspection was done at this property, and it revealed a litter nuisance. An order for clean-up was issued on that date. A copy was posted on the premises, the order was also mailed to the listed owner, Ruben Villa, 617 South 6<sup>th</sup> Street, Milwaukee, WI. A re-inspection of the property was completed on April 17, 2003. The re-inspection revealed the litter was present and in the same condition. The department hired a contractor to perform a clean-up on April 23, 2003. The Department of Neighborhood Services followed appropriate procedures in this matter, therefore, the City would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
