Whereas, The United States Census Bureau in April 2000 will conduct a Census of the City of Milwaukee to count and gather information about city residents; and

Whereas, The information collected by the Census Bureau will be used to reapportion and redistrict the United States House of Representatives as well as reapportion and redistrict State Legislative Districts and local governmental bodies; and

Whereas, Census data is the basis for the annual distribution of approximately \$200 billion in federal program allocations, such as education, housing and community development grants; and

Whereas, The City of Milwaukee recognizes the importance of an accurate count of

all its citizens in the 2000 Census and has proposed that a cooperative effort between the United States Census Bureau, the city, and community leaders be initiated to ensure that the hard to reach and historically uncounted segment of the city's population are counted and reflected in the 2000 Census; and

Whereas, In 1989 the Common Council of the City of Milwaukee, recognizing the importance of an accurate census, appropriated approximately \$100,000 for the 1990 Complete Count Project; and

Whereas The 1990 Complete Count Project was very successful in that approximately 30,000 more people were counted than demographers projected and the Census Bureau identified the Milwaukee project as a national model for successful outreach efforts and complete count projects; and

Whereas, The advantages for the City of Milwaukee in conducting a Complete Count Census Program with respect to the 2000 Census far outweigh the potential cost; and

Whereas, The City of Milwaukee, recognizing that current city resources are not sufficient by themselves to carry out a Complete Count Program will contract for the services of a person, business or organization to help plan and coordinate the city's 2000 Complete Census Program; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Council endorses the initiation and implementation of a Complete Count Census Program for the 2000 Census; and, be it

The actuary shall annually determine the funds necessary to provide all duty disability benefits under s. 36-05 >> for persons who first became members prior to February 1, 1996<< . He or she shall certify the contributions required of the city and the city agencies to provide such benefits.

Benefits arising under s. 36-05-3-c >>for persons who first became members prior to February 1, 1996,<< shall be paid only from a fund established for such purpose and such benefits shall not be paid from any other funds of the retirement system. It shall be a violation of law to do so. [[Effective January]] >>For persons who first became members on or after February<< 1, 1996, [[the duty disability, special fund shall be merged with the retirement fund. Thereafter,]] >>there shall be established a combined retirement fund and<< there shall [[no longer]] >>not<< be separate determinations each year of the funds necessary to provide all necessary duty disability benefits under s. 36-05 and benefits arising under s. 36-05-3 [[-c shall be paid from the retirement fund]] >>for such persons<<.

Resolution relating to directing the Department of Public Works to solicit proposals for operating the cafeteria in the City Hall complex.

Whereas, The cafeteria in the City Hall complex has traditionally provided convenient meals and snacks for public employes whose duties require them to shorten their lunch breaks or eat at their desks, as well as when inclement weather makes it difficult for workers to leave the complex and purchase lunch within the allotted time for lunch; and

Whereas, The cafeteria also provides an important public service by offering convenient food service to private citizens who are in the City Hall complex to pay their taxes, go to public meetings or attend other events of public interest and concern; and

Whereas, The Milwaukee Metropolitan Sewerage District ("MMSD") is authorized to ameliorate drainage problems within its service area; and

Whereas, In recent years, drainage-induced flooding along Southbranch Creek in the city of Milwaukee and the village of Brown Deer has caused significant property damage in the area; and

Whereas, To address this problem, MMSD hired a consultant to investigate and recommend options for reducing the frequency of flooding of Southbranch Creek; and

Whereas, The consultant recommended the construction of 4 detention basins sized to contain Southbranch Creek during the 100-year flood; and

Whereas, One of the proposed detention basins would be located on the property of Henry David Thoreau Elementary School, 7878 North 60th Street, between West Bradley Road and the tennis courts on the school property; and
