This Acknowledgement of Public Authority Responsibility is by and between the Forest County Potawatomi Community (TRIBE) and City of Milwaukee, Wisconsin (CITY).

Whereas the routes listed below in the CITY are important to the TRIBE in that they serve the tribal community, tribal business and/or tribal member's homes.

And whereas, the above-listed routes, and as depicted on the attached Exhibit A will continue to be owned by the CITY and open to the public for travel.

And whereas, the TRIBE has an interest in ensuring these routes are maintained and in adequate repair.

Now Therefore, the TRIBE and the CITY agree when and if adequate funding for improvements to the listed routes becomes available, and any of the CITY'S listed roadways become an approved project for the TRIBE.

1. The TRIBE will enter a subsequent agreement with the CITY to jointly determine the type, scope, and limits of improvements that could be implemented on the listed roadways owned by the CITY.
2. If needed improvements are made to any of the listed CITY routes, the CITY will continue to own the route and will continue to be responsible for maintenance.
3. This Acknowledgement of Public Authority Responsibility is binding upon the signatories hereto not as individuals, but solely in their capacities as officials on their respective organizations and acknowledges proper action of the CITY and the TRIBE to enter into the same.
4. The Acknowledgement of Public Authority Responsibility will become effective upon execution of the CITY and Tribe, unless otherwise noted below.
