Dear Ms. Strosin:


We have received your claim in the amount of \$115.00, relating to the towing of your vehicle that you allege occurred on October 20, 2004 from 305 East Clarence Street.

Our investigation reveals that your vehicle was towed on October 21, 2004 for being "Parked in Tow-Away Zone." The citation was before the Municipal Court on December 22, 2004 and you were found guilty, but the sentence was suspended, so you did not have to pay the fine. The City followed proper procedure in towing your car and, therefore, we are denying your claim for a refund of towing charges.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
