There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/26/2019 officers were dispatched to a fight at Stark Foods II at 4616 W. Hampton Av. The officer spoke with the caller who stated an employee choked him. The officer spoke with the employee who stated the subject was being disorderly and he was asked to leave. When the subject refused to leave the employee pushed him out. The officer spoke with the applicant who stated the subject was disorderly and the employee removed him. The officer observed the video surveillance which showed the employee talking with the subject for several minutes. After the subject refused the leave the employee grabbed him in a bear hug and pushed him outside. No citations were issued.
2. On 03/17/2020 an officer observed a vehicle parked in the disabled parking place at Stark Foods, 4616 W. Hampton Av. The officer knows the vehicle is the applicant and she does not have a handicapped permit. The officer has warned the applicant on prior occasions to not use the disabled space for parking. She stated that she was unloading items for the store and would move the car. On this date she was issued a parking citation.

3. On 05/10/21 at midnight, Milwaukee Police were dispatched to 5000 W. Chambers Street for a shooting complaint. The uncooperative victim described the address of 4616 W. Hampton

Avenue as the location of the shooting. Officers went to the address, found a cooperative employee who allowed officers to view surveillance video which showed no shooting, suspect, or suspect vehicles.

4. On 07/26/21 at 1:21am, Milwaukee Police were dispatched to 4616 W. Hampton Avenue for a burglary complaint. Investigation revealed that a subject entered the business through a ceiling vent, stole cigarettes, and left back through the ceiling vent.
5. On 09/03/21 at 1:38pm, Milwaukee Police were dispatched to 4616 W. Hampton Avenue for a battery complaint. Investigation revealed that two employees were involved in a physical altercation. The applicant was on scene and said that they both will be disciplined and neither employee wanted to prosecute.

7. On 02/04/24 at 9:53a.m., Milwaukee Police were dispatched to a Violation of Restraining Order at 4616 W. Hampton Ave. Investigation revealed a known panhandler was in front of the store approaching customers, however, was gone on police arrival. There was no restraining order on the subject.
8. On 03/13/24 at 6:35p.m., Milwaukee Police conducted follow up at 4616 W. Hampton Ave., regarding a ShotSpotter from 03/12/24, in which officers located casings in the parking lot. The business was cooperative and allowed officers to view video surveillance which depicts the suspects firing shots into the air. The business further identified the suspect, whom they have had problems with in the past and have called the police on.
9. On 03/25/24 at 11:41a.m., Milwaukee Police were dispatched to a Trouble with Subject at 4616 W. Hampton Ave. Officers were unable to locate the caller and the business was cooperative.
10. On 04/07/24 at 10:13a.m., Milwaukee Police were dispatched to a Welfare Check at 4616 W. Hampton Ave. Officers were advised a subject fell to the ground and their nose was bleeding, therefore the clerk called MFD, who were on seen treating the subject. The business was cooperative.

The following items are related to the business at 4616 W Hampton

11. On 09/21/24 at 10:00a.m., Milwaukee Police were dispatched to a Shot Spotter. Investigation revealed a suspect left the store without paying for an item. The Agent confronted the subject outside, where they displayed a firearm. The Agent went back inside to call police, at which time heard one shot fired. Officers did locate at casing in front of the business.
12. On 01/06/25 at 12:51p.m., Milwaukee Police were dispatched to a Trouble with Subject. Investigation revealed a subject causing a disturbance was asked to leave, then began knocking over items and throwing them to the ground. The subject was gone on police arrival.

The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

13. On 03/27/25 at 6:26p.m., Milwaukee Police were dispatched to a Property Damage. Investigation revealed the Agent called regarding a subject who had previously caused property damage to the store. The Agent stated the subject and other subjects were loitering and selling drugs in the parking lot. The Agent was cooperative and stated they would attempt to get officers more information on the subject's identity.
14. On 04/23/25 at 1:16p.m., Milwaukee Police were dispatched to a Battery. The Agent stated there were no problems at the store and the officers were unable to contact the caller.
15. On 05/01/25 at 12:00a.m., Milwaukee Police were dispatched to a Shot Spotter. Enroute officers were advised there was a shooting in the liquor store, however, on arrival found this to be a baseless call. The business was cooperative.
16. On 05/17/25 at 10:29a.m., Milwaukee Police were dispatched to a Threat. The business stated they wanted a subject to leave the business. On arrival the subject agreed to leave.
17. On 05/17/25 at 1:54p.m., Milwaukee Police were dispatched to a Trouble with Subject. Investigation revealed two subjects were in the parking lot holding firearms. Neither subject entered the location, however, the business thought it necessary to call the police as they were armed and arguing.
18. On 05/20/25 at 9:14p.m., Milwaukee Police were dispatched to a Battery. Officers interviewed the Agent who stated they have an on-going problem with a subject who bothers customers and gets upset when asked to leave. The caller was no longer on scene and appeared agitated and hung up on the officer.
19. On 06/06/25 at 4:15p.m., Milwaukee Police were dispatched to a Shooting. On arrival the officers observed multiple victims inside the store. One victim was pronounced deceased on scene. The business stated there was a scuffle between several subjects which led to gunfire. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
20. On 06/23/25 at 8:47p.m., Milwaukee Police were dispatched to a Subject with Weapon. On arrival it was determined this was a baseless complaint.
21. On 07/03/25 at 9:26a.m., Milwaukee Police were dispatched to a Subject Wanted. The business called regarding a subject that was wanted in a Burglary, however, the subject was gone on police arrival.
22. On 08/12/25 at 2:01p.m., Milwaukee Police spoke to an employee of the business who stated a subject that was causing trouble was no longer on scene.
23. On 08/12/25 at 8:05p.m., Milwaukee Police were dispatched to a Trouble with Subject. The employee stated a subject was sleeping in the store, had already left prior to officers' arrival.

On Saturday, September 21, 2024, at approximately 10:00am, Squad 7130 (P.O. Thomas DELANY and I) was dispatched to 4616 W. Hampton Avenue (Stark Foods II), which is located in the City and County of Milwaukee, for a ShotSpotter complaint.

Upon our arrival we canvass the area for casings. There was a round detected by ShotSpotter near 4616 W. Hampton Avenue. The address was a liquor store named Stark Foods II, located on the northside of the street facing south. There's an entrance from the east and another from the southwest side of the building.

I then spoke with Charn KAUR (A/F, 12-29-70, Cashier) who works at Stark Foods II. KAUR stated at approximately 9:35am two B/M entered the store and were inside for approximately twenty minutes. KAUR stated they attempted to buy some waters, but their credit cards would decline. KAUR stated they eventually paid for the waters with an EBT Food Stamp card. KAUR stated both subjects remained inside the store talking to other customers that walked in. KAUR stated they later asked her for a bottle of Xavier V (750ml bottle of Brandy), which cost \$8.99. KAUR stated suspect 2 was attempting to purchase the bottle by saying he had cash. KAUR stated suspect 2 then reaches over the counter and grabs the bottle. KAUR stated she suspect 2 did not pay for the bottle so she confronted both suspects outside the store. KAUR stated suspect 1 was inside the driver seat and suspect 2 was standing outside the vehicle. KAUR stated she told suspect 2 that he did not pay for the bottle, and he needed to pay. KAUR stated suspect 2 then lifted his shirt up and showed her a black semi-automatic handgun. KAUR stated she immediately walked back inside the store fearing for her safety and called the police. KAUR stated as she was calling the police she heard one gunshot fired.

CIB Squad 9190 (Detective Steven JEGEN) along with Squad 9162 (Detective Michael SLOMCZEWSKI) later responded to the scene and took over the investigation. Squad 9190 and 9162 review the video surveillance and place it on inventory. The business was cooperative and assisted us with the investigation.

On Monday, January 6, 2025, at approximately 12:51pm, Squad 7132 (P.O. Vincent ANDRYSCZYK and I) was dispatched to 4616 W. Hampton Avenue (Stark Foods), which is located in the City and County of Milwaukee, for a trouble with subject complaint.

Upon *our arrival* we did not observe anyone outside the store harassing customers. I went inside the store and spoke to the caller who identified herself as Navi KAUR (W/F, 12-29-70, Manager, Phone # 414-795-4056). KAUR stated there was a B/M outside her store harassing customers. KAUR stated the B/M would also enter the store and harass her customers inside and threw merchandise on the ground when asked to leave. KAUR stated the B/M has done this in the past and called police to have him removed from the property.

KAUR's Description of Subject

B/M, last seen wearing a black hat, black jacket, black hooded sweatshirt, black pants

The business was *cooperative* with the investigation. The business did not have security officers on scene.

I reviewed video surveillance footage. The footage showed the subject inside and outside the store harassing customers. Subject would enter the store and walk up to customers as to be begging for money. Subject then went towards the front registers and knocked over some candy boxes and walked outside.

While on scene, I observed the licenses posted and they were up to date. During my investigation I did

The following are remarks provided by the dispatcher prior to my arrival

16:57 Caller stated vehicles were selling drugs in her parking lot. Subjects came inside the store and damaged her store.

16:57 Suspects still on scene

16:57 Female involved said she has a gun but caller did not see one

16:57 4 vehicles involved. caller has video footage as well for the responding squad.

16:58 Color of the vehicles are red, light gold, black

16:58 Caller states 8 people involved. 4 females and 4 male subjects

16:58 No further information

18:24 Notify 7472 regarding backlog 10+ Pending

Upon my arrival, I P.O DANIEL observed the listed location to be occupied by Stark Foods, a liquor store, convenience store, and restaurant. The location appeared to be have multiple business that shared the adjacent parking lot.

I spoke with the caller Chern KAUR (A/F, 12-29-1970), 414-795-4056, the owner of Stark Foods, stated on March 27, 2025, at approximately 4:00 pm, a frequent customer known by the name of Bernice had caused damaged the cash register and knocked items to the floor. Bernice had also threw alcohol at

KAUR. KAUR stated that she wanted to call because Bernice was hanging out in the parking lot selling drugs with other males and females. KAUR stated that she wanted to report the incident to stop the loitering in front of the store. KAUR stated that Bernice had filled out an application to work at the store, in the past. KAUR stated that she did not have the application on hand with the Bernice information but would provide the information at a later date for Bernice to be ticketed.

The business was cooperative with the investigation.

The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed a black woman dress in all green, with a cup in her hand, appeared to be upset with KAUR. The woman was observed knocking items from the counter to the floor. The woman was later observed pulling the computer to the floor. She was observed outside of the store for approximately an hour with others talking, later leaving as the driver of Hyundai Suv dark in color.

The video showed a male in a Chevy trailblazer bearing the WI auto plate of ALR-7693 stopping customers, leaving, and returning to stand in front of the store with others. The male was observed to be selling unknown items from his car.

KAUR was able to give immediate access to cameras and assist officers.

No firearms were observed in the footage.

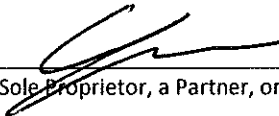
