

**C - Police Contact:** offender **has not** had police contact while on supervision







This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/07/17 at 11:39pm, a Pedi cab owned by the licensee was in an altercation with another Pedi cab company outside the Summer Fest Grounds (200 N. Harbor Drive). The other Pedi cab Company claimed that the operator of the licensees' Pedi cab battered her and was using an illegal Pedi cab (it had an electric motor). The police were summoned to the scene and after investigation, no citations were issued.

This report is typed by P.O. Corstan D. COURT assigned to First District - Late Power Shift. On 07/07/17 at 11:39pm, Bicycle Squad 1442, P.O.'s COURT and Xavier BENITEZ were dispatched to 200 N. Harbor Drive, (South Gate) for a battery complaint. Upon arrival, Officer's interviewed Beatrix MERCURY, w/f 01/25/84, owner of Mercury Transport, who stated that another Pedi-Cab operator battered her. MERCURY went on to say that she was waiting for her turn in line at the Pedi-Cab stand when she noticed that there was a Pedi-Cab that had a electric motor on the rear axle. When she confronted the operator, Arthur B. AMEY, w/m 04/04/88, he told her to get away and kicked her in the shin. MERCURY then "pepper-sprayed" AMEY and he left the area. While AMEY was gone and away from his Ped-Cab, MERCURY place a bicycle lock on one of AMEYs' Tri-cycle wheels to keep him from leaving with it when he returned. Officer's did observe a small abrasion on the lower part of the knee on MERCURY.

Officer BENITEZ located AMEY (who was the original caller) and he stated that MERCURY and two other Pedi-Cab operators, unknown which, surrounded his Pedi-Cab and told him to stop using his electric motor. When MERCURY tried to place a Bicycle lock on his front tire, he pushed MERCURY away and MERCURY sprayed him with "pepper-spray". This story was collaborated by the Pedi-Cab owner SYDOW.

Since there were two different accounts of the incident, officers allowed the complainants to decide if they both wanted to be cited or if they could avoid each other for the duration of the night. MERCURY and AMEY told officers that they did not wish to receive citations and MERCURY removed the bicycle lock from AMEYs' Tri-cycle and the subjects left.

Follow-up will have to be done on the ordinances regarding motorized Pedi-Cabs and the fine amounts associated with them.





Hello,

My name is \_\_\_\_\_ and I've been riding pedicab in Milwaukee since 2012. My business is

Last night I was attacked by a rider named Arthur Amey. He was renting a pedicab from James M Sydow (owner of Forward Pedicab). I request that you revoke his ability to ride in Milwaukee.

Arthur initially was asked politely to remove his ILLEGAL electronic assist wheel and stop trying to snake rides within 10 feet of our organized queue. When he refused, he also kicked my knee several times, bruising it badly and drew blood (see enclosed pictures). I had to mace him to defend myself. I then attached my personal U-lock to the wheel to prevent him from going anywhere while the cops were brought in. The cops had my back and told me to leave the lock on the wheel until they were through detaining Arthur.

These electronic assist wheels require special insurance/licensing and are prohibited in Milwaukee, so what he was doing was just plain wrong. He did this knowingly and deliberately to make more money and exploit our hard earned market for selfish gains. If he were to get into an accident at high speeds on a motorized pedicab in a town he is unfamiliar with he very well could have jeopardized my livelihood and put myself or the other members of the Rickshaw Guild of Wisconsin at risk of being associated with dangerous drivers. I will not stand by idly while this happens.

Since 2016 riders from Texas have been swarming in to exploit our town and our livelihood during summer fest upon invitation of James M Sydow. They are being housed by James and using his Milwaukee address to falsify Wisconsin residency under the loop hole that you have to be from here to ride here.

Although James is originally from here, and used to ride amongst us when the only pedicab business in town was Cream City Rickshaw, he has been traveling to Texas the past few years during the winters and made connections with these out of towners.

Last year, Nelson Sprague (Nomad Pedicab), was extremely confrontational with myself and a number of drivers and said several transphobic words to me, a transgender woman. It's hard enough dealing with the drunk harassment out there on a weekly basis as it is.

The bicycle police who stepped in to help me and told me to leave the bike lock i attached to the illegal wheel on Jame's renters cab while I did my best to continue working. James sought me out and confronted me by smashing into my cab head first and howled at me to "remove my F-ing lock off his property." James followed me, smashing into my cab several times along the way, continuing to scream at me and harass me. He veered into my wheels like a scene out of Ben Hur.

When I introduced James to the police officer who was helping me, James was informed that what I did was the right thing, and that the officer had requested me to leave my personal U-lock on the bike until they police were through detaining Mr. Amey.

Please consider looking into the falsification of address residency and the connections with Mr. Sydow, please consider revoking Forward Pedicab's ability to ride here, and please help keep Milwaukee safe by revoking Arthur Amey, and James M Sydow's PPL's.
