I was told by a city of milwaukee employee Aime Balistreri that there was side walk repair back in 2003 and roots was cut from the tree. I was not present at the time the tree fell on my SUV. Attached to this letter is a blue book estimate of the SUV which is \$25,350.00. As you can see in the photos that are attached there is no fixivng of the SUV. The SUV is totally rect. There is no fixing it what so ever I have brought machanics to look at the SUV and they also indicated that there is no fixing. I have examined the tree trunk which look like the trunk was rotted and there was not enough support from the roots to hold the tree. The tree was 24" in diameter and about approximately 60" in height. When the tree fell from across the street my SUV was parked on the other side. I would greatly appreciate if you can please reimburst me for the damages and loss of the car. This is evident that the tree should have been taken down long back in 2003 when the side walk was replaced. I do not feel that I should be held resposible for what has happend to my Lincoln Navigator for it was the city's tree that destroid it. I will like this matter to be rectified as soon as possible.
