Hello, I would like to file a complain with the City of Milwaukee regarding a driver for the Yellow Cab Company. The main dispatch number is 414-271-1800.

On Saturday, 04OCT2014, I called the Yellow Cab Company at 9:45 PM to make a reservation for a ride to the airport on Sunday, 05OCT2014 at 4:30 AM. The taxi never arrived. I called at 4:36 AM and again at 4:46 AM when I was told the driver got lost and was a few minutes away.

On Sunday, 05OCT2014 at 4:52 AM, Yellow Taxi Cab #164 arrived at my house. The cab driver promptly informed me his credit card reader did not function near the airport. I found this statement suspect, but agreed to pay cash.

The fare totaled \$14.50. I handed the cab driver \$20.00. At that time, I was told he had no change. I paid the cab fare, but did not receive change. I was late getting to the airport as it was and didn't have time to squabble over \$5.50. I would like to reiterate the additional \$5.50 was NOT a tip for the driver.

It is pretty obvious to me this cab driver scammed me. After doing some checking and reading, I found the "credit card reader doesn't work" is a way to get the rider to pay cash. This driver never had any intention of making change. He simply wanted to make a few extra dollars. I am pretty upset this type of behavior is allowed to happen from licensed cab drivers in the City of Milwaukee.
