There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Dear Council President Pérez and City Officials,

I am writing with extreme urgency regarding the escalating safety crisis at the intersection of 25th St and W Lincoln Ave, caused by the supermarket at 2512 W Forest Home Ave.

Our _____ has served the Hispanic community for over 40 years. We specialize in rehabilitating **grievously injured workers and auto accident patients**, many of whom are post-surgical and highly vulnerable. For these patients, physical safety and ease of access are medical necessities.

We are reporting the following critical violations:

1. **Blockage of Medical Access:** Freight trucks consistently park in the middle of 25th Street, completely blocking our patient entrances and designated post-surgery parking.
- 2.
3. **Safety & Crashes:** The congestion is so severe that we have witnessed vehicle crashes. The neighborhood's narrow streets, already constrained by residential parking, cannot accommodate these large trucks.
- 4.
5. **Hostility and Verbal Abuse:** When our staff or vulnerable patients attempt to enter or exit, truck operators respond with verbal abuse and refusal to move. This is creating a traumatizing environment for patients already seeking refuge after traumatic injuries.
- 6.
7. **Failure to Follow Site Plan:** We are certain the approved site plan required deliveries via the former Walgreens drive-through. This area is currently used for employee parking, forcing freight trucks onto the public road.
- 8.
9. **Community Disruption:** Constant hooting, traffic hold-ups during school bus hours, and persistent neighborhood conflict have become a daily occurrence.

We support local business, but the current operations are placing our patients and other drivers at risk. We request that **DNS enforce the site plan loading requirements** and that **DPW install "No Loading/No Parking" signs** at our clinic's specific entry and exit points to ensure our patients can safely receive the care they need.

I am attaching photos from this morning alone showing one freight truck completely blocking both our entrances on (25th street). Our patients were calling in because they were "wedged in" between multiple trucks and had an anxiety attack having just been in an accident. Another freight truck blocking 25th street while offloading with a forklift. Traffic became hostile having to turn around back into W Lincoln Ave. We hoped after the business settled in, they would utilize their approved site plan for deliveries but have failed to do so.

We can do better, we should do better...with your help.

The hearing before the Licenses Committee will take place on 6/9/2026 at 1:10 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
