We have received your claim in the amount of \$498.69, relating to damage allegedly sustained to your vehicle on April 27, 2013 when it collided with a pothole while you were traveling southbound on 100th Street just before Capitol Drive.

The Infrastructure Services Division records indicate that they did not have any maintenance projects along West Capitol Drive at North 100th Street on April 27, 2013. A reconstruction project along West Capitol Drive between North 84th Street and North Mayfair Road started on April 15, 2013. This is a State of Wisconsin paving project, State ID # 2025-11-71. 
