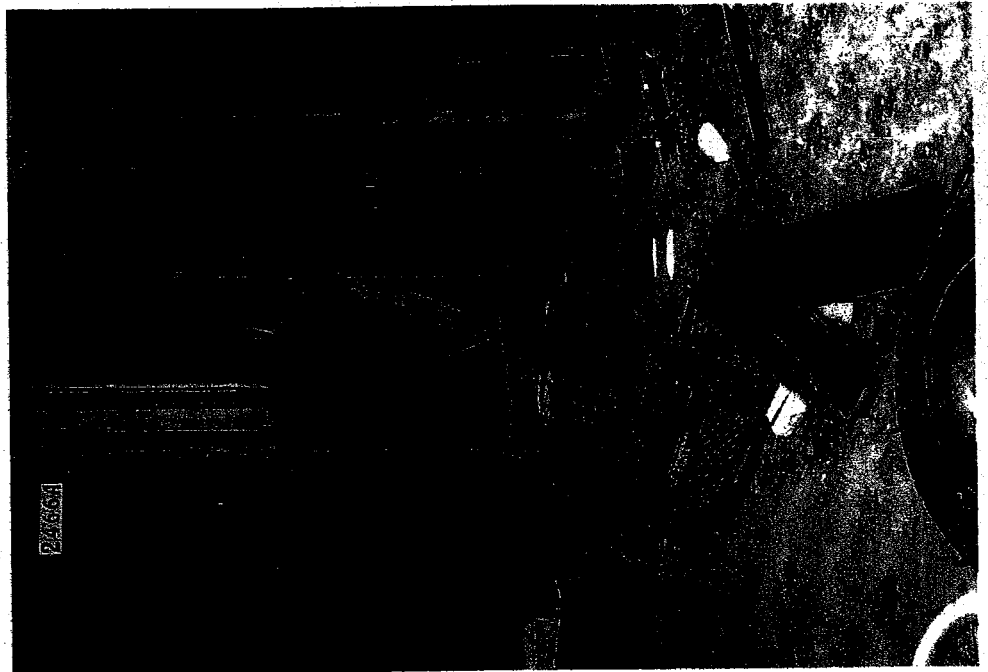

INVESTIGATIVE NARRATIVE:

THIS REPORT IS DICTATED BY DETECTIVE THOMAS GLASNOVICH, OF THE CRIMINAL INVESTIGATION BUREAU, ROBBERY UNIT, DAYS.

ON FRIDAY, 09-15-00, AT ABOUT 2:00PM, THE SUSPECT FIRED 2 GUNSHOTS AT THE VICTIM, USING A HIGH POWERED RIFLE, FROM 2461 N. 26TH ST. THE VICTIM WAS STANDING ON THE PORCH AT 2465 N. 26TH ST. FOLLOWING THIS OFFENSE, THE SUSPECT RETREATED BACK INTO HIS RESIDENCE WITH THE RIFLE. FOLLOWING EXHAUSTIVE ATTEMPTS TO HAVE THE SUSPECT VOLUNTARILY SURRENDER FROM THE RESIDENCE, FORCED ENTRY WAS MADE. MEMBERS OF THE TACTICAL ENFORCEMENT UNIT THEN LOCATED THE SUSPECT CONCEALED UNDER DEBRIS IN THE BASEMENT OF HIS RESIDENCE, AND HE WAS TAKEN INTO CUSTODY WITHOUT FURTHER INCIDENT OR INJURY.

AT 5:45PM, THE VICTIM WAS ALLOWED TO VIEW THE SUSPECT DURING AN ON-SCENE LINEUP, AND POSITIVELY IDENTIFIED THE SUSPECT WHO DID FIRE 2 GUNSHOTS IN HIS DIRECTION.
