Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this not

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.



3. On 02/07/2014 at 6:29pm Milwaukee police conducted a Licensed Premise check at 1500 West Mitchell Street (La Sirenita Bar). The applicant was cooperative with police and no violations were observed.

- 4. On 12/13/2014 at 11:55pm officers responded to La Sirenita Bar at 1500 W. Mitchell St regarding a loud music complaint. When they arrived the officers could hear music from inside but it was not excessively loud. The applicant was on scene and advised to turn it down slightly due to a complaint. No violations were observed.
- 5. On 12/20/2014 at 11:32pm officers responded to La Sirenita Bar at 1500 W. Mitchell St regarding a drug dealing complaint. The caller advised the police there was a subject inside the bar with cocaine. The caller pointed out the suspect. The police asked the suspect, who was identified as Elroy SANCHEZ-SANCHEZ, to step outside. When the officer conducted a pat down for weapons he felt an item in the pocket of SANCHEZ-SANCHEZ. When asked SANCHEZ-SANCHEZ stated it was cocaine. He was arrested and taken to District Two. While on the bench SANCHEZ-SANCHEZ was observed on camera hiding more cocaine he took from his sock. SANCHEZ-SANCHEZ was charged with POCS Cocaine w/ Intent to Deliver. He was convicted of the charge 04/22/2015.
- 6. On 02/02/2015 at 12:11am officers responded to La Sirenita Bar at 1500 W. Mitchell St for a Subject with Gun complaint. Upon arrival the officers were flagged down by a security guard who stated there had been a fight in the bar and the subjects were kicked out. One of the subjects was observed with a possible firearm. The guard stated he did not see the subject point it at anyone and all the subjects got into a red car, with unknown plates, which fled in an unknown direction. The officers conducted a tavern check and observed no violations. The applicant was on scene but had not called for police regarding a fight in the business.
- 7. On 02/03/2015 at 1:55pm officers responded to La Sirenita Bar at 1500 W. Mitchell St for a Battery complaint. The victim stated he was hit in the head with a beer bottle by an unknown subject. He refused medical attention and he refused to prosecute the suspect. The applicant was on scene but stated he did not witness the incident. The bartender, Silveria CRUZ-VERGARA, stated that the victim got into a short verbal altercation with the suspect at about 1:00am. At about 1:30am the suspect hit the victim to the head with a beer bottle. The suspect was escorted out by security. The applicant was issued a citation for Disorderly Premises.

8. On 03/29/2015 at 12:45am responded to La Sirenta Bar at 1500 W. Mitchell St for a Loud Music complaint. When officers arrived they could hear/feel the music from across the street. They contacted the caller who just wanted it turned down. The officers spoke with the applicant who was on scene. He had the DJ turn down the music and the bass. The applicant was not issued a citation.

9.	On 06/19/15, Milwaukee Police were dispatched to 1500 W Mitchell (La Sirenita) to investigate
	a Battery D.V. complaint. Upon arrival officers observed a female with blood running down her
	neck from her ear, where they observed a large portion of her ear missing. The victim stated
	the incident occurred inside the bar. She stated her husband became upset with her and had
	bitten her ear. The suspect was not on scene. The portion of the victims ear was located in the
	bar on the floor near a stool. The establishment was cooperative and a police report was filed.

10. On 05/25/2018 officers were dispatched to a shooting at La Sirenita Bar, 1500 W. National St. The victim was in the tavern with friends. He went outside and an unknown male approached him with a firearm. The victim was shot to the shoulder and back. Another victim was shot in the chest. Both victims were transported to the hospital. The applicant was on scene and stated he heard the shots and opened the front door and allowed one of the victims inside. He stated that he has security on the weekends but not during the week. He provided video surveillance of the incident to the officers. No violations were observed.

11. On 01/27/2020 at 12:25am officers were dispatched to La Sirenita Bar, 1500 W. Mitchell St, for a Battery complaint. The victim stated the owner hit him. The owner identified himself as Juan MARTINEZ-VILLEGAS, hit him. MARTINEZ-VILLEGAS denied hitting him, stating he escorted him out because he was arguing with another patron. The officers attempted to view the video but the interior cameras were not working. The victim stated he wanted to prosecute and the officer issued a citation. No record of the citation could be found in the Milwaukee Municipal Court database.

12. On 10/30/2020 at 11:52pm officers were dispatched to La Sirenita Bar, 1500 W. Mitchell St for a Battery complaint. The applicant was the caller and stated a patron requested to use the dance floor. The applicant advised him he could not dance and had to wear a mask. The patron threw a bottle at the applicant, causing minor cuts to his face. The applicant was not able to locate video of the incident.

- 13. On 06/13/21, Milwaukee Police were dispatched to St. Luke's Hospital for a battery/cutting complaint. Officers were told by the victim that he was stabbed inside the bathroom at 1500 W. Mitchell Street. Officers went to the tavern to investigate and found no blood inside the bathroom and the owner of the establishment stated he was not aware of any fights or altercations that occurred on the night in question.
- 14. On 12/11/21 at 2:34am, Milwaukee Police conducted a license premise check at 1500 W. Mitchell Street. The reason for the check was because there was an aldermanic compliant stating that the establishment was operating after tavern close. Officers entered the tavern and counted 28 patrons inside, consuming open intoxicates, and the employees were not telling them to leave until the police started to walk through the bar. The owner was on scene and was upset with the police presence and stated he would be speaking to the alderman about the tavern check. He was cooperative with the investigation and no other violations were observed.

- 15. On 02/05/23 at 2:25a.m., Milwaukee Police were dispatched to an Armed Robbery that occurred outside of 1500 W. Mitchell St. The victim stated they accidentally bumped into a patron inside the bar. Later as they were leaving the bar, the suspect confronted them, displayed a firearm, and demanded property. The agent was extremely cooperative and provided video surveillance of the incident.
- 16. On 02/13/23, officers responded to a Battery that occurred on 02/12/23 at 2:00a.m., at 1500 W. Mitchell St. Investigation revealed two subjects entered the bar and demanded money from the bartender. When the bartender refused, he was punched and struck in the head with a beer bottle. The bartender was cooperative and provided video surveillance which depicts the incident in its entirety.
- 17. On 10/09/23 at 12:55A.M., Milwaukee Police were dispatched to a Subject with Gun at 1500 W. Mitchell St. Officers were advised by the caller that earlier in the evening they had to escort a patron out, due to them being unruly. The caller/victim stated the suspect then walked toward them with their hand in their pocket. Fearing they had a gun, the caller/victim told the subject "don't take your gun out, because if you do, I will have to do my job". The subject then pulled their vehicle next to the caller/victim's and pointed at gun, at which time the caller/victim did the same. A friend of the subject then removed the firearm from the subject and they fled the scene.

On Sunday, February 5th, 2023, at 2:25 AM we were dispatched to the address of 2166 S 32nd St (which is located in the City and County of Milwaukee) for an Armed Robbery complaint. Upon our arrival to the listed address, we made contact with the caller/victim who identified herself as Nelysha Z ORTIZ CORREA (F/B 04-24-2000). ORTIZ CORREA stated she was at Sirenita Bar located at 1500 W Historic Mitchell St drinking with a friend. ORTIZ CORREA stated that during bar close time (approximately 2:00 AM) as she was exiting the bar, her friend (who she only knows as Brian) accidently bumped into a Hispanic male inside the bar. ORTIZ CORREA then stated as they were walking to Brian's vehicle, the Hispanic male confronted them about being bumped. ORTIZ CORREA stated that she began to apologize to the Hispanic male wearing the blue, black, and white jacket and he reached in his pocket as to retrieve a gun and demanded all of ORTIZ CORREA's property. ORTIZ CORREA stated a second suspect was with suspect 1 standing next to him. ORTIZ CORREA stated that the incident took place on the sidewalk near a dead end outside of the bar and that she never observed a firearm. The suspects then fled after retrieving ORTIZ CORREA'S property.

Through the course of our investigation, we made remained in contact with the owner of La Sirenita, identified as Juan F MARTINEZ VILLEGAS (M/W 04-02-1977) who was extremely cooperative and provided video surveillance of the incident that occurred outside of the bar. MARTINEZ VILLEGA took it upon himself to locate the video and provide it to investigating officers. Because of this, officers were able to get a suspect description that differed from what the victim had remembered, and the video was inventoried as evidence.

LICENSED PREMISE REPORT

Rodriguez Jr, Jesus 029217

This report is written by Police Officer (P.O.) Jesus Rodriguez (PS# 029217), assigned to District Two, Late Shift.

On Monday, February 13th, 2023, Pollimmy MORALES-GOLON (PS#027070) and I responded to the La Sirenita Bar, which is located at the address of 1500 W. Mitchell St. (City and County of Milwaukee) for a Battery complaint, which was later determined to be an attempted Strong Armed Robbery.

Interview of caller - Juan Omar MONTES-MARTINEZ

The caller Juan Omar MONTES-MARTINEZ (H/M, 12-24-97) who had a visible injury on his left eye resulting in a swollen "Black-Eye" informed me of the following.

On Sunday, February 12th, 2023, at approximately 2:00AM he was assaulted by two subjects who attempted to rob the bar. MONTES-MARTINEZ stated that he was working that morning as the bar tender as normal when two subject approached the counter and in Spanish told him to give them the money in the register, MONTES-MARTINEZ stated that he told them no and then one of the subjects punched him on the face and then threw a beer bottle at his head. MONTES-MARTINEZ also informed of another bartender, Armando ORTEGA-GONZALEZ (H/M, 05-26-76) who was working with him that morning was struck by the subjects as he tried to stop them.

MONTES-MARTINEZ said that the two subjects ran towards the front door where a security guard attempted to stop them but was unable as they pushed and punched him until all three men stumbled outside where the two subjects ran south on S. 15th St. from W. Mitchell St. where a light colored possibly Silver colored Honda Pilot was waiting. The subjects were seen entering on the passenger sides and the vehicle fled southbound on S. 15th St.

MONTES-MARTINEZ provided the following description of the subjects as the following.

Subject #1 - H/M, in his 20's, wearing a Red Cincinnati baseball hat, black jacket/coat and white jeans with white shoes.

Subject #2 - H/M, in his 20's, with curly blond/orange hair, black coat/jacket, Blue jeans and White Shoes.

MONTES-MARTINEZ did not have any additional information regarding the incident.

I spoke with Armando ORTEGA-GONZALEZ (H/M, 05-26-76) who stated that he does not remember which of the subjects struck him, but he believed that he was struck with a beer bottle on the back of the

While on scene I also spoke with witnesses Juan Francisco MARTINEZ-VILLEGAS (H/M, 04-02-77) and Blanca Estrella ASCATL-NAVA (H/F, 05-14-03) who informed me they were working that morning and witnessed the incident.

MARTINEZ-VILLEGAS informed me that he had access to the video cameras and was able to provide officers a view of the recordings.

Video Synopsis

Cameras #1 and #3 captured the incident from outside, and an unknown camera in the interior captured the incident inside.

Camera number #3 which is positioned on the outside of the business and has the ability of capturing motion and following recorded the following.

On date stamp 02/12/23 at 12:47:25 AM a Silver Honda Pilot is seen traveling Westbound on W. Mitchell St. and then turn South on S. 15th St. where it parks on the West side of the street. Subject #1 and #2 are seen exiting the vehicle and then cross the street.

Camera #1 then captures the two subjects enter the bar where they stay inside for approximately 1(one) hour.

Interior camera captured at approximately 2:04:35 AM the Two subjects walking in the crowd and approach the bar where they come in contact with MONTES-MARTINEZ, the video then shows Subject #1 lean towards MONTES-MARTINEZ and words are exchanged. Subject #1 then punches MONTES-MARTINEZ and strikes him with a beer bottle on the head. Both subjects then run to the front door where they push and punch the security guard.

On October 9, 2023, at 12:55am, we were dispatched to a subject with gun call at 1500 W. Mitchell St. which is located in the City and County of Milwaukee.

Upon arrival PO ESPINOSA spoke to the victim who identified himself as Martin J. RAMOS-MARTINEZ (W/M 06-06-2000) who stated that at approximately 12:20 AM he had to escort a male subject out of the bar due to the male subject arguing and threatening the customers inside.

RAMOS-MARTINEZ stated that as the subject was escorted, he walked to his vehicle which was parked on the south side of south 15th street. RAMOS-MARTINEZ stated that the subject walked back with his hand in his pocket, RAMOS-MARTINEZ stated that at this point he did not know what was in his pocket but told the subject "Don't take your gun out because if you do, I'll have to do my job".

RAMOS-MARTINEZ stated that as he told the subject that he turned around and walked back to his vehicle. RAMOS-MARTINEZ stated that the male subject then moved his vehicle and parked it next to his vehicle which was parked directly in front of the bar. RAMOS-MARTINEZ stated that is when the subject exited his vehicle and pointed a handgun at him and stated, "we kill". RAMOS-MARTINEZ was unable to describe the handgun the subject had. RAMOS-MARTINEZ stated he then drew his firearm and pointed it at the subject. RAMOS-MARTINEZ stated that the subject's friend exited the bar and took the firearm away from the friend and told RAMOS-MARTINEZ that subject no longer had the firearm. RAMOS-MARTINEZ stated that the subject and the unknown friend got into the car and drove westbound on west Mitchell St.


