There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/12/2022 officers, along with an agent from the Wisconsin Department of Revenue conducted a license premise check at 4402 N. 27th St., regarding gambling machines that were at the location. The agent issued the clerk a warning letter advising him he had ten days to remove the machines. The clerk was cooperative and no other violations were observed.

2. On 05/20/23 at 11:07a.m., Milwaukee Police were dispatched to a Property Damage at 4402 N. 27th St. Investigation revealed an unknown subject caused damage to exterior surveillance cameras by shooting them with a firearm. The business was cooperative with the investigation.

3. On 07/31/23 at 6:47p.m., Milwaukee Police were dispatched to a Fight at 4402 N. 27th St. Officers were met by the caller who stated they were approached by two subjects on the street, who began to assault the victim. The victim ran into the store and the subjects followed and continued the assault. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

4. On 08/25/24 at 12:39p.m, Milwaukee Police conducted a License Premise Check at 4402 N. 27th St., as follow up for citizen complaints of loitering. The officer did observe several people that appeared to be loitering around the business. The officer made contact with the employee who stated they were aware of people loitering, doing drugs, urinating and prostituting on the North side of the building. The employee stated they did post No Loitering signs on the side of the building; however, subjects keep taking them down. The employee requested police to assist with this issue as they fear for their safety if they should confront them alone. The employee was advised to post a sign higher up to avoid subjects having the ability to take it down.

5. On 09/11/24 at 5:12p.m., Milwaukee Police were dispatched to a Theft at 4402 N. 27th St. Investigation revealed as delivery companies are making their delivery to the business, suspects are stealing items from the delivery trucks. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report was written by P.O. Terry BELL assigned to District Five Early Power shift, Squad 5290.

On Monday, July 31, 2023, at 6:47 PM I was dispatched to 4402 N 27th Street for a Fight.

Upon our arrival, I observed a female subject, Tondra C MCKINNEY (F/B, 07-17-71) with injuries exiting the Gary Food Mart.

MCKINNEY was the caller who called from the store phone (414-873-5525). MCKINNEY stated that while walking on N 27th Street, she was approached by two unknown female subjects who accused her of breaking into their apartment unit. MCKINNEY stated that the two subjects then began to assault her. MCKINNEY stated that she then sought refuge inside the business where the two subjects followed and continued their assault. MCKINNEY stated that she fled the business and called for police.

I spoke to a witness, Nirmal SINGH (M/A, 05-24-61), an employee at Gary Food Mart who stated that he witnessed two subjects enter the business and begin to assault MCKINNEY. SINGH stated that there were store surveillance cameras which captured the incident. SINGH granted us access to the surveillance recording. P.O. MIKULSKY entered the office and reviewed the recording.

I observed the licensing certifications to document the business agent, Gurpreet SINGH. The certifications were all up to date. Nirmal SINGH was cooperative with assisting with our investigation of the incident.

This report is written by PO David LETTEER, assigned to District 5, Day Shift, Sq. 5166.

On August 17th, while at a community meeting, I was informed that citizens were concerned about the area of N. 27th St., and W. Port Sunlight Way. I was informed that there was a liquor store and that there were people hanging outside of the liquor store, sitting out there all day, prostitution related activities, as well as drug related activities. The people who were hanging outside, were on the northside of the liquor store, as well as the front of the liquor store.

After the meeting, I did go to the area and observed that W. Port Sunlight Way had many parked cars, with people with sitting in the vehicles or just outside of the vehicles. I did observe people sitting or standing on the sidewalk on the northside of the liquor store, as well as people standing and sitting in front of the liquor store.

I did observe the people outside and I observed a male bringing out a popcorn from the store, to one of the individuals sitting outside, in a lawn chair. Eventually most of the people left and I proceeded to enter the liquor store. I did not observe any no loitering signs or cameras on the northside of the building. I did observe a paper no loitering sign taped to the front window of the business. I entered the store and met with Nirmal Singh, an employee, who did allow me to check on the store licenses.

I spoke to SINGH and explained why I was here and what I was told in my meeting. He stated the people are always sitting and hanging out on the northside of the building at all hours of the day and night. He stated there are people who are doing drugs, urinating, prostituting and also selling illegal items on W. Port Sunlight Way.

SINGH stated the business had put up a no loitering sign on the northside of the building, but the people who are always outside, keep removing the signs. He stated he is only one person and that for safety reasons is not going outside to confront many people.

SINGH asked if the police could help with the business. I informed SINGH to call the police when people are outside loitering. He was advised to put up a no loitering sign and post it as high as he could, so that the people who are outside can not easily reach it and take it down.

SINGH was cooperative and wants to work with the police. SINGH stated he would get another sign and post it on the outside north wall of the building.

Several people left, but one person remained and argued with me about having a right to sit on the city sidewalk all day long in his retirement. As I was speaking to this individual, another male walked up and tried to talk to him as well, telling him that the officer was trying to help and that he was the one who keeps taking down the no loitering signs from the building.

This report is written by Police Officer Joshua TRYAN-HERNANDEZ, assigned to District 5, Early Power Shift, Squad 5222. I was operating a marked black and white MPD squad car, vehicle 261, equipped with the MDVR system which was activated during this incident. I was in full MPD uniform equipped with my issued body camera, which was activated during this incident.

On Wednesday, September 11, 2024, at approximately 5:12 PM, my partner P.O. Shelley WEISSENBORN (passenger) and I (driver) were dispatched to a Theft at Gary Food Mart, 4402 N. 27th St, located in the City and County of Milwaukee.

Upon arrival, Gary Food Mart employee/caller identified as Nirmal SINGH (w/m, 05/24/1961) reported deliveries dropping off product keep getting stolen before being delivered inside the store. SINGH report this has occurred approximately two other times prior, and one incident occurred today, Wednesday, September 11, 2024, at approximately 2:00 PM. SINGH reported the delivery companies stolen from included Beechwood, Pepsi, and Frito-Lay. SINGH reported not witnessing any of the incidents but was told by the persons delivering product after each incident. SINGH reported the companies did threaten to not deliver product anymore if nothing is done to curb product being stolen. SINGH reported known product stolen from Beechwood included two boxes (unknown contents), Pepsi (six cases of soda), and did not provide what was stolen from Frito-Lay. SINGH did report this to be occurring at different times as the deliveries are not always the same. SINGH reported the alleged actor(s) are known to hang out on the one way of W. Port Sunlight Way between N. 26th St and N. 27th St. SINGH reported he knows U-Hauls to be involved which sell the stolen product. SINGH reported only one exterior camera showing the main entrance outside the business and the rest of the cameras are interior. SINGH reported two subjects he knows to be involved but did not witness them committing the act.

SINGH did show video which depicted two subjects, whom he reported to be involved inside the store (a lighter skinned black male, approximately 50s year of age wearing a white V-neck t-shirt with black pants along with a black male wearing a black shirt with dark sunglasses). SINGH did report that U-Haul trucks being parked on W. Port Sunlight Way are also involved, and he knows them to be selling stolen merchandise out of them.

No representatives from Beechwood, Pepsi, or Frito-Lay were on scene and there had been no reports from them as such. SINGH was informed they would need to contact police as the product is being stolen prior to be being delivered to his store. SINGH was provided an Evidence.com link to upload video footage of the actors inside the store but no exterior cameras are present on W. Port Sunlight Way.

While on scene, P.O. WEISSENBORN did observe all the licenses posted in the back office which were up

to date and not expired.

During the investigation, I did make contact with store owner identified as Gupreet SINGH (w/m, 02/04/1998). Gupreet advised he was unaware his employee had contacted police. Store owner and Employee were cooperative with the police investigation.

Per the district community partnership unit this location is a designated nuisance premise. *The business is in billing status OR The business submitted an abatement plan which states the business will complete the following items... to eliminate nuisance activity.*

Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
