Dear Ms. Marshall:

We have received your claim in the amount of \$741.30, relating to damage to your vehicle on when you allegedly struck a chunk of ice and show that was in the driving lane at 875 West Layton Avenue on February 14, 2007.

Our investigation reveals that the snow plow truck that was assigned to plow this route followed standard plowing procedures to clear the snow from the roadway. It was noted that a shopping area is located here and the plowing company that plowed for this facility may have pushed snow into the roadway. Since there is no evidence that the City was negligent in this matter, it cannot accept liability and we are denying your claim

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
