## **Property**

1701 N. LINCOLN MEMORIAL DR. Milwaukee Flushing Tunnel Pumping Station **Description of work** The Milwaukee River Flushing Tunnel Station has been occupied by Colectivo Coffee (originally Alterra) since 2001. HPC gave approval for the outdoor seating area in 2001.

> The current proposal is to enlarge the outdoor seating area and add an outdoor coffee bar at the northwest corner of the building and construct an outdoor fireplace.

The seating area will be expanded out to the public sidewalk and will be bordered with a low brick wall on which will be installed light fixtures. This will result in an additional 13 tables and 10 individual Adirondack chairs placed on the grounds. At the north end of the new seating area an outdoor fireplace will be constructed. A new concrete path will be poured behind the fireplace zone.

New or additional landscaping will be added to the grounds consisting of ornamental grasses, annuals, perennials and shrubs according to the plan submitted.

Paving will consist of permeable pavers in the original seating area along Lincoln Memorial Drive, concrete at the pergola seating and new crushed gravel or pea gravel in the extended seating area.

The new gas fireplace (13-feet 6-inches tall) will be built of concrete with benches to either side. The benches will be made of reclaimed cream brick with limestone seats. From these

seats will extend concrete masonry unit walls faced with brick having limestone caps, approximately 1-foot 10-inches tall.

The outdoor coffee bar will be located at the northwest corner of the building and be clad in reclaimed wood and framed steel lattice. The structure will be self-supporting and not attached to the building. It will have a canvas roof. It will not be used in winter but will remain a permanent feature on the grounds.

The entry canopy is being redesigned and a future COA will be issued to approve that element. No construction on the entry canopy can begin without approval of its design.






