There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Officer Carlos Felix, assigned to the License Investigation Unit, Day Shift. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/04/2024, at 3:27 PM., Officers responded to 540 N. 27th St., Buffalo Boss, for a Shooting. The victim sustained a gunshot to the left flank while driving and was able bring their vehicle to a stop in the Buffalo Boss parking lot, where officers made contact with them. An officer spoke to a cashier at the business whom refused to identify herself. The officer made a requested to review the parking lot surveillance camera footage, but the cahier stated the owner only had access to the system. There was no manager on scene, and the cashier would not provide the owner's contact information to the officer. A short while later during the investigation a detective made contact with a male employee at the business and requested access to surveillance footage. That male stated the cameras were not working, and the detective pointed out the security monitor. The male replied he would not allow police to review it. The importance of reviewing security footage due to the victim's vehicle being parked directly in sight was explained, but both employees were uncooperative with officers. An officer made contact with the owner who stated he would check security footage and notify officers if he observed anything related to the incident.

LICENSED PREMISE REPORT

This report is written by P.O. Antonio OBREGON, assigned to District Three Early Power shift, Squad 3233.

On 07-04-2024 at approximately 3:27 p.m. P.O. Ryan SHARP and I were dispatched to a Shooting complaint at the location of 540 N. 27th Street.

Upon *my/our arrival* I observed a white SUV in the parking lot of the aforementioned location, also known as the fast-food restaurant, Buffalo Boss. The vehicle was parked in the Southeast corner of the lot and there was a black male standing outside of the vehicle, later identified as Cameron L. SANDIFER (b/m 12-31-1994). The male was shot to his left flank and the vehicle also had bullet holes in it. There was also a small child in the vehicle as well as another male. Due to having a large scene this required the response of 6 District Three Squads to block traffic, hold on evidence and maintain crow control.

The caller to 911 was the victim in this incident. The only information provided to 911 prior to our arrival was that he had been shot and he was at the location of N. 27th Street and W. Michigan Street.

See Detective's supplemental reports regarding the interviews of witnesses and other people involved.

I spoke to licensed premise employee who was a cashier. She was a middle-aged heavy set black female that did not wish to provide her information and did not witness the incident. It was determined that the incident did not happen in the parking lot of the business, however the victim did drive his vehicle into the moments after the shooting occurred only a block away. Due to observing cameras on the outside of the building I asked if I was able to review video and I was informed by the cashier that the only person who could watch it was the owner. She did not want to provide me his number but did say his name was Taj Pearsall.

An MPD records check of this name and address allowed me to ID the owner as Taj M. PEARSALL(b/m 04-21-1975). I then asked if I could speak with a manager in hopes they might have the owner's number, but I was told there was not a manager working. I then ended my contact with the cashier. Later during the investigation Det. MALAFA went back inside the business and spoke with a different employee who was uncooperative. The employee was described as a medium build black male wearing a cowboy hat and black t shirt.

Det. MALAFA asked the subject if there was video at the business while looking at the tv monitors for the video and he was told they did not. After confronted about the monitors the Detective was then told

they did have working cameras, but he was not going to allow police to review it. The Detective explained how important it was to the employee that he review footage, but he was still informed he was not going to cooperate with the investigation and did not feel like he had to. The Detective was also provided the owners information but has not been able to reach him.

If video is not able to be reviewed a search warrant will be drafted to obtain evidence from video surveillance. These cameras in the lot are point directly where the vehicle was located and entered.

It should be noted that I did make contact with the owner of the store via phone. He was very cooperative and stated he would be checking his video and would notify us if anything was observed related to our investigation.

The hearing before the Licenses Committee will take place on 2/19/2025 at 10:40 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
