This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 07/03/23 at 11:09a.m., Milwaukee Police were dispatched to a Shooting at 2045 E. North Ave. Investigation revealed a fight broke out between two subjects and a large group was gathered outside. A firearm was produced and a victim was shot, resulting in homicide. The business was cooperative and provided video surveillance to officers.
- 2. On 07/29/24 at 2:06a.m., Milwaukee Police were dispatched to a Shooting at 2045 E. North Ave. Investigation revealed a subject was leaving the location after ordering food, when another subject approached and a physical fight ensued. The fight eventually broke up and one subject fled the scene, while the other entered a parked vehicle. A suspect began to fire rounds toward the vehicle, striking a different vehicle in the lot, causing injury to the occupant due to glass breaking. As of this report two additional requests were made to the business to upload video surveillance to Evidence.com, however, they have not complied.
- 3. On 08/31/24 at 3:40a.m., Milwaukee Police were dispatched to a Battery at 2035 E. North Ave. Investigation revealed two subjects arguing outside the business, when one subject punched the other subject. A third subject got involved and punched the first subject, causing them to fall to the ground and lose consciousness. The business was cooperative and allowed officers to view video surveillance of the incident.

Upon arrival at 2045 E North Ave, I located manager Ahmed MOHAMED (w-m 6-28-84) who stated that he was at the location when a fight broke out inside of the restaurant between two unknown females, MOHAMED stated that he did not see anyone with a firearm, but that there were a lot of people.

MOHAMED indicated that he provided surveillance to the officers the night of the incident and was compliant with officers. Video was available on scene which revealed a large crowned in front of the location with a single gunshot fired from a firearm.

I asked MOHAMED if license holder Nabil MUTLAQ at the location during the time he indicated no, he was still on vacation.

This report is written by PO Mujeeb KHAN, District 1, Squad 1330, Late shift with Squads 1340 PO KONZ, 1341 FARRAND, 1390 HUGHES, and 1312 Sgt. PAGACZ.

On Monday July 29, 2024, at approximately 2:06 AM I responded to 2045 E North Avenue, MAD CHICKEN restaurant regarding a shooting which is located in the City and County of Milwaukee.

Upon arrival I was met with Oscar T MILES (M/B, 02/22/2001) who stated that he ended making delivers for Door Dash at 1:03AM, his last location for delivery was in Shorewood. MILES came back to pick up food for himself. MILES stated, upon arrival to 2045 E North Avenue he did not even make it out of his vehicle, a Gray 2022 Toyota Camery SE bearing Florida license plates LDH-N63, VIN4T1G11AK0NU665509 when he heard sounds like "firecrackers". MILES stated he ducked and leaned right while in a seated position. MILES remained in the position described until the "firecrackers" sounds stop. Upon rising MILES noticed that his car was shot. The victim only suffered injuries from the glass and was not shot during the incident.

During the canvas of the area, I interviewed multiple witnesses.

Witness 1: Ramy M. AMER (M/W, 01/04/1983) who was working in the front of the store taking customer orders stated that suspect 1 (B/F, 20-25 y.o. wearing dark leggings, bright color T-Shirt, light built with short stature and wearing a gold and white Wig up with shoulder length hair) had just purchased her meal and was leaving the second set of main entrance doors when another female (Suspect 2), B/F, wearing a tank top and a white/gray hoodie, with multi-color makeup on her face with white and gold wig which measured up to shoulder length and appeared taller than Suspect 1 but with a light built, met her at the exit doors. AMER stated, the argument led to a physical altercation in front of the store and shifted its direction east in front of the store. The physical altercation which left the light pole disabled and damaged by ripping it out of the base and it fell over. AMER stated, the fight lasted approximately a minute and a half. AMER stated, once the fight was done Suspect 1 was on the ground and unable to move while Suspect 2 left walking Westbound on E North Ave on the same side of the road as the incident. Suspect 1 was assisted into a vehicle driven by suspect 3, a B/M approximately 17-23 y.o. wearing a light color heavy sweatshirt, dark color jeans, dark color shoes and with a medium height, light built, and short black hair.

According to RAMY suspect 1 had someone waiting for them parked in front of the main entrance, suspect 3. Suspect 3 assisted suspect 1 off the ground and into his dark color car. RAMY stated, as soon as both suspects sat in the car two shots were fired. RAMY stated, suspect 1 got out of the dark color car and ran on foot southbound on N Prospect Avenue, suspect 3 got out of his vehicle and hid in front of the car by ducking in front of the car. According to RAMY another 3-4 shots were fired in the direction of suspect 3's car. RAMY stated, suspect 3 then ran back into his vehicle once he noticed the shooting has stopped and drove his vehicle southbound on N Prospect Avenue.

Witness 2: Edward F. JOHNSON (M/B, 4/9/1971) who stated that he heard 5-6 shots and left the scene.

Witness 3: Gary KORTSCH (M/W, 12/13/1972) who stated that he was standing near Ivanhoe and North Ave facing westbound near the pillars when he noticed one individual, suspect 4, on foot walking with a gun and according to KORTSCH suspect 4 fired 8 shots in KORTSCH direction. According to KORTSCH he hid behind the pillars until shots stopped being fired.

Other miscellaneous individuals inside 2045 E North Ave working who did not witness anything or heard anything are as follows:

Individual 1: Islam M. HARES (M/W, 9/29/1978) who is cook, did not witness anything or heard any shots.

Individual 2: Ramy M. AMER (M/W, 01/04/1983) who is cook, did not witness anything or heard any shots.

Individual 3: Jose Luis CAPELLAN RIVERA (M/B, 05/1/1985) who is cook, did not witness anything or heard any shots.

Individual 4: Mohmmed A. AHMED (M/B, 1/1/1997) who is also a cook, who is cook, did not witness anything or heard any shots. AHMED was uncooperative with this investigation and did not initially want to speak with officers or show any surveillance videos.

Individual 5: Mudathir A. HAROON (M/B, 3/18/1991) who is cook, did not witness anything or heard any shots.

From the time of the initial request two additional requests were made to have Mad Chicken upload video to Evidence.Com but it was not received. Officers did determine the suspects exited Mad Chicken were involved in a confrontation and several shots were fired.

On August 31st, 2024, at 3:40am, I was dispatched to 2045 E North Av for a Battery complaint which is located in the City and County of Milwaukee in the State of Wisconsin.

Upon arrival I observed the victim Jade STOJOVIC (W/F, 07/20/2005) who stated that she had gotten into a verbal disagreement outside of the above listed address with an unknown female who was described as a W/F, blonde hair, last seen wearing a pink shirt, light blue jeans and white shoes. STOJOVIC stated that the W/F then punched her and began battering her outside of the restaurant, STOJOVIC stated that she eventually lost consciousness from being punched in the face but is unsure which individual had punched her. Witnesses on scene stated that they witnessed a B/M with the female suspect punch STOJOVIC during the incident. The male suspect was described as a B/M, slim build, dreadlocks, last seen wearing a black hat, gray t-shirt, blue jogging pants and white shoes. Suspects intentionally and without consent battered the victim causing pain and causing her to lose consciousness. STOJOVIC stated she does not remember how many times the suspects had punched her during this incident.

I spoke to a witness Talia A. ROGERS (B/F, 05/19/2004) who stated that she witnessed the interaction between STOJOVIC and the suspects. ROGERS stated that STOJOVIC and the female suspect were having a petty argument over someone being disrespectful, and she observed the female suspect punch STOJOVIC in the face. ROGERS stated that she then attempted to separate the two subjects and as she tried to break up the fight, a B/M that was with the female suspect then tried blocking her away from breaking up the fight. STOJOVIC stated she then observed the male suspect punch STOJOVIC causing STOJOVIC to fall. ROGERS stated she then ran to attend to STOJOVIC and observed STOJOVIC unconscious for a full minute.

I did not speak to the license premise owner.

I reviewed video surveillance footage. The footage showed the victim and the suspects in this incident fighting in front of Mad Chicken.

Per the district community partnership unit this location is not a designated nuisance premise.

Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
