

Subject: Anti-Graffiti Policy Committee

Attached for your information is the summary of vandalism and graffiti-related ordinance violations that includes information through August 31, 2009. In addition to the standard report, I have provided more a detailed listing of cases for vandalism-graffiti related offenses and for cases relating to sale and possession of spray paint/wide tip markers. You will note that several of the juvenile cases have a guilty verdict but have no monetary judgment noted. This is because the juvenile was found guilty by default (they did not appear in court) and a juvenile warrant was issued for their arrest. A monetary judgment will be applied when they appear before the judge.
