This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

Santora stated as he was attempting to escort out a patron due to his alcohol intoxication level, the patron swung at him but missed and fell to the ground hitting his face on the floor. Medical was called for the patron as well as police. Officers also interviewed the patron who gave the same statement of events. A citation for Disorderly Conduct was issued to the patron.
 - 2. On 10/09/2011 at 2:02am, Milwaukee police were dispatched to 724 E. Layton (Amelia's Tavern) for a fight. Investigation revealed a fight had taken place inside the business. The actors were escorted off the property and were no longer present when police arrived. The investigating officer noticed the licensed posted inside the business had expired 09/19/2011. The bartender stated the owner just stepped out and would return shortly. The officers waited and spoke with the applicant, who stated he thought the bartender had a license. This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MVDR ability.

On Tuesday, October 8, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. Joel BUNKELMAN. During our course of duty we conducted a Tavern check at Amelia's which is located at 724 E. Layton Av. in the City of Milwaukee.

We entered the establishment through the front that opens to E. Layton Av. to the sound of karaoke and music being played. Within the bar we also observed several of the occupants to be drinking several different forms of intoxicating liquors (mixed drinks, beers and etc.). We were first greeting by the door man then directed to the on duty bartender.

The bartender was identified as Shannon M. WENDORF (F/W 03-04-81) and was asked to produce her bartender's license and photo id. WENDORF went behind the bar to retrieve the asked item but only returned with her Wisconsin photo ID card. WENDORF stated that she did not have her bartenders license on her but stated she has one. Then she stated that she turned in the application but just hasn't received her paperwork yet. Her information was collected and P.O. BUNKELMAN and I returned to our squad car to investigate further. I checked LIRA (License Information Reporting and Administration System) for any license information on WENDORF and had no results discovered. The negative results meant that WENDORF did not have any bar related license issued nor applied for. We returned to the establishment and informed WENDORF of our results which she then stated she thought she applied for the license and has one in the city of South Milwaukee and Cudahy. WENDORF was told that a license for this city is needed to serve at this establishment and without a license person on duty no more alcohol or intoxicating beverages can be served. WENDORF stated that she was sorry and that she was originally working with the owner Albert G. DOSTAL (M/W 09-04-61) but he had to go and drop someone off in the city of Cudahy. She also stated that he will be on his way back shortly so he can take over. WENDORF could not confirm if DOSTAL was on his way back to the

establishment and was asked to connect him so we could talk.

WENDORF allowed me to speak with DOSTAL on her cell phone in which he told me he will be at the bar in 3 minutes. P.O. BUNKELMAN and I waited and spoke with DOSTAL outside the establishment. DOSTAL stated that he believed WENDORF had her bartender's license and this was the first time he was informed that she did have it. He also stated that he has been going in and out of the establishment all day trying to get different things taken care of. I then informed that because WENDORF was left in charge of the bar that citations would be issued regarding. DOSTAL stated that he understood and that he will make sure she gets the proper license if she wants to work there.

It should be noted that **DOSTAL** did work well with Milwaukee Police officers and understood the violation. **DOSTAL** requested that the citation he will be issued be mailed to the establishment address.

DOSTAL was issued 1 citation for Responsible person upon License premise - M580VFSSGL.

WENDORF was issued 1 citation for Class D Bartenders License Required -



Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

This report is being written by P.O. Christopher JACKSON assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MVDR ability.

On Tuesday, October 8, 2019 I was assigned to the License Premise Unit, Squad 6468 along with P.O. Joel BUNKELMAN. During our course of duty we conducted a Tavern check at Amelia's which is located at 724 E. Layton Av. in the City of Milwaukee.

We entered the establishment through the front that opens to E. Layton Av. to the sound of karaoke and music being played. Within the bar we also observed several of the occupants to be drinking several different forms of intoxicating liquors (mixed drinks, beers and etc.). We were first greeting by the door man then directed to the on duty bartender.

The bartender was identified as Shannon M. WENDORF (F/W 03-04-81) and was asked to produce her bartender's license and photo id. WENDORF went behind the bar to retrieve the asked item but only returned with her Wisconsin photo ID card. WENDORF stated that she did not have her bartenders license on her but stated she has one. Then she stated that she turned in the application but just hasn't received her paperwork yet. Her information was collected and P.O. BUNKELMAN and I returned to our squad car to investigate further. I checked LIRA (License Information Reporting and Administration System) for any license information on WENDORF and had no results discovered. The negative results meant that WENDORF did not have any bar related license issued nor applied for. We returned to the establishment and informed WENDORF of our results which she then stated she thought she applied for the license and has one in the city of South Milwaukee and Cudahy. WENDORF was told that a license for this city is needed to serve at this establishment and without a license person on duty no more alcohol or intoxicating beverages can be served. WENDORF stated that she was sorry and that she was originally working with the owner Albert G. DOSTAL (M/W 09-04-61) but he had to go and drop someone off in the city of Cudahy. She also stated that he will be on his way back shortly so he can take over. WENDORF could not confirm if DOSTAL was on his way back to the

establishment and was asked to connect him so we could talk.

WENDORF allowed me to speak with DOSTAL on her cell phone in which he told me he will be at the bar in 3 minutes. P.O. BUNKELMAN and I waited and spoke with DOSTAL outside the establishment. DOSTAL stated that he believed WENDORF had her bartender's license and this was the first time he was informed that she did have it. He also stated that he has been going in and out of the establishment all day trying to get different things taken care of. I then informed that because WENDORF was left in charge of the bar that citations would be issued regarding. DOSTAL stated that he understood and that he will make sure she gets the proper license if she wants to work there.

It should be noted that **DOSTAL** did work well with Milwaukee Police officers and understood the violation. **DOSTAL** requested that the citation he will be issued be mailed to the establishment address.
