**COST SHARING AGREEMENT
BETWEEN**

THE CITY OF WAUWATOSA AND THE CITY OF MILWAUKEE


1. The City of Milwaukee will pay to the City of Wauwatosa a share of the preliminary engineering. Each community's share is calculated as the ratio of the roadway area (curb face to curb face) within each community over the total roadway area (curb face to curb face). Due to the change in road width and alignment, this share will be calculated following preliminary design.
2. The final preliminary engineering costs for each municipality will be calculated by prorating the actual preliminary engineering expenditures using the final construction costs within each municipality as the percentage of proration. If the City of Milwaukee's actual share is less than the paid amount, the difference will be refunded to the City of Milwaukee; if the City of Milwaukee's share is greater than the amount paid, the City of Milwaukee will make additional payment to cover the balance of their share.
3. Each municipality will pay for roadway construction costs within its municipal boundaries. The City of Milwaukee will deposit with the City of Wauwatosa their estimated share for construction and construction engineering after the successful bid has been accepted.
4. The final roadway construction costs for each municipality will be determined based on actual measured quantities within each respective municipality and the prorating of the lump sum items.
5. The City of Wauwatosa agrees to consult with and seek approval from the City of Milwaukee during the project design process and plan preparation for the improvement.
6. Construction engineering costs will be prorated between each municipality using final construction costs in each municipality as the percentage of proration.
7. If the City of Milwaukee's actual share for roadway construction and construction engineering is less than the deposited amount, the difference will be refunded to the City of Milwaukee, or if the City of Milwaukee's share is greater than the amount deposited, the City of Milwaukee will deposit additional funds to cover the balance of their share.

8. The cost sharing and maintenance of roadway related drainage items (mainline sewers, laterals, and other appurtenances) will be subject to a separate agreement to be determined and entered into upon a mutually agreeable design, as necessary.
9. The cost of sharing and maintenance of street lighting items, traffic signalization work items, and roadway maintenance will be subject to separate agreements to be determined and entered into upon a mutually agreeable design, as necessary.
10. The costs of any additional or unforeseen items not covered in the above will be paid by each municipality by mutual agreement.




