This office is in receipt of your claim in the amount of \$177.00, relating to health abatement charges placed on your tax bill for 2222-2224 South 7th Street for the Tax Year 2001.

Our investigation reveals that you filed this claim on June 5, 2003. Pursuant to §893.80 (1) (a), State Statute a claim must be filed within 120 days after the happening of the event giving rise to the claim. Since the claim was not timely filed the City cannot accept liability. Accordingly, we are denying your claim.
