The Overdose Warning Network – OWN – is the first mobile and desktop application for first responders to enter overdose incident data. It will have one data repository that will store opioid overdose incident data which will serve as an epidemiological indicator to provide incidence and prevalence data on opioid overdose data on local, state and national levels. It will be licensed by city/town and keyed by state /town.

The Overdose Warning Network was developed for First Responders including law enforcement, Hospital, Fire and EMS personnel and other individuals administering Naloxone in an opioid overdose event. It is also available for Android and iPhone.

Right now, Republican state Rep. FUNDING UPDATE

Today the Bureau of Justice Assistance (BJA), U.S. Department of Justice released the solicitation for the Comprehensive Opioid Abuse Site-Based Grant Program (COAP), funded through the Comprehensive Addiction and Recovery Act (CARA).

Who will be eligible to apply for BJA's Comprehensive Opioid Abuse Site-Based Grant Program (COAP)?

As laid out in CARA, applicants may include state agencies, units of local government, and federally-recognized Native American and Alaskan tribal governments. BJA will also accept applications that involve two or more entities, including treatment providers and other not-for-profit agencies, and regional applications that propose to carry out the funded federal award activities. What can be funded through this program?

BJA's COAP site-based solicitation contains six categories of funding. The funding categories include:

Category 1: Overdose Outreach Projects

- **Category 2: Technology-assisted Treatment projects**
- **Category 3: System-level Diversion and Alternative to Incarceration Projects**
- **Category 4: Statewide Planning, Coordination, and Implementation Projects**
- **Category 5: Harold Rogers PDMP Implementation and Enhancement Projects**
- **Category 6: Data-driven Responses to Prescription Drug Misuse**

I am excited to see what kinds of changes & impact this can have on communities throughout Milwaukee County in terms of not only reducing the number of drug deaths but also in supporting the individuals and families still struggling with addiction issues and those currently in recovery.

It seemed that valuable connections were made with other agencies and organizations that already have some of the resources and information the task force can use and I encourage you to continue to look to build those kinds of collaborations.

I had previously reached out to different city and county representatives asking how to join the Task Force as a community participant. as it was my understanding that was one area that would be included & represented.
