There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/18/16, applicant was cited for Building Code Violations at 2424 N Fratney Street.

Charge: Building Code Violations

- 2. On 06/26/16, Milwaukee police were dispatched to a 4th Degree Sexual Assault complaint at District #6 front desk. Investigation found the incident took place between 06/18/16 11:00 pm and 06/19/16 5:00 am at the Milwaukee Airport Inn at 1716 W Layton Avenue. The victim, who is an employee of the motel, stated a co-worker touched her body approximately 10 times during her shift at the front desk while she worked. The victim stated 5 out of 10 times the suspect intentionally and without consent, touched her vagina on the outside of her clothes. The owner of the motel, Prabhu Kasthurirangaian, cooperated with the investigation and made a copy of the security footage of the listed dates and information regarding the suspect. The case was no processed at the DA's office due to lack of evidence.
- 3. On 10/18/16 at 9:02 pm, Milwaukee police were dispatched to 1716 W Layton Avenue for an armed robbery complaint. Officers spoke with an employee of the motel who stated an

unknown male subject handed her a note and demanded money from the cash register and implied he had a weapon. The owner, Prabhu Kasthurirangaian, was notified of the robbery. Police were able to view surveillance of the incident.

- 4. On 08/30/19 at 10:52pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 146) for a fight complaint. Officer's interviewed an injured citizen who stated that he did not get into a physical altercation but "fell" in the hallway. A person in a neighboring room stated that the injured subject was in a physical fight with two unknown actors. While interviewing the suspected victim, officers observed that the sliding glass door to room 146 had a large piece of plywood on it and had exposed glass facing the exterior of the room. The clerk at the hotel said the glass had been broken for about a month and does not know when it will be repaired. A check of the "calls for service" showed that multiple calls regarding the tenants in rooms 146 and 148 because they often "fight" each other.
- 5. On 09/22/19 at 11:26pm, Milwaukee Police were dispatched to 1716 W. Layton Avenue (Room 127) for a property damage complaint. Investigation revealed that an ex-boyfriend broke into room 127 through the patio window. The tenant in the room called the front desk who, in turn called the police. Police found the subject in room 146, told him he was not allowed at the hotel, and escorted him off the property. While police were still on scene, the subject returned to the location twice and was subsequently arrested. The manager worked well with officers and was able to provide them with information to help locate and identify the suspect.
- 6. On 10/18/19 at 8:30am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for an armed robbery complaint. Investigation revealed that the alleged victim met a subject at the hotel for the purpose of prostitution. The manager was informed of the situation and he stated that he would not rent any more rooms to the subject.
- 7. On 10/18/19 at 11:27pm, Milwaukee Police conducted an underage alcohol procurement at the address of 1716 W. Layton Avenue. During the "sting" and underage Police Aide was able to buy a bottle of beer from the bartender inside the tavern at that location. The bartender, Chanhsamay BOUNKET was cited.

8. On 11/02/19 at 1:37am, Milwaukee Police were dispatched to 1716 W. Layton Avenue for a threat complaint. Upon arrival, officers interviewed the caller who stated that he was assaulted by two males who told him that he was stalking the bartender inside the tavern of the establishment. Officers interviewed the bartender who stated that the caller frequents the tavern while she is working and tonight, he was parked in his vehicle, with his high beams shining through the window, staring at her. The bartender says that she told other patrons inside the tavern that she does not feel comfortable when the caller is around but denies that she told the two males to confront the caller. The caller was told that he was not welcome at the tavern, so he checked into the hotel for the next two days.

- 9. On 03/18/20 at 08:26pm, Milwaukee Police conducted a license premise check at 1716 W. Layton Avenue to see if the tavern at the establishment was in compliance with Emergency Order #5 (inside Executive Order #72). Upon entering the tavern, officers observed two patrons sitting at the bar and one of the subjects had a drink. Officers informed the bartender that per the Governor, people were not allowed to be inside any establishment that serves food or drink. The bartender was under the impression that people could have a drink at the bar when they were waiting for their food. The officers went over Executive Order #72 (Emergency Order #5) and the bartender understood the order and made sure they are immediately followed by asking both patrons to leave. The bartender was extremely cooperative in the past and was again during this encounter. The bartender was given a copy of Emergency Order #5 and the premise check was ended.
- 10. On 06/25/20 at 9:01pm Milwaukee Police were dispatched to a reckless use of a weapon complaint at Travel Lodge, located at 1716 W. Layton Av. Investigation determined that the assignment was a sick/injured complaint, that occurred in the parking lot of the business. Officer spoke with victim who stated that she was leaning on her boyfriend's vehicle and lost her balance after the car was in motion. When the boyfriend left the location he unintentionally ran over her arm causing the victim pain. The victim was conveyed to St Luke's hospital for medical treatment. Officers spoke with the on duty manager at the hotel who stated that he just started his shift and did not see the incident. The manger was advised by the prior manger about the incident. The business was cooperative with the investigation.
- 11. On 07/20/20 at 12:12am Milwaukee Police were dispatched to a trouble with subject complaint at Travel Lodge, located at 1716 W. Layton Av. Upon arrival officers spoke with the caller, a juvenile who stated that the issue was resolved. The caller did state that he did not agree with the way he was treated by the security, because he said a racial slur. Officers spoke with the on duty manager who stated that the hotel resolved the issue with juvenile and his mother, and that security did not use a racial slur. The manager stated that he was going to allow both subjects to stay the night but then have both subjects leave in the morning.
- 12. On 07/21/20 at 1:58am Milwaukee Police were dispatched to a theft complaint at Travel Lodge located at, 1716 W. Layton Av. The caller stated that an unknown female that he has invited to his room on serval occasions stole his phone and disappeared. The caller could not give officers any relevant information on the female. Officers spoke with the front desk employee who stated that the caller has been inviting the female over most of his 30 day stay at the hotel. The employee believes that the caller has been doing drugs in his room, and that he will be evicted after today's events. Officers were not allowed in the room by the caller. The business was cooperative with officers regarding the investigation.
- 13. On 08/27/20 at 5:56pm Milwaukee Police were dispatched to an injured/sick complaint at Travel Lodge, located at 1716 W. Layton Av. Officers met bell #445 with the caller in room #232 regarding. The caller stated that he was intoxicated and feeling depressed. The caller stated that he wanted to go to the hospital. The caller was conveyed by bell ambulance and police services were not needed.

- 14. On 09/08/20 at 1:00pm community officers from District 6 conducted a Safety and Security meeting at Travel Lodge, located at 1716 W. Layton Av. The officers were met by two mangers of the business that did a walkthrough of the location. Discussed at the meeting were the hours of the onsite restaurant, the amount of security cameras, and the use of private security. Concerns covered were the amount of sick/ injured calls regarding over dose complaints. The management stated that any information regarding drug or prostitute use would get a renter band from the hotel. The renter would be placed on a do not rent list. Management told officers the hotel policy is to check ids, and vehicles associated with the renter. Officers were showed the current renter form with the required information. The management expressed that a main issue has been from long term stay renters. To help resolve those issues the hotel has only rented rooms on a day to day basis. Officers observed that some of the connecting buildings of the hotel are still under construction. This concluded the meeting.
- 15. On 10/09/20 at 3:24pm community officers from District 6 conducted a meeting at Travel Lodge, located at 1716 W. Layton Av., regarding an incident that occurred on 10/07/20. Officers spoke with the onsite mangers regarding the indent in which drugs were located in the rented room. The mangers were then given a Notice of Public Nuisance Drug Letter, and explained the contents of the letter. Management explained that the subject related to the complaint appeared to be under the influence of a drug when using the in lobby ATM. The manger on duty that day then put the renter on the Do Not Rent List. The management then showed officers the computer with the renter's information. Next to the information there was the letters DNR, and a brief comment regarding. This allows staff to be aware if a customer is on the Do Not Rent List, and not to rent any rooms to said person.
- 16.On 12/01/20 at 9:15pm Milwaukee Police were dispatched to a fight complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke to the front desk who stated that renters in room 103 have been arguing all day and staff could not make contact with the renters. Officers spoke with subjects, they were advised to keep the noise down or they would be asked to leave the location. The hotel staff was cooperative and no violations were observed.
- 17. On 12/11/20 at 8:08 pm Milwaukee Police were dispatched to a threat complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the caller who stated that he wanted to turn himself in on his warrant. The subject did have a valid warrant, a search incident to arrest revealed that the subject had items that appeared to be narcotics. The items were tested positive for methamphetamine and fentanyl. The subject was conveyed to District #6 to be processed.
- 18. On 12/13/20 at 4:03pm Milwaukee Police were dispatched to a child neglect complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the manger on scene who stated that a 6 year old child came to the front desk and stated that she got locked out of the room. The manger asked the child where are your parents the child replied that they were not there. The manger then called the police regarding. Investigation revealed that the child was left in the care of a 16 year old and that the parent now at the location did not neglect the child.

- 19. On 12/16/ 20 at approximately 9:51pm Milwaukee Police were dispatched to a battery complaint at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the caller who stated that she met the suspect through Facebook, and had been talking to him for a while. The suspect took the caller to the outside of location and wanted to pay her for intercourse. The victim refused to go to the room and the suspect became angry striking the suspect in her arm pushing her out of his vehicle. The suspect left the location with some items belonging to the victim. Officers spoke with the front desk and were able to obtain the suspects information. The victim had minor pain and injures from the incident. The victim was then was conveyed home and given officers information along with a PV-17 form.
- 20. On 01/04/21 at 8:45pm Milwaukee Police were dispatched to a sick/injured complaint at Travel Lodge, located at 1716 W. Layton Av. Officers located a subject lying on the floor of the lobby of the hotel. Investigation determined that the subject is staying in room # 116 and became intoxicated at the bar attached to the hotel. Officers located the subject's live in friend with same address and phone, in the room. The friend stated that he would care for the subject's wellbeing. The hotel staff was cooperative and no violations were observed.
- 21. On 01/12/21 at 9:01pm Milwaukee Police were dispatched to a trouble with subject complaint at Travel Lodge, located at 1716 W. Layton Av. The caller indicated that the subject was in room #106, causing a disturbance and stealing items. The subjects inside the room refused police services. The business was cooperative with the investigation, no violations were observed.
- 22. On 01/19/21 at 5:02pm community officers from District 6 conducted a meeting at Travel Lodge, located at 1716 W. Layton Av. Officers spoke with the manager, James Perry and conducted a walkthrough of the hotel. Officers observed multiple exit/entrance doors, which were not secured due to faulty door brackets on the first floor. Mr. Perry stated to officers that new door brackets were ordered and hoped to have the brackets installed within the week or so. Mr. Perry stated that the hotel does have security at the location Monday-Thursday 10pm-6am, and are looking for a coverage Friday-Sunday for the same time frame. The third building of the location is still currently being renovated and should be completed within approximately two weeks. The third building is intended to be used for extended stay customers. Officers discussed dispatched calls from 10/22/20 to 01/19/21. The dispatched calls were 48 calls for service with 28 of those calls being dispatched assignments. Mr. Perry stated to officers that the business tries to handle all matters in house before altering the police. Mr. Perry stated to officers that the business had had serval issues of domestic violence, and changed policy that both parties of the room have to leave the establishment. This policy is to deter a return of potential problems. Officers observed security cameras operational at the time of the meeting. Mr. Perry was advised, officers would have quarterly meetings with business and discuss any issues regarding.
- 23. On 01/20/21 at 5:50pm Milwaukee Police were dispatched to a threat complaint at Travel Lodge, located at 1716 W. Layton Av. Officers responded to room 107, and could not make contact with the complainant. There was no answer at the door or answer on multiple call backs to the caller. No Violations were observed by officers while they were on scene.
- 24. On 02/09/21 Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. The caller stated they were in room #106 and an unknown subject was pounding on the door. On arrival no one was located in the hall near Room 106, and the occupants stated they did not call police. Management was notified and cooperative.

- 25. On 02/19/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Welfare Check. The caller stated a friend of his that was staying at the hotel contacted him and was having a mental health crisis. On arrival police made contact with the subject, who was intoxicated and denied needing any assistance. The subject did not have any injuries and appeared to be in good health.
- 26.On 02/21/12, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Burglary Investigation. On arrival it was determined a suspect grabbed a key card from the neck of a housekeeper, entered the victim's room and stole items worth approximately \$3100. Management and employees were cooperative with the investigation.
- 27. On 03/03/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Sick and Injured Call. On arrival the caller declined any medical attention or police service and stated they had called for private transportation. The security officer at the hotel was cooperative and stated they would check on the guest periodically until the private transportation came.
- 28. On 03/04/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject in Room 218. On arrival officers did not hear any movement in the room, or signs of any guests in the room. Officers knocked several times; however, there was no answer at the door. The hotel clerk was notified and cooperative with police.
- 29.On 03/12/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. Investigation revealed there were two guests that were loitering on the property after checking out. The guests were gone on Police arrival. Management was cooperative with Police.
- 30. On 03/15/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Missing Check. On arrival it was determined the missing was not at the hotel. Later in the day officers conducted follow up at the hotel and were able to locate the missing in a hotel room. Management cooperated with the investigation.
- 31.On 03/19/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Battery complaint. Officers were advised there was an individual bleeding from the nose, kicking the door to a room and blood all over the hallway. The employee stated the individual was yelling and threatening guests, causing them to fear for their safety. The individual was located and arrested.
- 32. On 03/19/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Battery complaint. The employee/caller stated a known suspect came to the location and cut both rear tires of her vehicle two days ago, and again on 03/19/21. Investigation revealed the employees' statements to be contradictory to a report filed previously and video surveillance observed by the police, however, she was provided with information on a restraining order.
- 33. On 03/23/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Trouble with Subject. On arrival the caller stated the subject left and police were no longer needed.

- 34.On 03/28/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Dead on Entry. Officers were met by MFD and investigation did not indicate any foul play was involved. It was determined this was a probable drug overdose.
- 35. On 03/23/21, Milwaukee Police were dispatched to Travel Lodge, located at 1716 W. Layton Av., for a Threat complaint. On arrival officers were advised by the manager they wanted a hotel guest removed from the premise due to being loud and using profanities. The guest was located and removed from the establishment.

- 36. On 04/20/2021 at 12:06am officers were dispatched to a Threat complaint at the Travel Lodge, 1716 W. Layton Av. The officers were advised the clerk was reporting a subject was in the lobby making threats. When officers arrived the subject was gone and the clerk was uncooperative with the officers. The clerk refused to identify herself and was advised she could receive a citation for Disorderly Conduct based on the statements she made to the 911 operator.
- 37. On 05/27/2021 at 2:05am officers were dispatched to a Sick and Injured complaint at the Travel Lodge, 1716 W. Layton Av. The officer spoke with the caller who stated she might have been drugged but she is not sure because she consumed a lot of alcohol. The officers called for medical treatment but she refused. The officers escorted the female to her room. The officers attempted to locate an employee for the business but there was no one available.
- 38. On 05/28/2021 at 12:26am officers were dispatched to a Trouble with Subject at the Travel Lodge, 1716 W. Layton Av. The officers spoke with a tenant, who stated her room had an adjoining door to the room next door. She stated she saw the door moving like someone was attempting to get inside. The officers observed the rooms were being renovated and suggested she get a different room. The manager was able to relocate the caller.
- 39. On 06/12/2021 at 7:42pm officers were dispatched to a Call for Police at the Travel Lodge, 1716 W. Layton Av. The officer went to the room number listed for the caller but were unable to locate him.
- 40. On 06/14/2021 at 11:24pm officers were dispatched to a Battery at the Travel Lodge, 1716 W. Layton Av. room #146. The officer determined there was no battery but the occupants were just being loud and yelling. The subjects were advised to keep the noise down or they would be kicked out.
- 41. On 06/19/2021 officers were dispatched to a DOE at the Travel Lodge, 1716 W. Layton Av. The officers met MFD, who was on scene with a deceased subject. The officers interviewed the hotel manager who stated the subject was staying for 6 days and when he did not check out they checked his room and found him deceased. There was no foul play suspected.
- 42. On 06/27/2021 at 10:55pm officers were dispatched to a Battery at the Travel Lodge, 1716 W. Layton Av. The officers spoke with the caller, who stated he was upset because he was over charged. He stated a security guard pushed him out of the lobby and he wanted to press charges. The security guard stated the subject was yelling at the clerk. The clerk refunded his money and he continued to cause a scene and was refusing to leave. The security guard then escorted him out.

- 43. On 06/29/2021 at 11:11am officers were dispatched to an Overdose at the Travel Lodge, 1716 W. Layton Av. The officer spoke with the caller, who stated her boyfriend was overdosing on heroin. The subject refused medical attention from MFD and refused to speak with officers. The officer did not observe any evidence of drug use. The caller stated she would stay with her boyfriend to monitor his condition.
- 44. On 07/19/2021 at 1:47am officers were dispatched to a Trouble with Subject at the Travel Lodge, 1716 W. Layton Av. The caller stated he did not like how he was treated by security a t the location. The officers spoke with security who stated the subject was sitting in the lobby and he asked him to leave. There was no hotel clerk working to check in the caller and security does not have access to check customers in.
- 45.On 07/31/2021 at 10:21pm officers were dispatched to a Battery at the Travel Lodge, 1716 W. Layton Av. The officers spoke with a security guard, who stated he confronted a subject on the property. He stated the subject reached behind his back and stated "I got a bullet for you". The security guard stated he grabbed the subject by the neck and "handled business". The subject was located several blocks away and was found to have severe injuries requiring medical treatment. The officers located a witness who observed the guard striking the subject with a baton to the ribs and head. The agent arrived to operate the video system but he did not have a required passcode. The guard was arrested for Substantial Battery.
- 46. On 08/09/2021 at 10:32pm officers were dispatched to a Theft at the Travel Lodge, 1716 W. Layton Av. The officer spoke with the caller, who stated her cell phone was missing and she "pinged" it. She located it in room #103 but the occupants refused to return the phone. The officers went to the room and the occupants denied having the phone. The caller did not want a police report.
- 47. On 08/22/2021 at 2:42pm officers were dispatched to a Battery at the Travel Lodge, 1716 W. Layton Av. The officers interviewed the victim, who stated she has been living with a subject at the hotel for the last five months. The subject battered her and choked her today. The victim was conveyed to the hospital for treatment.
- 48. On 09/24/2021 at 8:58pm officers were dispatched to a Property Damage at the Travel Lodge, 1716 W. Layton Av. The investigation revealed a group of subjects was arguing with the clerk about being kicked out. One of the group threw a pen at the clerk and the clerk pepper sprayed the whole group. The group then began knocking items over in the lobby. One subject was arrested, another subject was issued a citation.

On Sunday, May 7th, 2023, at 4:05 AM, I was dispatched to the location of 1716 W Layton Ave (Travel Lodge Hotel), regarding a Theft complaint. PO Omar PEDROZA-BELTRAN (Squad 6390) also responded to this location with me. It should be noted that both officers were equipped with functional Axon body worn cameras which did capture this investigation digitally.

Upon arrival, I spoke with the hotel security employee, Elliot, who stated they had a resident who was deaf and making an accusation that someone may have stolen from her. After we were briefed by Elliot, he directed us to the complainant's room so we could speak with her regarding this matter.

I soon spoke with the complainant, FARRAR, Lydia M (w/f, 04/16/1984). FARRAR was in fact deaf which made communication somewhat difficult, but we managed to communicate by way of writing things down, and her ability to read lips. FARRAR stated she has been staying at the aforementioned hotel for a few days with her homeless boyfriend, and that earlier in the day she withdrew \$80.00 from the bank to buy crack for them. FARRAR stated after she bought the crack from her dealer, they smoked it all, and she took a bath afterwards. FARRAR stated while she was in the tub her boyfriend, CHEERS, Ricky D (b/m, 02/12/1979), took her government issued tablet, and the remaining \$40.00 she initially withdrew from her bank. FARRAR stated she exited the bathroom and CHEERS was gone with her things, and he left a note saying he went for a walk. FARRAR stated this was at approximately 9:30 PM, and she hasn't heard from him since,

FARRAR stated she knew for sure that these items were inside the room prior to her taking a bath, and that no one else was inside her room, FARRAR was adamant that CHEERS stole her property and wanted to be a victim and make the complaint. PO PEDROZA-BELTRAN and I went back to our squad cars to query the two subjects and observed a man walking through the parking lot that resembled CHEEKS. We observed the male enter the hotel and began walking towards the victim's hotel room.

PO PEDROZA-BELTRAN and I went back inside the building to verify with FARRAR if CHEERS had returned and later confirmed that he had. With officers present FARRAR questioned CHEERS regarding the missing items to which CHEERS denied taking anything from her. I advised CHEERS that if he had taken the property he would be arrested and cited for theft since FARRAR wished to be a complainant. FARRAR quickly changed her mind and informed us that she no longer wanted to prosecute and was just worried that CHEERS wasn't going to come back. FARRAR stated she just wanted CHEERS to come inside with her so they can get some sleep before they check out. I verified with both CHEERS and FARRAR that they would be civil with each other if allowed to stay by hotel management, and they both insisted that they were fine. Both subjects received a PF-6 Community Contact card regarding this encounter.

On Monday, 09-04-23, at 2:01 PM, I was dispatched to 1716 W Layton Ave, Travelodge by Windham, regarding a Threat complaint. Upon arrival, I observed the complainant, Breanna N SEEGER (W/F 02-24-85), outside at the front entrance of Travelodge. SEEGER was with her fiance, Joshua R GARRISON (W/M 05-4-92).

I spoke to the caller, GARRISON (#509-712-8047), who stated that he was in town to visit his fiancé, SEEGER. GARRISON stated that he and SEEGER had been staying at Travelodge during his visit. GARRISON stated that SEEGER approached two other individuals, who had been staying at the hotel. Those individuals were later identified as Princess L WALDEN (B/F 11-27-81) and Queen L JOHNSON (B/F 02-03-99). GARRISON stated that SEEGER approached WALDEN and Q JOHNSON over a parking issue, and WALDEN and Q JOHNSON became profane and threatening. GARRISON stated that he heard WALDEN or Q JOHNSON call SEEGER a bitch and threaten to kill him and SEEGER. GARRISON called police. GARRISON explained that WALDEN and Q JOHNSON had left the location in a gray Chevrolet SUV with Georgia registration plate SAR4119. GARRISON did not wish to prosecute.

I spoke to SEEGER, who explained that WALDEN and Q JOHNSON'S vehicle had been parked in a way that made it difficult for her and others to maneuver their vehicles without the risk of hitting the WALDEN'S or Q JOHNSON'S vehicle. SEEGER stated that she approached WALDEN and Q JOHNSON to be helpful. SEEGER stated that WALDEN and Q JOHNSON became aggressive with her. According to SEEGER, the older of the two individuals, WALDEN, was driving the Chevrolet and the younger of the two individuals, Q JOHNSON, was the passenger of the Chevrolet, when WALDEN and Q JOHNSON became threatening. According to SEEGER, WALDEN and Q JOHNSON both threatened to whoop her ass. SEEGER reported that the driver stated to her and GARRISON, "You're messing with the wrong nigger y'all, I will kill both y'all". SEEGER stated that WALDEN and Q JOHNSON left in the Chevrolet, which drove West in the parking lot in front of the Travelodge. SEEGER did not wish to prosecute.

I spoke to licensed premise manager, Pabina (NMN) KHADGI (A/F 09-04-85). KHADGI was cooperative with the investigation. KHADGI was unaware that the police were called. KHADGI stated that she did not observe the interaction between GARRISON, SEEGER, WALDEN and Q JOHNSON, but she did observe WALDEN enter the lobby in an upset state. KHADGI provided a photo copy of WALDEN'S and Q JOHNSON'S identification, which they used to check into the hotel. KHADGI did not feel there was a reason to call police based on the little that she observed. Travelodge did not have any security officers

While on scene, I observed a gray Chevrolet SUV with Georgia registration plate SAR4119 drive up to the front entrance of Travelodge and stop. The driver appeared to be Q JOHNSON and the passenger, who exited the vehicle and entered the front lobby, appeared to be WALDEN.

I spoke to the driver, who identified herself as Q JOHNSON. Q JOHNSON admitted that she had words with SEEGER, after SEEGER confronted her and WALDEN about parking. Q JOHNSON explained that she did not threaten SEEGER, but SEEGER threatened to hit Q JOHNSON'S vehicle. Q JOHNSON further reported that following the initial interaction and after police were on scene, GARRISON threatened to put a bullet in her. Q JOHNSON did not wish to prosecute.

I spoke to the passenger, who identified herself as WALDEN. WALDEN admitted that she had words with SEEGER, after SEEGER confronted her and Q JOHNOSON about parking. WALDEN explained that she did not threaten SEEGER. WALDEN felt like she was being harassed by SEEGER, who confronted them at the patio of their hotel room. WALDEN did not wish to prosecute.

Since this investigation was not criminal in nature and all parties involved did not wish to prosecute for any ordinance violation, a review of video surveillance was not conducted.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the threat complaint, I did not observe any violations in the licensed premise.

Upon arriving I made contact with the victim Michael J. BRYANT (B/M, 09/10/1966) who was in the rear parking lot of the location.

Scene description and initial observations

The incident location is a hotel located on the North side of W Layton Av in the 1700 Block. The hotel has a parking lot in the front and west side of the location as you pull onto the property. The parking lot extends into the rear of the location. There is a fence separating the back lot to the West side parking lot. Upon arriving I observed the victim who is an elderly black male. The victim appeared to be disoriented and had trouble standing as well as walked with a limp. I observed the victim bleeding from a cut on his right eyebrow which also had begun to swell.

Interview of Theola MEALY

I made contact with the caller Theola L.S. MEALY (W/F, 11/22/1977).

MEALY stated she was laying in her bed when she heard through her open window a man screaming for help. MEALY went to her door and observed 3 subjects pull BRYANT out of his vehicle and began striking him while he was on the ground. MEALY described the suspects as one being a black male, approximately 5'7, 160 lbs, with a slim build. MEALY could not give a clothing description. Another security employee was escorting this female juvenile, JOHNSON, Mahagony J (b/f, 03/26/2010) to the front lobby.

I spoke to the caller, L'OHNSON, Ryenesha R (b/f, 07/06/1991) who is the mother of Mahagony and her legal guardian. Ryenesha stated she has been staying at this hotel for the past couple of days while her brother is away, and stated Mahagony came to visit her. Ryenesha stated everything was great between them until Mahagony requested to use her IPhone, and was told no. Ryenesha stated Mahagony began to tap/bang on the dresser, which woke up her much younger siblings and proceeded to go outside when she was asked to stop. Ryenesha stated she suddenly began to hear crashing sounds as though someone was intentionally throwing rocks at the hotel windows, and stated when she looked outside she observed Mahagony throwing rocks and landscaping blocks at the windows causing one window to shatter. Ryenesha stated she attempted to get Mahagony to come back inside the hotel room, but she continued to refuse and the police were called. Ryenesha stated her daughter suffers from behavioral issues, but stated she has never acted this disrespectful before.

MILLIES stated was able to get away from his son, and was then choked again. M. MILLIES stated E. MILLIES (son) was able to place him in a chokehold, and began to push on his Adam's apple causing pain, which impeded his breathing. On Wednesday, March 27, 2025, at 2:55 A.M., I along with my partner P.O. Edgar RODRIGUEZ, were dispatched to the location of 1846 W. Layton Ave., which is located in the City and County of Milwaukee WI, for a stabbing call. It should be advised that the locat on given was not a valid address.

Upon our arrival to the approximate area given, which included an apartment building (1900 W. Layton Ave.) and a motel (Travelodge: 1716 W. Layton Ave.), there were no persons outside and there was no activity depicting a stabbing.

I attempted several times to call the caller however; the call went to voicemail on all attempts.

I. along with my partner P.O. RODRIGUEZ, searched the hallways of the Travelodge motel for a scene however there was no indication of a stabbing having occurred.

While searching the parking lot, we spoke with a patron, identified as Natalya KOVACEVIC (W/F, 12/03/2000), who was staying at the motel who stated that her ex-boyfriend broke the rear passenger window of her vehicle.

I spoke to licensed premise employee at the front desk, identified as Meekahyah S. CRAWFORD (B/M, 08/23/1979) who stated that he was not aware of anyone calling the police. CRAWFORD stated that his father, who stays in a room on the second floor that he heard an argument in the hallway and mentions of causing damage to a vehicle.

P.O. RODRIGUEZ spoke with KOVACEVIC regarding the incident, and was able to confirm that her phone number matched the call made for the stabbing call. KOVACEVIC stated that she had been in an argument with her boyfriend, identified as Devin D. HARRIS (B/M, 08/25/1998). KOVACEVIC stated that there was no

stabbing incident.

I was able to review camera footage, which revealed that KOVACEVIC appeared to have a verbal argument with HARRIS in the hallway, on the second floor of the motel. The video appeared to show the argument escalate and HARRIS began battering KOVACEVIC. The video shows HARRIS leave the scene going down the stairs. The video shows HARRIS return and batter KOVACEVIC again. The video then shows KOVACEVIC grab a fire extinguisher from the wall and HARRIS ran back down the stairs. The video shows HARRIS return, grab several items of his from the floor and leave the scene. KOVACEVIC then leaves the scene as well. I was not able to recover the video footage at the time. It should be noted that there was no indication of ε stabbing depicted in the camera footage. HARRIS was not on scene and was not able to be reached.

While on scene, I observed the licenses posted and they were up to date.

It should be noted that KOVACEVIC did not want to press charger regarding the battery and the window damage and there were no DV elements at the time. I provided KOVACEVIC with a PD-33 and a Community Contact Card.

I provided CRAWFORD with a Community Contact Card.


