There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

**Notice for applicants with warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to attend this meeting may result in the denial of your license. Individual applicants and partnership applicants must attend or attend by an attorney. The agent or attorney for corporate or limited liability applicants must attend. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

Good Morning Sir,

We have not met yet, but I am the newly assigned Captain at District 4. I'm looking forward to meeting you and working together to help serve the citizens of Milwaukee and to keep them safe. Last night we had our monthly Crime and Safety Meeting with the citizens of the district. It was a good meeting with a lot of thoughtful exchange regarding some of the challenges we face as a community. One of the items that came up on multiple occasions from different citizens was the ongoing problem we have had with the Courtside Bar located at 9012 W. Silver Spring and the Hook-Us Lounge at 9006 W. Silver Spring which are located next to each other. The residents of the neighborhood to the north of these businesses have constantly called the district with garbage, noise, reckless driving, shots fired, general disorder complaints for some time now. There was a recent incident where multiple shots were fired from a high powered rifle with persons connected to Courtside. Luckily no one was hurt from the incident. The complaints I get often from the neighbors are that they feel like they can't leave their homes after 7pm at night for fear that they will run into some issue stemming from those businesses.

We have been investigating and documenting every incident in order to provide the Council with the best information possible to make an informed decision regarding the renewal of their permits. We have stepped up our patrols in the area and are filing License Premise reports when we can to document any problems. In the past few weeks we have had in person meetings with the owner/operators of both businesses and they essentially blame each other for the reported problems. Members of MPD, DNS, and the City Attorney's Office were in attendance and offered both businesses suggestions on how they could reduce the amount of observed ordinance and state law violations as well as citizen complaints. Unfortunately, we have not seen the improvements we were hoping to have. The citizens are looking for the city to do something about these problem businesses and I ensured them that we are. If there are any ideas you have to help us in this regard, I would appreciate it as we are definitely willing to do our part. Thank you for your time and attention to this matter.

Capt,

Tonight we conducted a Business Check C of Courtside Bar at 9012 W Silver Spring Dr. Officers drove by and observed approximately 20 vehicles parked in their lot. I contacted Sgt RADEN regarding our options with doing the business check at the location.

Upon arrival at the location, we were able to make entry through an open front door. During our time in the bar, there were a total of 4 "workers" and 1 "customer" waiting on their food. We explained that we were conducting a business check, and requested to view the basement, which was currently locked. The owner Earnestine GOODSON (F/B,D.O.B.10/14/52) was talked to over the phone by P.O. XIONG, who stated that she was the only one with a key to the basement, and she was not coming to the bar to open it.

After further speaking with Sgt RADEN, I was advised that they do not have a food license, and we could close the bar down and make people leave and lock it up. I had P.O. XIONG file a license premises report IR 20-120-0118, and issue citations for Food dealer License required (0681X9CGFD) And resist/obstruct (0681X9CGFF).

I had 2 squads stand by and monitor the location for a period of time to see if anyone came from the basement. There was nobody that left the location while it was being watched.

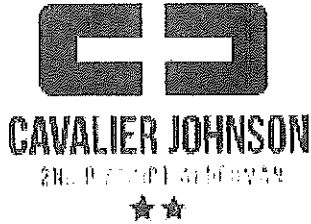

In addition to the notes that my staff compiled during their September 2nd meeting with the management of Courtside Bar and Grill and MPD-Four, please also add my personal account from my visit to the establishment including a photograph that I captured at 1:20am in the early morning hours of Sunday August 16th.

- When I visited the establishment with less than a hour to go before 2:00am, the security on the outside did not pat me down or otherwise check me.
- I was not informed by security on the outside or staff that I encountered on the inside that I needed to wear a mask upon entry during the coronavirus pandemic.
- When I entered the establishment, I noticed that patrons were in very close proximity to one another and I did not notice anyone wearing a face covering. I recalled that the capacity at this establishment isn't very high which became a cause for concern.
- I spoke with the agent (Ms. Earnestine Goodson) and asked her about the capacity and if it had been met. Ms. Goodson refused to answer my question and instead kept flashing a \$20 bill as the cover charge.
- I continued to ask Ms. Goodson questions about capacity and face coverings due to the COVID-19 pandemic only to be told that it costs \$20 to get in. Ms. Goodson then raised her voice and told me one final time that it's \$20 to get in and at that point, she was done with the conversation.
- I turned from Ms. Goodson and proceeded to capture the attached picture of the inside of the establishment and the proximity of the patrons.
- The security guard that I encountered outside was now inside and I asked him about the capacity of the establishment since the agent refused to provide that information. The security guard told me that he was unaware of the establishment's capacity.
- I left to the outside of the establishment followed by the security guard who suggested that I shouldn't be concerned about face coverings because there would soon be a vaccination for COVID-19.
- As I left the property, I noticed that patrons were not only disrupting the flow of traffic but, that they we also parked on the Silver Spring Drive sidewalk. While some of the vehicles doing these things may be attributed to Courtside, in fairness, there is hookah establishment next door that also has issues and is likely contributing to the traffic and vehicle problems. I've attached a photo of vehicles parked on the sidewalk as well.

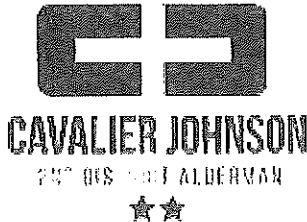

Problems at the property -

Multiple reports of shots fired on different days/nights, bar staff violating the license stipulation of 25 years old and over, overcapacity, illegal parking in the neighborhood, **sale of illegal liquor from Texas and other unlicensed/illegal sources**, parties after hours, lack of cooperation from bar staff (refusal to let MPD into bar, grant access to videos from security cameras), overall lack of management.

MPD Suggestions -

Reduction of capacity, apply and secure food license (which they currently don't have), report issues on neighboring Hookah Bar, hire and promote a qualified and licensed security force, purchase a wand to identify weapons/ID scanner, hire licensed bartenders, post cover fee that the public can see before entering bar, work on adding parking.

Many of the suggestions were accepted by the agent and her attorney. They will send over a detailed plan by September 15.

Other key items/notes -

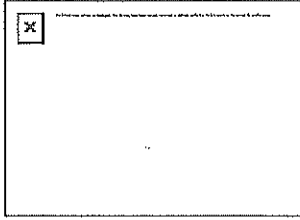
Agent of Courtside mentioned she is looking to buy the land and will try to renew license, they have interior DNS code violations due on September 14, right now they aren't patting down female customers, only male. The illegal liquor was found by MPD and Department of Revenue agents.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/01/2009 the Wisconsin Department of Transportation revoked the applicant's driver's license for 6 months for Operating While Intoxicated.

2. On 11/29/17 at 12:37 am, Milwaukee Police officers conducted a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill). Before entering the establishment, officers observed several vehicles parked along the north side of W. Silver Spring Drive and in the taverns' parking lot. There were also approximately ten vehicles parked in the BP filling station (9040 W. Silver Spring Drive) and officers observed the people from those vehicles enter the Courtside Bar & Grill. Officers entered the tavern and told the manager on duty that the Class B Tavern license for this establishment had expired and that they were not supposed to be open until the license was renewed and made current. The manager said that he was unaware the license was expired and willingly complied and closed the tavern down for the evening. No other violations were observed by officers and no citations were issued.
3. On 01/06/18 at 1:14 am, Milwaukee Police conducted a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill). While talking with the on duty manager, a fight erupted inside the bar area between three to four subject. With the help of security personnel, the officer was able to defuse the physical fight and detain one of the actors. The actor was arrested on outstanding warrants and no violations were observed.

4. On 01/12/18 at 12:45 am, Milwaukee Police interviewed the co-licensee at 9012 W. Silver Spring Drive (Courtside Bar & Grill) about an incident that occurred on 01/10/18. During the incident, an employee (victim) called the police about a trouble with subject and upon their arrival, pointed out a subject who threw an object at the employee (victim). During the investigation, another employee decided to get involved and tell the victim not to cooperate with the police. When the officer explained to the employee that any investigation that relates to the tavern needs to be investigated. The employee again told the victim not to get involved. The co-licensee was told that the police need full cooperation from all parties involved, especially those employed by his establishment. The co-licensee understood and said he would speak to the individual who made the comment. The officer also told the co-licensee about his patrons vehicles blocking residences' driveways and he said he would have security personnel monitor the situation.
5. On 03/03/18 at 1:27 am, Milwaukee Police were dispatched to 9012 W. Silver Spring Drive (Courtside Bar & Grill) for a battery complaint. The investigation revealed that a patron was hit in the head with a glass bottle which required stiches. While investigating the incident at the tavern, an officer observed a commotion as patrons exited the tavern and another officer found that several employees were not being cooperative with the investigation. The officer said that the employees inside the tavern during the incident did not see it occur and there is not a working surveillance system inside the tavern. Later follow up on the incident revealed that the co-licensee was extremely vague about the battery and that there are working surveillance cameras inside the tavern. An Incident report was filed (180620020).
6. On 03/11/18 at 1:00 am, Milwaukee Police were performing a license premise check at 9012 W. Silver Spring Drive (Courtside Bar & Grill) when multiple individuals started fighting outside the establishment. Investigation revealed that the fight started inside the tavern and security escorted them outside, together, and went back inside and locked the door to the establishment. Other issues which were observed by officers were; the surveillance system malfunctions, the door person does not have a counter to know how many people are inside the tavern, patrons vehicles that block the public walkway, and employees not forthcoming with information to officers. A meeting was scheduled with the owner in regards to these issues.
7. On 03/23/18 at 10:55 am, a meeting was held, in the Captain's office, at the Forth District Police Station about the tavern located at 9012 W. Silver Spring Drive (Courtside Bar & Grill). The agent was advised about the nuisance activities and complaints lodged against her establishment and she said that she understood. She was told that she could not have a working Jacuzzi, bed, lights, furniture, and food tables in the basement of her establishment because it can only be used for storage. She understood that fact but said she sometimes sleeps down there and uses the Jacuzzi when she is sore. Also discussed in the meeting were; getting the video surveillance system working, providing the name of the security firm they use, pat down search or wand everyone who enters the tavern, having a counter at the door for over capacity issues, and keeping an open line of communication with the Fourth District.

8. On 10/07/2018 officers conducted a licensed premise check at Courtside, 9012 W. Silver Spring Dr. The officers spoke with the manager, Shaun THOMAS, about the bar's capacity and patrons parking their cars in the neighborhood. THOMAS stated he is open Tuesday thru Saturday and the only busy night is Tuesday when its lady's night. He stated he has 2 security staff on most nights and 4 on Tuesday. The bar has cameras inside and outside and THOMAS stated the bar will assist in any investigations the officers have in the area.



9. On 02/20/2019 at 12:54am officers observed a large crowd outside 9012 W. Silver Spring Dr and they conducted a licensed premise check. The officers were advised a shots fired complaint had just come in at that location. The bar was in disarray with tables turned over and glasses on the floor. The officers spoke with patrons but no one wanted to give a statement. The staff stated there was talk of a fight and the patron became boisterous so they decided to close for the night. Officers concluded that no shots were fired inside of the bar. The officers assisted the staff clear out the bar without incident.
10. On 03/27/2019 at 12:45am officers were dispatched to 9012 W. Silver Spring Dr for a complaint the tavern was over capacity. The officers found the business to be under capacity by one person. The applicant was on scene and decided to close for the night.
11. On 03/27/2019 at 10:57pm officers went to 9012 W. Silver Spring Dr in an attempt to obtain surveillance video for a robbery that occurred outside the location. The bartender stated she did not know how to operate the system and would have someone call the officer.
12. On 04/19/2019 at 8:39pm officers conducted a licensed premise check at 9012 W. Silver Spring Dr. The officers spoke with Jimmy SIMS, who stated his mother is the applicant, regarding the parking situation and capacity issues. SIMS stated they have been having issues with security and are looking for new staff. He was reminded the capacity was 99 including staff and it was recommended he stop letting patrons inside at 80 to allow them to remain in compliance. He was advised to not allow cars to be double parked in the lot for safety reasons or to allow vehicle to park partially on the sidewalk. The business currently only has eight parking spots on the west side of the building. The applicant arrived and stated she wanted things to run smoothly, stating it has been hard to find good security staff. The officer advised the applicant to set up a meeting with the captain. The encounter appeared to be productive.
13. On 06/26/2019 at 1:55am officers heard gun shots in the area of N. 92<sup>nd</sup> St and W. Thurston Av which was in the area of Courtside Bar as it was closing. The officers checked on the subject who was not injured. The subject stated he was at Courtside drinking and left at closing time. He started to drive away and started to feel sick so he parked his auto and got out of the vehicle and sat in the passenger seat. He stated he did not hear gun shots and did not know when his auto had been struck but stated the damage had not been there prior to parking at Courtside Bar.

The caller stated the tavern was letting patrons under 25 into the business. The officer entered and observed two security guards at the door checking ID's and searching for weapons. The officer checked the tavern and could not locate anyone under 25 years of age. The employees were cooperative with the officers.
17. On 03/18/2020 at 8:39pm officers were dispatched to Courtside Bar, 9012 W. Silver Spring Dr. for a tavern violation. The caller stated there were multiple cars in the parking lot and the business should be closed because of the emergency orders. The officers arrived and did observe several cars in the lot. They waited several minutes for the applicant to open the door. She stated she locked the door because she did not want to let anyone else inside. The applicant was advised to have security labeled on their clothing and vehicles. The applicant was advised to enforce the 25 year and older age restriction. The attorney stated they would create an abatement plan in the next 2 weeks.

HERRMANN and I) along with squad 4330 (P.O. SCHAAPVELD and P.O. WALLACE) were dispatched to 9012 W. Silver Spring DR. (Courtside Bar and Grill) which is located in the City and County of Milwaukee License Premise investigation. The investigation occurred in the south parking lot, assembly/ bar area, and patio of this location.

### Initial Observations

Upon arrival we notices vehicles parked a block away from address on the north side of Silver Spring Dr. We also noticed multiple parking violations of vehicles parking too close to driveways, blocking neighboring driveways, and parked in the bike lane. P.O. SCHAAPVELD issued 10 parking violations.

This report is written by P.O. Jason FINLEY, assigned to District Four, Late Power Shift, Squad 4486.

On Wednesday, April 29, 2020 at approximately 9:27 PM my partner, P.O. Lee XIONG and I (in full duty uniform, marked MPD squad, and equipped with AXON 2 body cameras) conducted a License Premise Check of 9012 W. Silver Spring Dr (Courtside Bar and Grill). While on patrol it was observed there were approximately 10 vehicles parked in the parking lot and there was also an anonymous call to District Four regarding the vehicles in the parking lot and possibly a party going on inside the establishment.

Based on the potential for there being a large group of people inside the establishment, Squad 4485 P.O. Shane BISHOP and P.O. Jason DAERING, Squad 4237, P.O. Nicholas SCHELI and Nicholas REID, Squad 4227, P.O. Shane DOUGHTY and P.O. Brett STAGERWALD, Squad 4281, P.O. Gabrielle HERRERA and P.O. Andrew FUERTE, Squad 4421, P.O. Travis CAPELLE and P.O. Brittany GALLOWAY, Squad 4213, Sergeant Kevin PANFIL and Squad 4210 Sergeant Nicholas FEDERER additionally responded to the location regarding.

Upon arrival, it was observed that the lights were on inside, and I could see approximately four subjects inside walking around, talking, drinking, and eating food. We knocked on the door, and was greeted by an unknown, unidentified black male who let us into the establishment. Once we were inside, the unknown male had called the owner, identified as Earnestine GOODSON (f/b, 10/14/52) on his cell phone. P.O. XIONG and spoke with GOODSON about us being in the establishment and the Licensee notification was made. GOODSON was not cooperative with our investigation when we informed her that people were inside the establishment when they should not be open at all for any reason due to the COVID-19 Stay at Home order which was issued by Governor Tony Evers. While P.O. XIONG was speaking with GOODSON he asked her to come to the establishment due to the belief that there were subjects in the basement and that we would like to insure there was nobody down there, but she stated she would not be coming. GOODSON then hung up the phone on P.O. XIONG and he attempted to call her back several times, but did not receive an answer.

Immediately after P.O. XIONG gave the unknown male his phone back, he then stated he was going to move his vehicle before "we towed it" and never returned.

While P.O. XIONG was speaking with GOODSON on the phone and then trying to contact her again after

she hung up, I spoke with the other subjects who were inside the establishment.

I spoke with Shakilya L. WRIGHT (f/b, 03/17/91) who stated she was a licensed bartender at the establishment and had been working there for approximately 3 years. WRIGHT stated they were "open tonight for curbside pick-up for food." While speaking with WRIGHT, I did observe that there were several pieces of chicken on the grill that was behind the bar and there was a subject, identified as Glenn D. THOMPSON (m/b, 04/07/79) who was also standing at the bar eating chicken. THOMPSON stated he had been in the bar working as an electrician. Based on my observations while speaking with THOMPSON, I did not believe that he was there working in the capacity of an electrician based on his level of intoxication. Also while I was speaking with THOMPSON, I did observe several small clear plastic cups on the bar that were filled with an unknown pink/red liquid.

I also spoke with a female who was standing behind the bar, who was identified as Naomi S. LAWERY (f/b, 06/22/96) who stated she was a waitress at the establishment and had been working there for just a couple months. There was also a subject who was seated at the bar, who was identified as Jazmyn K. BROOKS (f/b, 06/14/90) who stated she had come into the establishment and ordered food and paid for the food but had not received it.

There was a sixth subject who was in the establishment, identified as Tomas W. TRICOCHÉ (m/h, 09/25/86) who stated he was asked to come into the establishment and paint murals on the east wall, which was consistent with the paint cans that were on one of the tables and the clothes he was wearing.

All subjects who were inside the establishment, other than the unknown black male who left were cooperative with police and the investigation. The only uncooperative subject was GOODSON who stated she would not come to the establishment and hung up on police regarding our investigation.

A license check of the establishment showed that they do not have a Food Dealer License and should not be selling food at all, nor are they an essential business that should be open during this COVID-19 state of emergency declared by the President of the United States, Donald Trump, and the Wisconsin State Governor, Tony Evers.

Due to the establishment not having a Food Dealer License and WRIGHT telling police that they were serving food for curbside pick-up and the patron, BROOKS saying she ordered food, paid for the food, and was waiting inside at the bar for food, GOODSON was issued a citation for being in violation of the City of Milwaukee Ordinance **68-21-1-A (citation # 0681X9CGFD)** regarding. A records check did reveal that the establishment did apply for a Food Dealer License, but the license was never granted when they applied in 2019.

GOODSON was also issued a citation for Resisting and Obstructing regarding our investigation and not being cooperative with police. GOODSON was issued the citation for being in violation of the City of Milwaukee Ordinance **105-138-2 (citation # 0681X9CGFF)**.

Both citations were issued by P.O. XIONG.

It should be noted there have been several calls for service at the location regarding since the Stay at Home Order has been in effect. Below are the prior calls for service regarding:

**03/18/20 IR# 200780126.** Officers that responded spoke with subjects inside the establishment and did notify all occupants of the establishment of the current Stay at Home order and there was to be nobody inside the establishment and they were not to be open for any kind of business.

**03/20/20 IR# 201210095.** Officers responded to the location and did observe approximately 10 vehicles parked in the parking lot of the establishment. Officers did attempt to make contact at the front and back door, but there was no answer. There were no lights on inside, and both the front and the back door were locked. P.O. XIONG did monitor the parking lot after attempting to make contact, but never did see anyone leave.

**03/22/20 IR# 200820103** regarding a call for a party that was taking place in the basement of the establishment. P.O. XIONG and I did make contact with subjects inside, as well as subjects who were in the locked basement.

**03/23/20** Squad 4290, P.O. Justin MURPHY and P.O. Jonathan BOHN conducted a Business Check-C. There were no vehicles in the parking lot and it did not appear that there was anyone inside the establishment. P.O. On Wednesday, May 27, 2020, at approximately 8:32 PM myself (in full duty uniform, marked MPD squad, and equipped with an AXON 2 body camera) responded along with Squad 4281, P.O. Gabrielle HERRERA and P.O. Andrew FUERTE, Squad 4410, Sergeant Julian NUNEZ, Squad 4210, Sergeant Nicholas FEDERER, and Squad 4213 Sergeant Kevin PANFIL to the address of 9012 W. Silver Spring Dr (Courtside Bar and Grill) located in the City and County of Milwaukee, Wisconsin.

There was an anonymous call that was placed to District Four stating that Courtside had been open for business for the past several days, and that they were open again this evening. Captain Heather WURTH also instructed officers to respond to the establishment, and ensure the establishment was not operating. Officers responded to the location, and observed approximately seven vehicles parked in the parking lot, and the lights on inside the establishment. Officers went to the front door, and found the front door to be open, and there being approximately eleven people inside the establishment. The bartender, identified as Shakilya L. WRIGHT (f/b, 03/17/91) who was behind the bar serving drinks, and approximately eight patrons sitting at the bar drinking what appeared to be alcohol. Along with the liquids that appeared to be alcohol sitting on the bar, there were also Styrofoam containers sitting on the bar in front of several of the patrons, which is commonly used for food and take out food.

While asking WRIGHT to turn the music off for us, Jimmy E. SIMMS (m/b, 06/13/74) came out of the basement of the establishment. SIMMS stated he had called District Four and District Seven yesterday,

May 26, 2020 and he was told by unknown officers that there were no laws preventing them to be open, and that they could open at their own risk. SIMMS stated he was not aware that the City of Milwaukee placed an order in place not allowing taverns to open. SIMMS stated he thought that since the Wisconsin Supreme Court said that order that was given by Gov. Tony EVERS had been ended that they were allowed to re-open. SIMMS was provided a copy of the City of Milwaukee Health Department Order, given by Mayor Tom BARRETT and shown the directive specific to taverns and bars. SIMMS stated again he did not know about it, but acknowledged the information I had given him, and stated he understood they couldn't be open moving forward until further information from the Mayor.

Prior to responding to the establishment, I conducted a license search though the City of Milwaukee website to check what valid licenses Courtside currently held. A search revealed that they do have a valid Class B tavern license and an entertainers license, and that they applied for a Food Dealers License on May, 14, 2020. While speaking with SIMMS he told police that he was granted a temporary Food Dealer License when they applied for the license, which I was unable to verify as he had no paperwork regarding, and there was nothing online showing such. I then provided a copy of the Food Dealer License application, which under section eight was signed and initialed by the owner, Earnestine GOODSON (f/b, 10/14/52) stating and acknowledging "I understand the Health Department must conduct an inspection and advise the License Division of their approval before the license may be issued." GOODSON also initialed at the bottom of section eight saying "I will not operate my food business until the license has been issued."

I also checked behind the bar, and observed several chicken wings sitting in the deep fryer basket, along with two separate bowls sitting next to the grill that appeared to have batter and breading in them that would be used to prepare the chicken before frying. I also observed other containers behind the bar next to the grill that contained chicken wings.

Due to GOODSON not yet obtaining a Food Dealers License, GOODSON was issued another citation (0681X4FB07) for operating without a Food Dealer License under City of Milwaukee Ordinance 68-21-1-A.

Due to the establishment not allowed to be open, we instructed SIMMS to close up the establishment and leave for the evening. Police the left the location, and as police were leaving and drove past the front of the establishment and observed two or three more subjects walk in the front door.

I turned around, and pulled back into the parking lot and observed a vehicle with approximately four females get out and were going to go in the establishment, when I told them the establishment was closed. The front door was locked, and I was then greeted by GOODSON and observed three other individuals inside who were not there the first time. SIMMS stated they were employees and they were there to clean all the food up for the night. Sergeant PANFIL asked GOODSON if they were on the payroll and GOODSON stated they do not have proof of being on the payroll because she only pays them cash when they work. SIMMS stated they were all going to be leaving after they finished putting up all of the food and "stuff" that was out for the night.

Due to GOODSON now being at the establishment, I then explained to her as I did to SIMMS the City of Milwaukee Health Department Order that was issued by Mayor Tom BARRETT. I also explained to

GOODSON that they were not able to operate as a Food Dealers License. GOODSON stated she understood and acknowledged the application that she signed and was cooperative with the investigation and stated she now understands that she is not allowed to be serving food at all.

It was also explained to SIMMS and GOODSON that as business owners they are responsible for knowing the City and State Laws pertaining to their establishment and it is their responsibility to be checking on what has been changing.

SIMMS and GOODSON were issued a community contact card with all officers who responded to the establishment.

This is the end of my report.

I spoke with Earnestine GOODSON (B/F 10/14/1952) who stated she was the manager of Court Side. Earnestine did provide officers with a copy of her licence which indicated their capacity is 99 persons. While I was gather information from Earnestine another work walked up to me and made comments about having lawyers for capacity issues.

During this time due to current health concerns regarding Covid-19, the city health department had limited capacity of business such at bars and restaurants to 50% of there original capacity which is 99 persons.

While on scene I observed 58 people exit the front door and P.O. RUMMEL observed 48 people exit the exit in the rear. Upon entry to the bar several subjects that left prior to stating the count.

On Thursday, August 13, 2020 at approximately 9:15 PM my partner, P.O. Lee XIONG (in full duty uniform, marked MPD squad, and equipped with AXON 2 body cameras) responded to 9012 W. Silver Spring Dr (Courtside Bar and Grill LLC). We accompanied Special Agent Georgeann KING and members of her team from the State of Wisconsin Department of Alcohol and Tobacco to conduct a liquor license premise check. Squad 4238, P.O. Donald KRENZIEN, P.O. Marlin SCHLICHER, P.O. Justin SCHWARZHUBER Squad 4237, P.O. Brittany GALLOWAY, P.O. Nicholas SCHLEI, Squad 4281, P.O. Andrew FUERTE, P.O. Gabrielle HERRERA, and P.O. Brett STAGERWALD, and Squad 4313, Sergeant Sean MANHKE also assisted.

Several officers waited at the back door of the establishment, while the Alcohol and Tobacco Special Agents and several officers went to the front door of the establishment. The Alcohol and Tobacco Agents made entry through the front door and identified themselves to Earnestine GOODSON (f/b, 10/14/52) who is the license holder of the establishment, and explained the procedure of the procedure. GOODSON stated she understood the procedure of the license premise check.

When we entered the establishment there were several patrons in the establishment that had left, without being identified. The others subjects that stayed in the establishment were identified as Jimmy E. SIMMS (m/b, 06/13/74) and Jamal L. CAMPBELL (m/b, 08/01/86) who stayed on-scene for the entire length of the investigation.

Once inside the establishment we all cleared the establishment, including the basement to ensure there were no other subjects inside attempting to hide from police. While searching for other subjects, an abandoned Black and Tan Schyver 5.56 caliber AR-15 pistol, model S-15, with two loaded 40 round magazines, and one round in the chamber of the firearm (SERIAL# S00206) was located behind the futon couch on the north east wall of the establishment. We asked GOODSON, SIMS, and CAMPBELL if the firearm was theirs and they all stated it was not theirs and they were not aware the firearm was in the establishment or behind the couch. The firearm was placed on Milwaukee Police Department Inventory #20028910 as evidence, with Gun Tag #93134. The firearm and magazines were sent to B of I for processing.

While conducting a walk through of the basement the basement floor had standing water and a bath tub that appeared to have been un-installed. While in the basement, we also observed a quantity of hookah pipes, coals, and tobacco in the basement. Please see P.O. GALLOWAY's supplement regarding.

While in the basement, inside the walk-in cooler, I observed various food items such as chicken wings, french fries, bread, buns, eggs, condiments, and other items commonly used to cook food that would be sold to patrons. There were also items such as coleslaw, corn, rice, pickles, cooking oil, and other condiments that were located behind the bar near the grill area.

While in the basement of the establishment it should be noted that there is a "gambling table" made of 2x4's and ply wood, with the ply wood covered with gray carpeting. The table is approximately 6 feet long and 3 feet wide. On top of the table were dice and cards, which would be consisting with subjects gambling at the table.

Alcohol and Tobacco Special Agents conducted a seizure of all alcohol in the establishment. Special Agent KING stated she asked GOODSON if she knew where the alcohol was purchased from, and she stated she does not know where it comes from exactly but stated she knows that it is not purchased through a wholesale dealer. Special Agent KING stated she located 72 bottles of liquor in the establishment that had a Texas tax stamp. SIMMS stated he had brought the alcohol back from Texas and brought it to the establishment for sale.

Special Agent KING also seized a total of 226 various bottles of liquor which had come from an unauthorized source. She also seized a total of 96 bottles and cans of beer that had come from an unauthorized source that were located in the establishment. The items were located in both the basement and behind the bar.

It should be noted that there were no invoices located on the premise for any of the alcohol, which includes the size of the stock. There were no invoices that were prepared, retained in sequence, or had been retained for two years.

I also took a total of 51 digital photographs depicting the location of the incident, the firearm that was recovered, the evidence of food and cooking supplies, the basement which was unsanitary and includes the possible gambling, the tobacco, and food in the walk-in cooler.

On Tuesday, September 02, 2020 at approximately 1:59 AM, Squad 4332, P.O. Lorenzo MAHOLMES and P.O. Deangelo WARD were in the area of N. 87 St and W. Carmen Av when they heard multiple shots fired in the area of N.91 St and W. Silver Spring Dr. located in the City and County of Milwaukee Wisconsin.

Squad 4332 broadcasted the information on MPD Talk group 4 regarding the shots fired. While broadcasting the information other squads, they stated they could continue to hear the shots fired.

P.O. XIONG and I, along with several other squads (Squad 4430 P.O. Damien RAINEY and P.O. Eian WEST, Squad 4460 P.O. William SCHLICKE, Squad 4440 P.O. Oneal STAMPS and P.O. Brittany GALLOWAY, Squad 4410 Sergeant Julian NUNEZ, Squad 4312 Sergeant Amy BARTOL, and Squad 4313 Sergeant Sean MANHKE) all responded to the area.

Upon arrival, P.O. RAINEY located several casings in the rear of 9012 W. Silver Spring Dr (Courtside Bar and Grill). All other squads began checking the immediate area for other casings and potential shooting victims. No shooting victims were located in the immediate area and no shooting victims were located at any area hospitals.

While in the rear of Courtside Bar, P.O. GALLOWAY believed stated she could hear a male voice yelling from inside the bar. Based on finding the casings outside of the rear access door, the Milwaukee Fire Department was contacted to attempt to force entry to the establishment. Once the Milwaukee Fire Department arrived on-scene, Jimmy E SIMMS (m/b, 06/13/74) arrived on-scene and allowed officers access to the building through the front in order for officers to check for any shooting victims or injured parties that may have resulted from this incident. No persons were located inside the building, but there were two fired cartridges located near the rear access door of the building (north end) as well as one bullet fragment under one of the speakers on the floor in the northwest corner of the building. The basement was also checked for any subjects, and nobody was located. SIMMS stated he was not at the establishment at the time of the incident and was notified by Darren COWART (m/b, 06/18/84) of the incident by a phone call after police arrived on-scene. SIMMS told police that he does not know what happened and was not contacted by anyone else and had no further information about the incident. SIMMS was cooperative with police in letting them in the establishment and did wait on-scene throughout the investigation.

In the rear of the Courtside bar, there were a total of 58 various casings located to include both rifle casings and handgun casings. The casings were spread out ranging from right outside the rear access door to the far north side of the parking lot.

The residence 9015 W. Thurston Av #3 was struck by the gunfire once resulting in damage to the residents northern window. The bullet entered apartment #3 which was occupied by the resident when this incident occurred. Two vehicles that were parked in the rear of 9015 W. Thurston Ave were also struck by gunfire.

Officers continued to check around the building and surrounding area for victims, fired cartridges, buildings, vehicles struck by gunfire., and any other evidence pertaining to this incident. Officers observed that the address of 9006 W. Silver Spring Dr (Hook Us) was struck by gunfire approximately 3 times. There was one bullet strike in the front door of the building and two bullet strikes to the upper glass above the entrance door. There was also two bullet strikes in the door jam of the door, but it appeared they did not penetrate. Additionally there were 11 fired cartridges located in the parking lot in front of 9006 W. Silver Spring Dr. Those casings were spread out from the front entry door of the building to the far south side of the parking lot near W. Silver Spring Dr.

There were also two vehicles that were struck by the gunfire that were parked in the northwest corner of the parking lot closest to 9006 W. Silver Spring Dr. The owner of one of the vehicles stated he did not wish to be a victim and refused to provide any information, but was wearing a black "security" shirt. His vehicle was struck two times in the front driver's side hood area. The second vehicle that was struck was unoccupied and sustained three bullet strikes. Officers were unable to locate the owner of the vehicle.

It should also be noted that the west exterior wall of 9006 W. Silver Spring Dr was struck approximately 10 times with bullets. The west wall is adjacent to 9012 W. Silver Spring Dr.

Officers attempted to speak with individuals who were leaving "Hook Us" but there were no witnesses who stated they saw anything and refused to give any information.

I did briefly speak with COWART who stated he did not know exactly what happened, but stated there was a female who was in his establishment that was causing an issue who he told to leave. COWART stated after she left, she was still causing some sort of disturbance in the parking lot and that is when he heard what he believed to be shots fired. COWART stated he did not know who was shooting and does not know why. COWART was semi-cooperative but refused to stick around for the duration of the investigation and stated he had to leave because he had a "flight to catch at 5:30" and needed to get going. When I asked COWART about the bullet strikes to his building he stated that he did not want to be a victim and that he was just going to have to pay to get the windows fixed. COWART was very reluctant to provide any other information about the incident and or who was involved.

There was video surveillance which appeared to be inside and outside of Courtside. Due to the lack of cooperation, CIB removed the "DVR" from the premises and is to be conducting a search warrant for the recovery of the video which should assist in gathering potential suspects regarding the incident.

On Wednesday September 2,2020 at 1:00 PM, we held a meeting at District Four in the back meeting room. Present for the meeting were the following: LT. Shannon Taylor, Sgt. Chad Raden, P.O. Carrie Resnick, P.O. Tracey Geniesse, ACA. Heather Hough, Georgeann King with DOR, Earnestine Goodson Licencee, Jimmy Simms last known manager, Attorney Emil Ovbiagele, Todd Miller and Arlisisa McHenry both representatives from Alderman Johnson's office.

Lt. Taylor stated there has been a lot of activity occurring, such as incidents of shots fired, loud music, traffic control issues, vehicle break-ins with firearms taken and over capacity. Lt. Taylor stated all of these incidents are using a good amount of police resources, but there are things occurring here that are under your control. Capacity issues and underage (under 25 yoa), how do you keep tract of the customers coming and going? Goodson stated, I have security guards, they do the checking and I'm not aware of them allowing in underage subjects into the bar. Taylor stated, when the police arrive on scene and are conducting investigations, no one wants to cooperate with the police department. We don't have the resources to sit at your business every day, there is a huge lack of cooperation. So we all have to work together.

Ovbiagele stated there are laws that prohibit discrimination laws in regards to age limits. Its a soft target to cover solutions. One problem is parking and I understand this could cause problems. I have made the suggestion to cut the occupancy in half for now.

Simms stated they have been in business for four years and haven't had the problems they've had until Hook Us opened next door. Simms stated he has recently moved to Texas and they were without a bar manager, but now they have one. He was unable to provide the contact information at this time.

Hough explained she has observed Courtside partnering with Hook Us during special events on social media. Raden stated businesses start pointing the finger at each other, that's not why were here. We need to come up with solutions instead. Some of the following are recommendations, if the businesses next to your are having issues, it probably would be best not to have contact with them. Have employees park off site, if you only have twenty parking spots, you will have to come up with a plan for additional parking and where that will be. Hired security should be licensed through the state and bonded. This will cover you as a business, but be consistent with your security guards, so they will know your expectations. They should also be labeled as security, vehicles and clothing, for the reason of being able to be identified by customers or other's who may attempt to commit illegal activities, etc. There is no wiggle room with the age limit. If he license states 25 years of age and older, that is who would be allowed inside of the bar. If there is a cover charge, it must be posted in front of the business. Get a strong manager. Promoters are using your license, so be aware of who you are working with.

Ovbiagele stated they will create an abatement plan, will send the new managers info, security info and camera info along with the plan in the next couple of weeks (around September 15th, 2020)

Security measures that are currently in place, pat downs of all male patrons, look inside purses and viewing all identification cards.

We then advised Simms and Goodson to provide a calendar of events to District Four.

Dear Officer Geniesse:

As you know, my Firm represents the above-referenced establishment. On behalf of my client, we are grateful to the department for setting up the September 2, 2020 meeting that was attended by several officers and other representatives of the City. We found the discussions to be very productive and helpful.

At the September 2, 2020 meeting, the department shared some of its concerns with regards as it relates to recent developments at the establishment. Broadly, these concerns included: (a) management concerns; (b) sale of food items; (c) parking; and (d) need for proactive security measures. Other matters addressed included some open DNS orders. At the meeting, we also discussed potential solutions and have taken the recommendations provided by the parties into consideration in developing this written course of action plan.

My client fully intends on maintaining the premises in a way that promotes orderliness and safety. It is their mission to work with the neighbors, their Alderman's office, and District 4 to ensure that their concerns are timely and adequately addressed. This letter sets forth my clients' planned course of action for remedying the matters discussed. If we can provide any further information or documentation, or if I can answer any questions, please feel free to contact me at 414-585-0588.

- *New Manager.* A lot of the issues discussed were attributed to management. To that end, my client has recently obtained the services of its former manager, Shaun Thomas. Mr. Thomas was previously the Class B Manager of the establishment before going to work elsewhere. However, he is back and will be reapplying for a new manager's license. He

once held a license (#BMGR-0197677) that was associated with the establishment. Up until his departure, a lot of the new issues seemed to have been under control. By the end of October, we anticipate he will have an updated manager's license on file, and I can provide that upon request by then. In addition, Ms. Goodson and her son, who serve as the business managers, plan on being at the premises more often as well. We do believe that consistency and a strong managerial presence is important to alleviating a lot of the issues we discussed.

- *Licensed Bartenders.* My client ensures that all their bartenders are licensed. Right now, due to reduced capacity, there are two primary bartenders that work at the establishment. Both of which have valid Class D operator licenses: Evalynn M Fowler (#BART-231045) and Victoria M Johnson-Luckett (#BART-230218).
- *Cameras.* Since our meeting, my clients have updated their security system. There are 8 cameras inside and 8 outside. This new state of the art camera system captures major angles of the building. Further, there is a standing order amongst all employees that, absent any issues, they are to provide the department with external camera footages upon reasonable request to assist the department in its efforts to keep the community safe. I have attached a picture that shows some of the exterior camera footage.
- *Lights.* At our meeting, the department requested that the external lights be kept on even when the business is not in operation. It is our understanding that the department feels this will help provide a well-lit area at all times and also help deter unwanted activity when my client's business is closed. To this end, my client has no issues and will comply with this request.
- *Security Wands.* Although there have been no incidents of violence at my client's location, we believe it is important to continue improving security measures and being proactive. Rather than doing pat-downs, security staff will now use security wands to check patrons that come through the doors in the evening. Please see the attached photo.
- *ID Scanner.* Pursuant to suggestions from the department, my clients purchased a Viage ID Card reader. In addition to physical ID checks, this will be used to verify the ages and identities of patrons that come to the establishment. Please see the attached photo.
- *Counter.* On busier nights, my client will be employing the use of a counter to ensure that capacity requirements are followed. Staff members have been trained on this procedure.
- *New Security Company.* Our client recently retained the services of "CN Private Security, LLC" for the provision of security and patrol services. We believe this will help deter any rowdy activity outside, ensure parking laws are being followed, and ensure orderly conducts of patrons (in and outside of the tavern). This should also alleviate some of the secondary issues associated with parking.
- *Food Dealers License.* As of September 3, 2020, my clients submitted a new application for a food dealers license.

- *Non-use of Promoters.* For the remainder of the year and the near future, my client will not be using the services of outside promoters for the marketing of its business.
- *DNS Orders.* A portion of the outstanding DNS orders discussed stemmed from issues with the grease trap and the hood. As of September 15, 2020, my client retained the services of AD Hood Cleaning, LLC to perform services related to these matters. I have included a picture of the certification of performance. My client is in the process of closing out the remaining orders and working with DNS to get this accomplished. We anticipate that these will all be taken care of by October 15, 2020.
- *Parking.* We recognize that parking is an issue in the area, in general. However, my client has over 15-20 parking spots. It seems in recent time, a lot of the parking issues stem from a newer establishment next door. Be that as it may, my client has instructed its staff members to avoid parking in the allotted spots to ensure patrons have enough room to park on premises.
